### Child Care: Iowa's Patchwork Approach

Access to affordable and reliable child care is more than a parental concern. It helps keep the workforce humming, strengthens childhood learning and well being, and reflects a caring community. On March 10, the League of Women Voters of Johnson County will present "Child Care: Iowa's Patchwork Approach" at the Iowa City Public Library from 6:30 to 8:00 p.m. Speakers Jana Garrelts, Neighborhood Centers of Johnson County; Allison Bettine, 4Cs of Johnson County; and Laurie Nash, Johnson County Social Services will enlighten us on current efforts to address the childcare crisis in Johnson County. This program will challenge us to think about the possibility of following the lead of New Mexico, which as of November 1, 2025, guarantees no-cost universal childcare to all its residents.

The first LWVJC Legislative Forum of the 2026 session was held on Saturday, January 24 at the Iowa City Senior Center. Senators Zach Wahls and Janice Weiner as well as Representatives Adam Zabner, David Jacoby, Amy Nielsen and Elinor Levin participated. Senator Dawn Driscoll and Representatives Heather Hora and Judd

Lawler did not attend. The elected officials started off with their updates on the initial week of the legislative session and some of their priorities.

The focus topic for this forum was education. Representatives from various educational organizations came with questions. Questions were also posed from the general public in attendance.

The legislators urged all of us to follow the bills being introduced on the Legislative web page and participate in the subcommittee work on the bills. You can track the bills and schedules on the website:

February 4 from 3 – 4 p.m. is the first meeting (via Zoom) of the five (5) member VR sub-committee. The major purpose of this meeting is to review previous registration locations, identify additional locations, and to discuss the logistics of holding multiple events in one day or week.

## FUNDRAISING

The Fundraising Committee kicked off the formal 2025/26 Campaign November 1 with a letter mailed to each member. The goal for this campaign is \$9000 and a secondary effort is aimed at increasing the numbers of members participating above the 20 percent experienced in the last few years.

As of December 31, a total of \$6125 has been received: Operations, \$3975, and \$2150 for Education. This is approximately 68 percent of our \$9000 goal; 45 members have contributed at approximately a 27 percent rate of our current membership count of 166. Thanks to all of you who have donated to our efforts, both operational/administrative support and in support of our tax deductible Education Fund.

The League nonpartisan goal is to provide information to our voters that will help them make informed choices and decisions regarding

who they vote for. We even have leadership and members in our chapter devoted to Voter Registration, Voter Services, Advocacy, and Education who are engaged to provide members and the general public with information consistent with our priorities. This year, there is so much work to do because OUR VOTES COUNT! And your financial contributions to our administrative, operational and education expenses help us provide the services that the League through our national, state and local organizations we have been doing for over 100 years.

There are only a few more weeks left for you to donate. If you have not yet donated, please help us meet our increased goal. If you have made a donation, thank you for your support. If you did donate and can, will you give a bit more? I will because I believe EVERY VOTE COUNTS!

*The goal of the LWVJC Advocacy Committee is to Inform, Empower and Advocate.*

The Iowa Legislature is back in session and moving quickly with their agenda. An informed electorate demanding transparency and responsive government is crucial to protecting our democracy. Over the past two weeks, the LWVJC Advocacy Committee has posted Advocacy Action Alerts on the following legislation:

- The EPA's proposed redefinition of protected waters
- Iowa's Bottle Bill review Iowa Code Chapter 455C
- The closing of the Iowa City Historical Society facility
- SJR11 Amendment restricting Iowa tax increases
- A vote on the standalone DHS bill to continue pushing for ICE reforms while ensuring continued funding for essential government agencies.

## **ADVOCACY**

The Advocacy Committee informs, empowers  
and activates our League members  
In support of our LWWIA Priorities



★ VOTING

Promote equal access to voting and ensure all votes are counted. Adopt automatic voter registration. Pass a constitutional amendment allowing Iowans with felony convictions to vote after time served. Promote open primary elections. Join the National Popular Vote Interstate Compact.



TRANSPARENCY & CITIZENSHIP

Demand government accountability and transparency by requiring all amendments and bills discussed in committee to be available to the public prior to a vote. Demand timely processing of Freedom of Information Act (FOIA) requests. Encourage direct citizen participation by requiring virtual committees and subcommittees.



EDUCATION

Provide oversight and track public funds being used for non-public schools. Require any non-public school receiving public funds to meet the same standards as public schools. Fully fund public schools. Continue to expand access to affordable childcare. Restore statewide special education and disability services.



REPRODUCTIVE RIGHTS

Guarantee access to the full range of women's reproductive health services. Repeal the six-week abortion ban. Make contraception available without prescription and promote programs that help prevent unplanned pregnancies. Ensure Medicaid services are comprehensive and accessible. Set policies that attract maternal health professionals and address the state's OB/GYN deserts.



HUMAN TRAFFICKING

Increase state funding for victim services; develop strategies to prevent human trafficking, domestic violence, and sexual assault; and enact "Safe Harbor" legislation to protect victims from criminal prosecution.



WATER

Prioritizing, protecting and improving Iowa water quality and ensuring its sustainable management. Enact policies that safeguard clean water and address challenges of health risks, pollution, overuse and climate change.



GUN SAFETY

Ban assault rifles and military-grade weapons for civilian use. Enact background checks on all gun sales, close gun show loopholes, require gun safety locks, repeal Iowa's "stand your ground" law, and oppose laws that allow carrying guns on school grounds.
