With the 2018 elections coming up we want to help with the vote by helping to register as many voters as possible. New voting procedures are also in the works in California, with the hope that more Californians will vote. Although these new procedures will not impact us yet in Los Angeles County, it is important to keep abreast of these changes. Soon we will be having several days to vote at voting stations using electronic machines. The County has been working on this since 2009.

Our current voting system was started in 1968. You will still be able to vote by mail if you so choose.

Also coming up shortly is the County League's Convention at the end of March. We encourage all members to participate in the Convention. The conventions are where the work for the League at this level is being decided. As a member of our local League, you automatically are also a member at the County level as well as at the state and national level. The League needs your support and more importantly your interest and activity. It is not difficult to support League actions at a higher level – just open the state or national site and find the legislative page. You can usually just click to send a message to our legislators- that may already be prepared for you. Of course – writing something yourself is always powerful.

Problems in Our Charter School Systems

43 states and Washington D.C. have enacted charter school laws. Charter schools are semi-autonomous and operate under a written contract (charter) with a state, district or other entity. This charter details how the school will be organized and managed, what students will be expected to achieve and how success will be measured. Charter schools enjoy freedom from laws and regulations affecting other public schools as long as they continue to meet the terms of their charter.

In the 25 years since the charter school movement began, both Democrats and Republicans have supported their expansion, believing that in exchange for freedom from regulations, charters would be more accountability and maintain higher standards. Yet the safeguards that regulations provide for public schools have often been circumvented by charters resulting in fraud, mismanagement and less transparency.

Last September, the Inspector General of the Department of Education issued an audit report entitled: "A Nationwide Assessment of Charter and Educational Management Organizations." The report assessed "the current and emerging risk" that is posed by charter management organizations for fraud, waste and abuse.

The sector, in general, operates more like businesses than schools. One in five are for-profit schools and still others turn over the majority of their funding to for-profit management companies (authorizers). Many are run as chains. Unlike businesses that start up with personal investment, the risk is assumed by taxpayers. If the charter fails, the taxpayers are the "investors" who are on the hook. Some examples include:

- Covenant Academy, a charter school in Arkansas, has never achieved academic proficiency, yet it was
 recently allowed to keep its autonomy, despite financial weakness and a deficit that was bailed out by
 the Walton Foundation.
- Ohio is notorious for weak charter governance. The Ohio Charter School Accountability Project found that more than one-third of the charter schools that received federal grants between 2006-2016 either closed or never opened. There is no record that the \$4,000,000 in grants given to the unopened schools was ever returned to the taxpayers.
- In Arizona, if a charter shuts down, the property of the charter becomes a parting gift to the charter operator. It is not returned to the taxpayers who paid for it.
- The Taylor International Academy in Michigan, ran out of money and recently closed its school 12 days early, after the charter's management company suddenly pulled its staff, including the principal.
- Last fall, 500 students fled the Livermore Charter School in California after it was alleged the school illegally charged foreign exchange students tuition and transferred them to a school in Stockton. The management team is under investigation for conflict-of-interest relationships as well as diverted, commingled and/or misappropriated public funds.

LWVC Legislation....Action Is The Name of the Game

Haven't you wondered how to look up the list of bills the LWVC supports and opposes, including up-to-theminute status, links to our letters sent to legislators, along with other details. Take a moment to access the LWVC website titled <u>https://lwvc.org</u>. On the opening page, click on Take Action on the title bar followed by the Legislation category and you will come upon the Bill Status Report. It provides a list of bills LWVC supports and opposes, with their up-to-the minute status, links to our letters to the appropriate committee and/or author of the bill as well as a brief explanation of what the bill would do. At this time of year, the <u>Bill Status Report</u> page also lists the bills that have been passed by the legislature and sent to the Governor for his signature as well as whether each has been approved or vetoed. Also take a look at <u>Bills of Interest</u> which includes those being "followed" by the League on which no formal position of support or opposition has been taken as well as those on which the state League has taken a position and recommends action.

Of note, 34 LWVC Supported Bills were sent to the Governor as of 1/17/2018. Check out the Bill Status Report to see which ones were approved or vetoed.

Training on ballot measures presentation will be on April 28, 2018

June 2018 Ballot Measures (from LWVC)

The LWVC board took final positions on the measures scheduled for the June ballot. We'll have a "The League Recommends" (aka Vote with the League) by early April. Meanwhile, here's a quick summary of the League positions on each measure.

Greenhouse Gas Reduction Reserve Fund (ACA 1)

This measure would add a requirement that two thirds of legislators approve the first appropriation of any money collected from the sale by CARB of Cap-and-Trade allowances. At a time that we need efficient and effective investments in climate change solutions, this requirement could lead to deadlocks, inefficiencies and poor decisions The LWVC opposes this measure.

Motor Vehicle Fees and Taxes (ACA 5)

If passed this measure would raise excise taxes on gasoline and diesel fuel, provides for regular increases to those taxes based on inflation, establishes a new fee on zero-emissions vehicles, and raises vehicle registration fees. The new revenue from these taxes would be used for transportation-related purposes – repairing streets and bridges, addressing deferred maintenance on highways and local roads, improving public transit, and investing in needed transportation infrastructure to benefit all Californians. The League supports measures to ensure adequate revenue to support needed service, including safe roads and good public transportation. The LWVC supports this measure.

Effective Date of Initiatives (ACA 17)

Currently an initiative that is approved takes effect the day after the election unless the measure provides otherwise. Election results are not officially certified until five weeks after the election. While most election results are clear shortly after election day, that is not always the case. Prop cc would provide that an initiative would take effect 5 days after the Secretary of State certifies the election results. This is a common-sense measure, ensuring clarity about what is- and what is not- California law. The League supports this measure.

California Drought, Water, Parks, Climate, Coastal Protection and Outdoor Access for All Act (SB 5)

This measure would authorize California to issue general obligation bonds, with the money used to finance state and local parks, water conservation measures, water reliability to disadvantaged communities, and flood protection projects. California parks provide open space and recreation, improving health and community well-being. The water projects funded by this bond are forward thinking and are a key part of our state response to climate change. The League supports this measure.
