**Share this alert about the February 10 special election.** This is an election for voters in East Valley, Newport, Rosalia, St. John, and Takoa School Districts only. Eligible voters should be aware that the changes to postmarks announced by the USPS on December 24, 2025 are now in effect. The LWVWA recommends that if you are voting within a week of an election day (in this case, Feb. 10), using a drop box rather than mailing your ballot is the best way to ensure that it arrives in time to be counted.

## Affordable Housing and Homelessness Solutions (AHHS)

### *The Gray Wave: The Elderly and Homelessness*

The “Gray Wave” refers to the growing population of unhoused individuals aged 55 and older. According to the 2024 HUD Point-in-Time Count, nearly 20%—one in five—people experiencing homelessness are 55 or older. Projections estimate that by 2030, the number of unhoused older adults will triple.

Most older adults never anticipated becoming unhoused. Yet a single destabilizing event—a medical emergency, job loss, rising housing costs, or the death of a spouse or partner—can quickly unravel decades of stability. Many older adults rely primarily on Social Security as their main source of income, which has not kept pace with inflation. A 2024 study by the University of California, San Francisco, found that prior to becoming unhoused, the median monthly household income for older adults was just \$920, with a significant portion spent on rent.

There is also a population of chronically unhoused older adults. These individuals often cycle in and out of homelessness while facing compounding challenges, including chronic health conditions, mental illness, substance use disorders, and the cumulative effects of trauma. Aging while unhoused accelerates physical decline and raises the risk of premature death.

#### **Call to Action:**

The Gray Wave is not made up of strangers. These are our parents, grandparents, friends, and neighbors—people who worked, raised families, and built our communities. They deserve to age with safety, dignity, and stability. No one should grow old without a place to call home. We must act by expanding affordable housing and creating shelters and services that protect older adults.

## Update of LWVWA Indian Treaty Rights Study

The state League is updating our 1980 Indian Treaty Rights Study to address significant changes in government-to-government relations between tribal nations and Washington state. Consideration will be given to History, Sovereignty, Government to Government Relations, Economic Prosperity, Energy and Salmon.

The study is expected to be completed in 2027.

Here are some interesting facts about Washington reservation sizes and populations, this can be confusing as tribes often list facts differently.

Statistics on land size includes: tribal trust land, individually owned tribal trust land, fee land and off reservation land. Population statistics include: total reservation population, tribal member population on reservation, non tribal population on reservation, off reservation tribal population and total tribal population.

**The Spokane Tribe** is 229,429 acres and 2,541 tribal members.

**The Colville Tribe** is 1.4 million acres and nearly 9,600 tribal members.

**The Yakima Tribe** has 1.4 million acres and 9,405 tribal members.

**The Hoh Tribe** is 477 acres and 97 tribal members.

**The Muckleshoot Tribe** is 3,922 acres and 3,353 tribal members.

**The Snoqualmie Tribe** is 12,000 acres and 650 tribal members.

I have visited 17 Washington reservations and plan on visiting 10 more February 7-14. It has been fun looking up tribal information. I also reread *There There* by Tommy Orange and his latest book *The Wandering Stars*.

For members interested in these issues, much information is available through tribal websites, books, documentaries, movies, and the internet generally. In addition, LWVWA's 7th/8th grade civics book, *The State We're In – Washington*, does a good job covering tribal history and current issues. # Redistricting Committee Update – A Program Action Committee

## Redistricting Commission Reform Committee (RCRC) – Next Steps

- Our LVVWA Leagues Redistricting Commission Reform mantra is **Put People First**.
  - Washingtonians deserve stable representation that protects the voices of all voters.

On January 21, 2026, at 1:30 P.M. our State League President Karen Crowley and State League Democracy Coordinator, Redistricting & Census Issue Chair, and Redistricting Reform Task Force Chair gave testimony on HJR 4209. (HJR means House Joint Resolution used in the context of U.S. Congress). If you've never heard or participated in testimony hearings you can familiarize yourself with the recordings via the website under Public Hearings, find the bill and become familiar with the webpage available content.

These two testimonials given by league for this bill were among the many who gave support or opposition to this bill. The League of Women Voters of WA opposes mid-decade census redistricting. By the time this is printed in February the outcome of this bill will have been voted on (or may not have come to the floor for vote).

And your thoughts may now be – “What?” Full context and for following the bill go to:

HJR 4209 Washington State Legislature

### The Summary of Bill:

*If any state adopts a new congressional map mid-decade absent a court order, the Legislature may, before the next decennial census, amend the congressional districts of the state districting law by a majority vote of both houses. Each district must contain a population, excluding nonresident military personnel, as nearly equal as practicable to the population of any other district. To the extent reasonable, each district must contain contiguous territory; be compact and convenient; and be separated from adjoining districts by natural geographic barriers, artificial barriers, or political subdivision boundaries. The amended districting law goes into immediate effect upon adoption by the Legislature and remains in effect until the Legislature amends the state districting law again after another state adopts a new congressional map mid-decade or until a new state districting law is adopted following the next decennial census.*

Foremost, the League of Women Voters of Washington State and our Spokane Area League believe it is important to maintain our corner-

stone of democracy and believes mid-decade redrawing maps for political gain is dangerous. It silences our voices and weakens our democracy. Thereby, why LVVWA opposes this bill.

When redistricting is done equitably and responsibly, fair redistricting ensures that every person's voice carries equal weight. When done quickly, and for partisan gain, redistricting silences voices that ensure a government that is responsive and accountable to the people.

Moving forward, our league goal urges the adoption of a constitutional amendment that reforms the Washington State Redistricting Commission to be an expanded citizen commission that emphasizes nonpartisanship and that commits transparency, accountability, access, and citizen engagement. We call this the People First Redistricting Commission – which is to remove the incentive for narrow self-interest.

### Our State Redistricting Commission Reform 2026 Goals are:

- Create and publish a model legislation for a new People First Redistricting Commission for Washington bill (North Star Proposal)
- Create and get support for a Redistricting Accountability Bill - prepare to advocate for the bill in the 2027 session.
- Identify legislative sponsors and champions, campaign chairs, and local and state coalition partners.

# Voter Services Report

## Young Voter Registration Project, 2026


In January the national LWV hosted a virtual meeting for recipients of their “**Young Voter Registration Project, 2026.**” Beth Pellicciotti had submitted a proposal on behalf of LWVSA, and we were awarded \$500 to use as needed for registering young people to vote. Along with background information provided by LWV staff people, ideas from other recipients of funding were shared.

Across the U.S. 126 Leagues involved in voter outreach at 2,300 schools, reaching 160,000 students.

LWV shared a report from Tufts University regarding a study of youth and voting in the 2024 election which identified specific reasons some young people give for not registering to vote and for not voting. The full report can be found here:




During the meeting, a request for brief reports from local Leagues turned up ideas that we in Spokane might want to consider:

- outreach to superintendents, voter registration at graduation rehearsals
- League member mentors high school students who then make announcements at schools about the importance of voting
- county high school visits with classroom presentations in language arts and gov't classes; in smaller districts have sessions in school libraries, this year also at tribal schools.

Later in the meeting, focus turned to GOTV (get out the vote) activities with young people. One story was really inspiring:

*Our League sends postcards to students we've registered and hold a GOTV event and rally at the high school before the primary election. For the rally we gather at the school library with blank poster boards for students to make signs, and have a table for phone banking so that students can make reminder calls about the primary to registered voters. We also invite elected officials to the event to answer questions from students. Super important to send thank-yous to teachers, principal, superintendent for helping. Our march goes out of the school to city hall, where students put their primary ballots into the ballot box.*



Another League noted that they have an OPT IN form whenever they register youth so that those interested in receiving reminders/texts from the League when important election dates approach are called.

As LWVSA gears up for voter outreach to high school students, this information should inform our approach and talking points with youth.
