For several years we have been using a schedule of which positions to address each year. This year we agreed in May to look at Transportation and Local Finance during 2019-20. The final position on our schedule for review is Mental Health, slated for review during 20-21. This means we now need to generate a new schedule for the next five or six years. At our meeting, we also need to look at what the National League is proposing for the national program so we will have to be very efficient with our time.

### Schools & Communities First By Mary Lou Lowry

Many of us want the same things: good schools for our kids, a healthy family, and safe neighborhoods. But for nearly four decades, big corporations have not been paying their fair share, leaving California with the most overcrowded classrooms in the U.S. and with some of the worst ratios of counselors, librarians, and nurses per student. Schools & Communities First ensures that our schools and communities come first with the resources to educate all of our kids and the services to support all of our families. It closes commercial property tax loopholes benefiting a fraction of corporations and wealthy investors, without affecting homeowners or renters, and reclaims \$12 billion every year to fund world-class schools and strengthen local economies to lift up all Californians. It's time to invest in California's future.

The Schools & Communities First proposition will be on the ballot in November of 2020, and will fill the corporate loophole that only profits large corporations at the expense of schools, the public and small business. It will allow small businesses to compete on a level playing field by adding a

small business real estate property tax exemption up to \$3,000,000.00, and eliminating the personal tax on their business equipment.

This measure mandates full transparency and accountability for all revenue restored to California while guaranteeing existing protections for residential property and agricultural lands.

We need your help! The coalition of partners supporting this reform has rewritten Proposition 1 to include improved protections for small businesses, to include every school district in California, and close the loopholes in Proposition 13 that enable large corporations to avoid property tax reassessment for decades.

We need to gather signatures to have the improved Proposition 1 on the November 2020 ballot. The new petitions are coming out at the end of October. We will need to gather many signatures and we only have until March. I hope you will join our campaign to put Schools & Communities First.
