To say I was stunned and disappointed, is an understatement. Feeling like I am living in a "Twilight Zone" skit has discombobulated me. It is an odd feeling to know that the League and its members worked hard to educate voters and turn out the vote successfully, yet the outcome was different than expected. Michigan had the second highest turnout in its history. The anticipated challenges to the vote didn't materialize and the lawsuits challenging the vote have been dropped. The system worked as it was supposed to. So, the question is, why do I feel so much concern?

The League of Women Voters will be celebrating 105 years of existence in 2025. Prior to that it took women 120 years to get the right to vote and women of color longer than that. The country

has made progress in the last 105 years. This election season we saw new voting rights make voting more accessible to more people, but now we are concerned. The pronouncements coming out of the next administration has me worried that the progress that has been made will be lost. My solution of stress-eating and retail therapy is not solving anything. Working together and being vigilant is the solution laid out before us. Our job is not done.

If you haven't read President Dianna Wynn's and CEO Celina Stewart's (LWVUS) statement on the 2024 election results, I encourage you to do so. Finally, we are pleased to welcome to the Northwest Board, Christina Stark. Christina was appointed at the November board meeting to fill the remaining term of a board member who was unable to serve. This term will expire in 06/2025.

It is my hope that you have had a good holiday season and have recharged your batteries for 2025. As League members, we are part of a 105-year tradition of defending democracy. In the new year, I am certain we will have one or more opportunities to do just that. Happy New Year and thank you for all that you do.

The meeting opened with acknowledgement of the recent election and the many emotions we all felt. The way forward was discussed later in the meeting (see President's Perspective article). We were treated to a Redford Township update from the Township Supervisor, Pat McRae. Thank you, Paula Bowman, for arranging his visit. We also had a representative from State Senator Mary Cavanagh's office in attendance. Lifetime member, Laura Callow, gave us an update on the ERA and asked us to contact the Biden administration to instruct the US Archivist to fulfill their statutory duty and certify and publish the Equal Rights Amendment in the U.S. Constitution.

Our guest speaker was Maria Woloson, a board member with LWVMI, and a member of the Oakland County League. After a discussion we moved on to committee reports.

Save the Date: LWV 105th Anniversary Celebration by Carrie Moon-Dupree

On February 14, 1920, the League of Women Voters was formed six months before the 19th amendment was ratified. This new organization's purpose was to help educate the 20 million new women voters and assist them in carrying out their new responsibilities. The National American Woman Suffrage Association, headed by Carrie Chapman Catt, saw the need to educate voters and defend democracy even after securing the vote and formed the fledgling organization.

Saturday, January 25 from noon to 3:00 pm, we will be honoring and celebrating that legacy at our membership meeting. We have booked the **Straight Farmhouse** in their Grand Parlor, which is part of the Garden City Historical Park. While this is an 1866 historical farmhouse, it has been made handicapped accessible. There is ample parking available.

We will have a short business meeting, a presentation on the history of Garden

City, and a discussion on how we are going forward with the transformational platform in 2025. After that, we will enjoy a light lunch and refreshments.

As a member of the Observer Corps, I have observed every Livonia City Council meeting for the last three years. I have learned a lot about how Livonia works. Here are two things that may be of interest to many Livonia citizens:

First, there is an opening for a new council member on the Livonia City Council because Councilman Jim Jolly was just elected judge. On December 16, anyone wanting to run for this position was able to make a three-minute

speech about why they want to hold this one-year office. A question and answers session followed, and the council will vote in January.

The second item of interest is the city recently voted on the yearly budget. How a city spends its money is an excellent way to ascertain city priorities. A handful of people were in attendance to witness the process. There is a website and Facebook page that reports on council meetings called "Vote, Run, Serve" that could be helpful resources for those interested.

The LWV Observer Corps helps keep city and township committees, mayors, supervisors, city councils, and trustee boards accountable. It is important work, and we are always looking for more people.

Scholarship Committee by Pat Bindas

The Scholarship Committee is proud to announce that the League will offer three \$1,000 Friedrichs/Bowman Scholarships for the 2024-25 school year to three Schoolcraft students instead of two as we have done in previous years. The scholarships will help contribute to students' dreams as they focus on their studies. We thank the League for approving the third scholarship.

The League is fortunate to work with the Schoolcraft College Foundation in coordination with their Financial Aid Office to complete recipient selection, and manage the distribution of the scholarships based on LWV NWW and Schoolcraft College criteria. Two women were selected for the 2024-25 school year. Each sent notes of appreciation to the League. One more student will be selected in January 2025.

One may ask, "Why continue the scholarships when Governor Whitmer signed tuition free options for Michigan students who meet specific criteria?" The free tuition options are called the Community College Guarantee and the Michigan Reconnect (Reconnect), neither of which is available to all students. For those who do receive them, there can be gaps between the full cost to attend Schoolcraft and what these Michigan opportunities provide. Gaps in financing could include books, housing, and transportation, to name a few. See below for an overview of the free tuition options.

Community College Guarantee

Beginning Fall 2024, high school students from the Class of 2023 and beyond

may be eligible to receive:

- In-district tuition, contact hours, and mandatory fees
- An additional \$1,000 Michigan Achievement Bonus award for Pell-eligible students, which can be used toward additional college costs

Michigan Reconnect (Reconnect)

A last-dollar scholarship program that pays for you to attend your in-district community college tuition-free or offers a large tuition discount if you attend an out-of-district community college. To be eligible, you must:

- Be at least 21 years old when you apply
- · Have lived in Michigan for a year or more
- Have a high school diploma, high school equivalency (GED), or certificate of completion
- Have not yet completed a college degree (associate or bachelor's)

Please support education and other programs by our local League. We help educate our citizens on the issues and their voting rights. With mis-and disinformation a common occurrence, the League is a beacon of truth and non-partisanship for our fellow citizens.
