On Saturday, June 14, 36 members of the League of Women Voters of Northwest Wayne County gathered at <u>Granite City</u> in Northville for the League's 65th Annual Meeting.

The event opened with a welcome from President Carrie Moon-Dupree and the recognition of the League's 5 lifetime members - those that have been in the League for over 50 years. President Moon-Dupree and outgoing Michigan Co-President Paula Bowman then recognized the Belle Ringer awardees who have done extraordinary work for the League over the past year. The business meeting adjourned just after 1pm, and was followed by lunch and a time of fellowship.

2025 LWVMI Convention Summary

The League of Women Voters of Michigan held their 39th Biennial convention in Grand Rapids from May 16-18, 2025. Every League in the state was represented with 170 total members in attendance. Northwest Wayne Co.'s voting delegates were: Laura Jannika, Toni Jones, Christina Stark and Carrie Moon-Dupree. We shared the class load and attended all the various classes which enabled us to bring back pertinent information to our League.

At the plenary sessions, the following votes were taken and approved:



- Bylaws Amendments language change to reflect new dues structure
- 2025-2026 Budget as presented
- 2025-2026 Slate of Candidates- as presented for officers, directors and nominating committee
- Adoption of State Program
- Concurrence with Utah Position on Aid in Dying
- Work on update of LWVMI Election Law position focusing on primary elections
- No non-recommended positions were approved for a vote

Throughout the convention, pictures of the statewide lifetime members and Belle Ringer awardee were shown. LWVNW lifetime members and Belle Ringers are noted in the annual meeting recap.

If you have not attended a convention, it is well worth your time.
