First Council - Lasting Impression Chuck Torelli

As a relatively new member of the LVW, I wasn't sure what to expect from the **2018 Washington State Council**, which was held June 1st through 3rd in Richland.

I feel the word that best sums up the three-day Council is "Collaboration." I have rarely seen so many with such varied backgrounds work so hard to come to consensus. Even when consensus wasn't possible, there was acceptance of different approaches to the issues. The core values of the League were on full display and I can't speak highly enough of the support I saw delegates extend to each other. For me, the key message was that the league 'represents a marathon approach rather than a sprint.' The issues raised by League require recognition that inequities may take years and even decades to resolve. The 'quick' solution, while satisfying, often has a limited impact.

The main theme of the Council, "Engaging the Future" displayed the power of recognizing when change is needed and how to effect that change. The LWV 2018 National Convention will focus on methods for implementing the Transformation Roadmap, changes I believe will result in a more nimble organization at all levels.

During the MELD (Membership, Engagement, Leadership and Development) training, the participants were given the opportunity to ask questions, offer suggestions and provide resources to one another. The end result was one of being invested in the success of the program. It is that type of collaboration that will see the League through the next 80 years!

Treasurer's Report

At the end of May, checking was \$1,111; savings was \$1,856 for a total of \$2,967.

Budget: We are under budget for both income and expenses, which is a good thing for expenses, not so much for Income. Contributions and scholarships exceeded our expectations at \$635. The budget was \$500.

Income: There was no income again. I should note that the end of the fiscal year is June 30th. Dues are not due until September 30th and a letter will be sent out late August or early September. However, anyone wanting to pay their dues after July 1 is welcome to pay me, use PayPal (<u>lwv-bf.org</u>) or send a check to P.O. Box 765, Richland, WA 99352. It would be wonderful if those using PayPal would consider adding its fee of \$2.50.

Expenses: We paid \$250 for the League Easy Web and will have to decide at some point whether to go with My League Organization (MyLO), which is the new platform and will be \$400 minus what we have already paid plus \$200 to migrate the data. All receipts for expenses and in kind should be sent to me by the end of June. The National Convention does not end until July 1st so those receipts can wait.

Membership: We still have 48 paid members and 56 in total. Madge Watson is now a lifetime member and Ginger Vetrano will be also. We need to vote on whether students can join our league for a nominal fee of \$5 or \$10. The mechanisms for student memberships are set up by the national League.

I attended the buffet dinner and keynote speeches. Our very own Susan Leckband was the keynote speaker and did a wonderful job of explaining the Hanford Advisory Board (HAB) with a little history of League's role on the HAB. The speaker from Ecology, Alexandra Smith, Nuclear Waste Program Manager at the Department of Energy, was excellent also. She discussed the waste tanks; the problems; the waste no one wants; the vitrification; and the end date of the cleanup, which depends on the funding we receive annually. David Reploeg, Vice President of Federal Programs, TRIDEC, gave an informative speech about the history of Hanford.

Sunday I volunteered in the morning and everything went smoothly. There weren't too many baskets at State Council so our three were very popular, selling for \$250 total, and we received half of the proceeds in our State Education Fund account. The volunteers get high marks for making this state Council a success. I'm sure there will be more to come. Who would not want to come to the Tri-Cities in June?

A brief overview of the Observer Corps: The League of BF has an invaluable tool in its mission of working for good government when there is a vigorous and lively Observer Corps in place. This group forms the eyes and ears of the Board as participants attend and observe the workings of governmental bodies with rule-making authority. What is the Observer Corps and how does it help the League? Observer Corps members attend council, board, commission and agency meetings to listen, observe, and make note of any information that the Board may wish to know. In particular, the Observer calls the League Board's attention to community and public policy issues that we can act/testify on based on League Position statements. Observers also identify trends or problems for future study and action by the League. Thus, timely reporting of that information to the Observer Corps Chair and/or League Chair is a primary duty of the Observer.

Update on Climate Lawsuit Lora Rathbone

Background: On February 16, 2018, 13 young people from across the state of Washington filed a constitutional climate lawsuit against the state, Governor Jay Inslee, and several state agencies in King County Superior Court. The complaint asserts that in causing climate change, the state of Washington has violated the youngest generation's constitutional rights to life, liberty, property, and equal protection of the law, and has caused impairment of essential public trust resources.

On June 1, 2018, the State of Washington Defendants moved to dismiss the Youth's case and the Youth filed their response on June 22, 2018. The Youth are supported by amicus briefs from a coalition of environmental organizations, leaders in the faith community, and the League of Women Voters of Washington. Oral argument on the State's motion will be held on July 13, 2018 at 11 am before the Honorable Michael Scott at King County Superior Court in Seattle, Washington.
