### Local Program Recommendation

Based on the conclusions of the Local Program Planning meeting (February 21, 2023), the Board recommends the following local program components:

- Voter service activities
- Participation in the Local Coastal Program update process, with an emphasis on enabling and encouraging public participation. Grass Roots Institute has taken the lead on this, and we would partner with them.
- Following our "lens" themes of climate and diversity
- Education and public involvement on emerging local issues
- Promotion of democratic values and attitudes
- Strengthening our organization by increasing participation

We support the national "Making Democracy Work" program. We will encourage individual members to use the LWVC interest group structure to pursue other themes of community concern.

Note: The Board has addressed the membership's desire for hybrid meetings. As a transitional arrangement, we plan to have a mix of some virtual meetings and some in-person meetings that will be hybrid to the extent our growing equipment and expertise allow.
