## ANNUAL MEETING MINUTES

#### League of Women Voters of Kent County - MAY 16, 2019 - Dover Library, Dover, DE

#### PROGRAM/SPEAKER

Prior to the Business Meeting, Ellen Wasfi, Board Director, welcomed attendees and provided an introduction of the speaker, Carol Jones, from LWV Sussex County who is also First Vice President of LWVDE. The topic of the program, entitled "We're the WE in We the People" provided the rationale and an overview of the work done by Carol in developing a 10-part video series which is comparable to Civics 101 for the average person. The series is focused on educating citizens about how their government works, civics being something many Americans know little about. She is also in the process of doing a similar video on the 19th Amendment. The presentation was informative and League members appreciated Carol's remarks.

A lunch catered by Panera followed the presentation.

A prepared printed packet containing the agenda and supporting information was distributed before the meeting.

The Annual Business Meeting of the League of Women Voters of Kent County was called to order at 12:30 PM by Christine Stillson, First Vice President.

Minutes of the last annual meeting: Beverly Jackson made a motion, to dispense with the reading of the minutes and to accept the minutes as published in the packet. The motion was seconded by Les Stillson, voted on and the motion carried.

Treasurer's Report: Beverly Jackson distributed a handout providing a brief report of the period ending March 31st: The ending balance was \$ 2595.36, pending deposits of \$336. The Education Fund balance was \$3,406.07. The Report was filed for audit review.

Proposed Budget for 2019-2010: Beverly Jackson, Finance Committee, presented the budget, having been distributed in the Annual Meeting packet. Few changes were made from the prior year, and members were reminded to acknowledge and record their in-kind donations so that the actual costs of League business can be illustrated. A motion was made by Ellen Wasfi to approved the budget, seconded by Les Stillson, and voted on. The motion carried.

Recommended Bylaw, Policy and Program changes: Christine Stillson noted the recommended changes as printed in the Annual Meeting Packet. She also noted that the first change below to the bylaws was mandated by LWVUS.

As recommended at the Annual Bylaws/Policy/Program Review, the following changes were proposed, motions made, seconded, and a discussion followed, a vote taken, and approved:

## Bylaws: Article III Membership

Replace current Section 1 and 2 with:

Sec. 1. Eligibility. Any person who subscribes to the purposes and policy of the LWVUS shall be eligible for membership.

Sec. 2. Types of Membership.

A. Voting Members. Persons at least 16 years of age who join the League shall be voting members of the local League (LWVKC), state League (LWVDE) and of the LWVUS; (1) those who live within an area of a local League may join that League or any other local League; (2) those who reside outside the area of any local League may join a local League or shall be state members-at-large; (3) those who have been members of the League for 50 years or more shall be life members excused from the payment of dues.

B. Associate Members. All others who join the League shall be associate members.

### **POLICY changes were:**

Board- (In first paragraph and line beginning "Each Board member..... and ending "carrying out League activities.")

Added: "Each Board member must have access to electronic communication (Email.)"

Candidate Meetings and Debates: Added: new # 8:

"8. Printed copies of these debate guidelines to be available at the door of the debate. "And Change the current #8 to #9.

## STUDY ITEMS -- Under "HEALTH CARE IN DELAWARE"

Currently reads: "With support taken from the state position, examine evolving Delaware health issues as they arise in the areas of quality, access and accountability.

Deleted period and Added: "including the Opioid Crisis and End of Life Options."

# Annual Report of the President: Christine Stillson, First Vice President.

"For the past almost two years, the League of Women Voters of Kent County has been led by Jill Fuchs, President since May 2017. She recently resigned as President due to family and health issues and we all acknowledge her tireless work in carrying out the business of our League and still being very active in the LWVDE's Advocacy Corps.

In examining the year in review, I am reminded that historically, the League's main mission since its inception in 1920 is to educate and advocate. Almost a hundred years later the League continues to be an activist, grassroots organization that believes people should play a critical (and active) role in democracy. We often don't think about how important it is to take action locally and be involved in issues of local and statewide concern. A major activity in the Delaware Leagues is advocacy at the state level. And being a small state, it means we have a lot more access to lawmakers and making our voices heard. Several of our Kent County members are working hard on our behalf in the league's Advocacy Corps.

The Kent County League's main focuses this year have included the Opioid Crisis Part II (holding a Hot Topic lunch with speakers), Candidates Nights in October (collaborating with AAUW and DSU), helping assist the newly formed DSU-LWVKC student unit, Voter Registration (having Registration tables at Pride Day in Dover, Wyoming Peach Festival, the Dover YMCA, Dover Public Library, and Bowers Beach Festival and a major Voter Registration effort at DSU), concurrence on Utah LWV's "Death with Dignity" Position (lunch and speaker Paul Baumbach), attending various activities on supporting the National Popular Vote Compact, and members actively supporting desirable legislation at the State Level. Our League also organized the Annual Joint League Holiday Luncheon, a time for all three Leagues to share ideas and to brainstorm.
