Duties: appoint the city manager; oversee the city manager and the direction of the city; approve the city budget and the tax rate; set salaries and benefits of city employees; pass ordinances and resolutions; appoint members to advisory boards.

1. What experience and knowledge qualifies you to serve on the Fair Oaks Ranch City Council?

Corley: My experiences as a combat veteran, infantry and combat engineer officer allowed me to develop time tested leadership skills performing and succeeding at every level in every climb or place. Being a data communication officer enabled me to understand and lead in a world that demands technology and high-tech systems in order to compete and survive. I was fortunate to be one of the key Officers responsible for planning, designing and implementing the Marine Corp's first global networks that is still in operation today. This first global network also included developing the first online and automated HR systems, Marine Online.

Elizondo: I am a retired MBA, CPA, CISA, CIA with over 40 years of experience. I have served the city as a volunteer or elected official for over 15 years, including two terms on FORHA in roles of Parks & Trails Chair and Treasurer, and two terms on Council. I currently serve as Mayor Pro Tem, Treasurer of the Fair Oaks Ranch MDD, the City Audit Committee, and the FM3351 and Utility Rate Study subcommittees. I also serve on the board of the KCCLEAAA, a credit union supervisory committee, and as an Honorary Commander for the 433rd Airlift Wing.

2. Why do you want to serve on the Fair Oaks Ranch City Council for this upcoming term?

Corley: Retiring as Marine Colonel in 2011 allows me to return to my family's early homestead which is now annexed into Fair Oaks Ranch. Serving my country for 24 years, I now ask to serve my neighbors. FOR has great history before 1988 as well as after. And, there is still more to accomplish. Doing such needs good judgement, unselfishness, knowledge, courage, endurance and most importantly: honor, integrity and leadership...I will serve the citizens everyday with these attributes in my mind. It is easy to ignore the "citizen" when always looking at "the city". For me, the citizen must come first!

Elizondo: I want to continue setting a solid foundation for our city's future. There are pressing issues relating to water rights and storm water that require mitigating errors of the past. Public safety and financial performance will continue to be among my top priorities. Other important initiatives include managing the impacts of city and regional growth, implementing a strategy for sustainable infrastructure, and continuing service improvements. The outcomes of Council's decisions must contribute to keeping Fair Oaks Ranch a great place to live now and into the future.

3. What is the most pressing issue facing the Fair Oaks Ranch City Council and what do you hope/plan to do about it?

Corley: I believe the majority of our citizens want to ensure our city remains that beautiful city as defined in the book "Vision to Reality" written by Gary Younglove. The most challenging issue is to safeguard the trust with our citizens. Let's develop and adopt both, a transparent and ethics-based code of conduct plus a conservative policy regarding all incoming funds as well as all expenditures. Elected officials need to practice responsibility and respect of the citizens' dollars. From my perspective, I will treat all revenue derived from fees, grants, loans, donations and/or taxes as "the citizen's" dollars – not the City's

Elizondo: Fair Oaks Ranch was first developed as a subdivision that was later incorporated in 1988. Until very recently there were no strategies for managing the impacts of growth that we are now seeing both in the city and the region. The most pressing central issue is to manage growth. To be successful we will need a foundation of strong strategies and programs for public safety, financial performance, sustainable infrastructure, and service excellence. I will continue to ensure our city is focused on these key pillars to maintain our quality of life.

4. What are the residents of Fair Oaks Ranch telling you about local problems, needs, or opportunities?

Corley: The residents are telling me that they are concerned about the constant increase in overhead and large scale projects that are intended to support future growth of our city that our officials are telling us they are also opposed to allowing to occur.

Elizondo: The citizens of Fair Oaks Ranch insist that we maintain our Hill Country Home Town quality of life. They want to feel safe, and they want city services to work. They also want their tax dollars to be used frugally and responsibly for their benefit. The opportunity is to press forward doing the things that keep our city a unique and great place to call home. The citizens of Fair Oaks Ranch deserve a representative that has a long and proven track record of doing the hard work to make those things happen for Fair Oaks Ranch.
