The League of Women Voters welcomes Judge Ketanji Brown Jackson to her historic confirmation as the next United States Supreme Court Justice. As the only Supreme Court Justice with experience as a public defender, she brings to the Court a long-needed perspective encompassing all aspects of the legal process.

Judge Jackson's appointment is a historic confirmation. We hope this will be a turning point in America and will set a precedent for the appointment of more diverse courts and therefore a more equitable judicial system. We applaud the US Senate for voting to confirm Judge Jackson and thank President Biden for delivering on his promise to name a Black woman to the highest court in the land. Powering Democracy Awards - Deadline Extended

The Powering Democracy Awards will be presented at the 2022 Convention in recognition of Leagues for their work exemplary over the past biennium. All winners will receive a cash prize from LWVUS in recognition of their work. Finalists will be selected by LWVUS staff, and winners will be selected by the public poll. **The original nomination deadline of April 21 has been extended to April 28.** Find more information on categories and how to submit <u>here</u>.

Board Recommended Program for FY22-FY24

The LWVUS board is recommending the readoption of the Campaign for Making Democracy Work® as LWV Program for 2022 – 2024. More than 300 Leagues participated in the LWVUS program planning process, and 100% of Leagues voted that LWVUS should continue prioritizing the Campaign for Making Democracy Work® in the next biennium. Leagues had the opportunity to indicate if there was another position or policy that LWVUS should work on. Staff will use those recommendations to shape the watchdog issues for LWVUS to respond to. Leagues proposing not recommended or other items need to follow the requirements outlined in LWVUS Bylaw XII Principles and Program Sec. 2(c). The Program Planning Committee will host a webinar (see webinars and virtual meetings section above) to explain the proposed program in more detail. A new

<u>platform</u> has been created for LWVUS and Leagues proposing studies and concurrences to post information on their proposals and for all League members to review and engage in discussion. For questions, email <u>progplan@lwv.org</u>.
