FEBRUARY FORUM

On February 15th, Jennifer Polinchock-Baugh, Ed D., Superintendent of the Lewisburg Area School District (LASD), presented a school district update and shared some of the challenges for school leaders during the pandemic.

Dr. Polinchock-Baugh joined the LASD in summer 2020. Some changes in education in recent years are related to the pandemic as well as to technology and social media. Because of limited face-to-face classroom time, it has been necessary to teach certain social skills and conflict resolution that would have been learned in the neighborhood/community or earlier in a child's educational experience. Less formal parent-teacher communication may be replaced by the prominence of social media/ the court of public opinion. Fewer teachers and administrators and a lack of substitutes, contribute to disruption and teacher fatigue when colleagues must cover, working longer hours. Covid-19 related issues were even more challenging this year than last.

Recent accomplishments in the LASD include: using newly available funding to modernize the HVAC system; new science activities; Equity Committee formed to seek needed support for all students; partners such as the Green Dragon Fund supplying restrooms and concession stand for athletic field; strategies to provide students with expected activities such as graduations and proms; School Board approval of salary increases for support staff.

Dr. Polinchock-Baugh also mentioned improvements that are being planned. They include an evaluation this summer of necessary

maintenance for the middle school and three elementary schools. There will be summer programming to help students keep up/catch up. She also hopes to strengthen inclusive programming, addressing the needs of all families. Although many students are well-supported by their families, others may be less visible while struggling with basic needs.

After her presentation, Dr. Polinchock-Baugh readily responded to questions and issues raised.

Redistricting: US and PA - as of 2/21/22

There are many unknowns about the upcoming primary because of redistricting in our state.

U.S. Congressional Districts

Based on results of the 2020 census, PA lost one U.S. Representative. Therefore, U.S. Congressional districts must be redrawn. The Legislature approved a map, Governor Wolf vetoed it. Other maps have been submitted, and now it is up to the PA Supreme Court, which held hearings on Friday, February 18th, about picking a redistricting map. We expect a decision soon.

Pennsylvania State Districts

Meanwhile, new redistricting maps for PA's Senate and House have been approved by a committee, but those maps can be challenged between now and the first week in March. We expect that there will be challenges.

What's Next?

Until maps are finalized, those running for U.S. House of Representatives and the PA General Assembly cannot file paperwork to run because they won't know what district they are hoping to represent. There is strong resistance

to moving the date of the upcoming primary (currently May 17th) among Democrats and Republicans, even though we are already into the time candidates would usually be filing petitions to run for office. The courts have suspended the Election Calendar (shown at the bottom of this page), pending decisions on the maps. Currently, the Election Calendar will have to be compressed if the primary date is kept.

Until we know more, Sheri Stayton, PAVOTE411 editor, will continue her work. She will report issues to the PA Department of State to encourage them to make candidate information available as soon as possible after filing deadlines so she can send Vote411 invitations to candidates. If the primary is not moved and the Election Calendar is simply compressed, there will be far less time than usual to collect candidate information. It is possible that there might not be time to produce our typical Voters Guide. However, we still expect to be able to have candidate information on Vote411.org. Once dates are final for the primary, if we do not have time to produce the typical Voters Guide, we will still make sure candidate information is made available to our community.
