At early voting locations, voters will have the opportunity to vote and insert their own ballot into the tabulator. Early voting takes place for a minimum of nine consecutive days, ending on the Sunday before an election. Voters can look up their assigned early voting site(s) up to 60 days prior to Election Day at Michigan.gov/Vote.

QUESTION 1: In my first three terms,

Policies such as providing free breakfast and lunch for students also help make sure that children and teachers can focus on learning rather than being hungry. Additionally, we have enacted policies this term that will help retain teachers by allowing them to negotiate for better pay and positions that better fit with their specializations. Reforming teacher evaluations will also allow teachers to focus on classroom instruction rather than standardized testing.

QUESTION 3: I was a lead sponsor on a bill that was part of the Clean Energy and Jobs Act, moving Michigan to a renewable energy future by 2040 and creating the infrastructure to train people in those fields. The state can also help advance public transit and transition to electric vehicles, both of

which would reduce carbon emissions. The legislature can also enact policy to help homeowners invest in energy efficient updates to their homes, such as using tax credits to help offset the costs of weatherization.

QUESTION 4: In 2023, we passed legislation to repeal the retirement tax and expand the Earned Income Tax Credit to help keep people here in Michigan and make it easier to make ends meet. We've also expanded Michigan Reconnect to help make college or trade school more affordable to keep students in state. We've also worked to make Michigan a place people feel safe and welcome by repealing Michigan's criminal abortion ban and explicitly extending civil rights protections to the LGBTQ+ community. Recent investments in our public school system and infrastructure will also help retain residents.

QUESTION 4: Since I have been in Lansing the leading approach has been How do we influence people to move to Michigan. My colleagues have been attempting to accomplish this goal by giving massive corporate handouts to attract corporations to move to Michigan. This is a mistake. However, if the attorney is privately retained, it would

be up to the litigant to address the issue, unless the conduct violates the Rules of Professional Conduct. Parties have the right to choose their preferred counsel, and judges do not have the authority to override that choice unless ethical standards are compromised. If ethical standards are violated, then there may be a duty to contact the ethics board.

Description: A proposed amendment to Section 5.3 (Regular Meetings) of the City of Belleville City Charter Currently, Section 5.3 of the City Charter requires that meetings of the City Council are held two times each month at 7:30 p.m. The proposed amendment requires City Council to set an annual schedule for its regular meetings by no later than the first meeting in December of the prior calendar year and allows the Mayor to cancel a meeting in the event a meeting has no scheduled agenda items. GARDEN CITY POLICE AND FIRE MILLAGE RENEWAL

Description: Plymouth City Charter Amendment for Parks and Recreation MillageShall Section 8.5 of the Charter of the City of Plymouth, Wayne County, Michigan, be amended to permit the levy by the City of a new additional ad valorem property tax in an amount not to exceed one and two-tenths (1.2) mills, for eight (8) years, from 2025 through 2032, to provide funds to the City to acquire, construct, improve, furnish, operate and maintain parks and recreation facilities? It is estimated that 1.2 mills would raise approximately \$834,000 when first levied in 2025.

WAYNE-WESTLAND COMMUNITY SCHOOLS PROPOSAL

Description: Wayne-Westland Community Schools Replacement Operating Millage ProposalThis proposal would, replace, restore, and extend the authority of the School District to levy the statutory limit of 18 mills on all property, except principal residences and other property exempted by law, which currently expires with the School District's 2025 tax levy and allow the School District to continue to levy the statutory limit of 18 mills in the event of future Headlee rollbacks of up to 3 mills. The authorization will allow the School District to continue to receive revenues at the full per pupil foundation allowance permitted by the State. Shall the limitation on the total amount of taxes which may be assessed against all property, except principal residences and other property exempted by law, situated within the Wayne-Westland Community Schools, County of Wayne, State of Michigan, be increased, in the amount of 21 mills with 18 mills being the maximum allowable levy (\$18.00 on each \$1,000 of taxable valuation), for a period of twenty (20) years, 2024 to 2043, inclusive? This operating millage if approved and levied, would provide estimated revenues to the School District of \$573,266 during the 2024 calendar year, to be used for general operating purposes.

WAYNE COUNTY REGIONAL EDUCATIONAL SERVICE AGENCY PROPOSAL

Description: Wayne County Regional Educational Service Agency Renewal of Regional Enhancement Millage ProposalPursuant to state law, the revenue raised by the proposed renewal of the enhancement millage will be collected by the Wayne County Regional Educational Service Agency ("Wayne RESA") and distributed on an equal per-pupil basis to local constituent school districts including eligible public school academies within the boundaries of Wayne RESA. None of the enhancement millage revenue will be distributed to Wayne RESA, and all funds shall be independently audited by the local constituent school districts and eligible public school

academies as part of their annual school audits. As a renewal of authority which expires with the 2027 levy, shall the limitation on the amount of ad valorem taxes which may be imposed on taxable property in the Wayne County Regional Educational Service Agency, Michigan, be increased by 1.9812 mills (\$1.98 per thousand dollars of taxable value) for a period of six (6) years, 2028 to 2033, inclusive, to provide operating funds to enhance other state and local funding for local school district operating purposes? Who Can Apply?

As of 2018, all Michigan voters are eligible to vote with an absentee ballot.

How Do I Vote Absentee?

Step 1: You first must submit an absentee ballot application. You can download one online, or call your Township or City Clerk to have one mailed to you. Return it by mail (make sure the envelope has proper postage and is addressed to your local clerk), or e-mail it (take a picture of the form or scan it and e-mail it to your clerk. Make sure your signature is visible), or deliver it in person to the the clerk's office.

Step 2: You will receive an absentee ballot in the mail. When your ballot arrives, read it carefully and follow the instructions to complete it and return it. Your ballot will not be counted unless your signature is on the return envelope and matches your signature on file.

What is the Application Deadline?

Application for an absent voter ballot must be received by your township or city clerk no later than 5 p.m., Friday, October 30.

What is the Return Deadline?

By 8 p.m. on Election Day, Tuesday, November 3.
