

# **IMPORTANT ANNOUNCEMENTS**

**PRIMARY ELECTION: JUNE 7, 2022** 

Mail-in Ballots will be sent out the week of May 9, 2022



In addition to voting on candidates for federal and state offices, Santa Clara County (SCC) voters will be voting on 3 major county-wide offices, one Congressional District 16 office and one county-wide ballot

measure, **Measure A**, on the June 7, 2022 ballot. Registered voters in Los Gatos and Monte Sereno will also be voting on our potential representative in the newly configured Assembly District 28.

Primary Elections determine the top two candidates who will be on the November ballot even if both candidates are in the same political party and even if one candidate has received a majority of the votes for that office.

All five Leagues in Santa Clara County are co-sponsoring these one time, virtual, county-wide Candidate Forums. *All of the Candidate Forums are being recorded and will be posted to the individual League's website and its YouTube channel.*

# **President's Message**

Dear Friends of the League,

Time flies! It's already the final month before the California Primary Election, which will be held on June 7, 2022.

Mail-in ballots will be sent out to all registered voters by the SCC Registrar of Voters starting the week of May 9, 2022. Our League and sister Leagues in Santa Clara County are hosting a series of candidate forums online. Please register ahead of time to get reminders for these important events.

The Santa Clara County League had a special meeting on April 20 in which all five Leagues in the county voted to oppose Measure A due to its misleading language; **Measure A** was placed on the ballot by the Santa Clara Valley Water District. The Santa Clara County Leagues of Women Voters determined that the measure did not meet the good governance standards that the League supports.

#### SANTA CLARA COUNTY LEAGUES OF WOMEN VOTERS RECOMMENDS

#### Vote No on Measure A

#### Press Release (April 20, 2022):

"The Leagues of Women Voters of Santa Clara County recommend a **no vote** on the proposed county-wide **Measure A** on the primary election ballot June 7. Measure A asks voters to approve an increase in term limits from the current Santa Clara Valley Water Board member term limits of three successive four-year terms (12 years total) to four successive four-year terms (16 years total). However, the ballot language says, "Shall the measure amending the Santa Clara Valley Water District Ordinance 11-01 to limit Board members to four successive four-year terms be adopted?" This language implies to voters that they are limiting the length of Board member terms when in fact they are increasing the length of available Board service from three to four terms. Therefore, the Santa Clara County Leagues of Women Voters **opposes Measure A** on the basis of **misleading ballot language**. Deceptive language that confuses voters violates LWV standards of good governance."

Judge LaDoris Hazzard Cordell will share her life experiences and journey to the Bench, her time on the Bench, and what she sees as needed criminal justice reforms. 

# WHERE, WHEN, AND HOW TO VOTE: June 7, 2022:

### **Vote In Person or By Mail**

All registered voters can vote using a vote-by-mail ballot instead of going to the polls on Election Day. Mail-in Ballots are being sent out by the SCC Registrar of Voters starting the week of May 9, 2022.

**Mail-in Ballots** can be returned in the postage paid envelope in one of three ways: via the US Post Office, via an official SCC Drop Box, or in person at a polling center.

As of 2020, Mail-in-Ballots are <u>automatically mailed</u> to every registered voter in the state of California.

#### California can save as much as \$500 Billion in Healthcare Costs

The Healthy California for All Commission Final Report, "**Key Design Considerations for a Unified Health Care Financing System in California**," was published in April.

This report shows the investigation and analysis of the healthcare system in California conducted by a Commission appointed by Governor Newsom. It provides the rationale for adopting what it terms "unified financing" to replace the current fragmented and costly system.

The Commission found that without unified financing, California will spend \$158 billion more annually on health care in 2031. By contrast, residents, businesses, and government agencies would save money within the first year of the new system—and those benefits would increase over time. The Commission's report finds California could save up to \$500 billion or more over the next decade if the state shifts to unified financing, a portion of which could pay for long term care services covering every resident in the state.

# Implementation of SB-9, Other Housing Developments and A Good Space

Every 8 years, each city will create a plan for providing affordable housing to meet the regional needs, which is called the Housing Element. Starting from January 1, 2021, AB 686 creates new requirements for all housing elements to ensure that the obligation to "affirmatively further fair housing" (AFFH) is included. More background and history can be found in the <u>introductory section of the AFFH Guidance Memo.</u> This <u>web page</u> from California Department of Housing and Community Development (HCD) includes an interactive statewide <u>AFFH Data</u> <u>Viewer to assist</u> in the assessment of fair housing, webinars and other resources.

The <u>HCD AFFH Webinar on Implementing AB 686</u> stresses the importance of reaching out to all segments of the population and reducing barriers for attending meetings, such as providing transportation. It also describes the 5 areas that must be included in the Fair Housing Assessment. It concludes with common mistakes and pitfalls to avoid since quite a few draft housing elements from Southern California cities did not get certified; many failures are due to insufficient AFFH components.

Besides AB 686, "Affirmatively Further Fair Housing" (AFFH) is a <u>long standing federal program</u> under U.S. Department of Housing and Urban Development (HUD) program:

• Title VIII of the Civil Rights Act of 1968, known as the <u>Fair Housing Act</u>, requires HUD and recipients of federal funds from HUD to affirmatively further the policies and purposes of the Fair Housing Act, also known as "affirmatively further fair housing" or "AFFH." The obligation to affirmatively further fair housing requires recipients of HUD funds to take meaningful actions, in addition to combating discrimination, that overcome patterns of segregation and foster inclusive communities free from barriers that restrict access to opportunity based on protected characteristics, which are: Race, Color, National origin, Religion, Sex (including gender identity and sexual orientation), Familial status, Disability.

Three webinars by <u>Project Sentinel</u> in its 2021 Housing Symposium give practical advice: <u>Panel: Know Your Fair Housing Rights</u>, <u>Panel: Fair Housing Protections for Families</u>, and <u>Panel: Public Policy</u>, <u>Gender</u>, <u>and Sex Discrimination</u>. <u>Project Sentinel</u> assists individuals with housing problems such as discrimination, mortgage foreclosure & delinquency, rental issues including repairs, deposits, privacy, dispute resolution, home buyer education, post-purchase education and reverse mortgages.

#### Water: Local, reliable is best

Dams and reservoirs are becoming less favored—they represent 19th- and 20th-century thinking that won't work in our 21st century faced with climate change and long-term drought. Instead, *reuse, efficiency, and stormwater capture* are methods that can bring us local, reliable water that is secure and cost-effective.

These three methods could mean less water exported from the fragile Sacramento-San Joaquin River Delta, where the water is needed instead for the environment. Efficiency alone could reduce urban water use by 30-48%—obviating the need for more dams, etc. These three methods could also "reduce the state's massive groundwater overdraft, currently at around two million acre-feet a year." <a href="https://pacinst.org/wp-content/uploads/2022/04/Pacific-Institute-Untapped-Potential-Infographic-2022-1.pdf">https://pacinst.org/wp-content/uploads/2022/04/Pacific-Institute-Untapped-Potential-Infographic-2022-1.pdf</a>.

The California Department of Water Resources has warned of a changing hydrology: by the mid-2050s, expect a 50% chance that any year will be like the 2012-2016 drought—or worse. Disadvantaged or otherwise vulnerable communities will be disproportionately impacted.

- The Leagues of Women Voters of Santa Clara County have voted to <u>oppose</u> and encourage a NO vote
  on the deceptive <u>Measure A</u> on the <u>June ballot</u>. <u>Measure A</u>, placed on the ballot by Santa Clara Valley
  Water District (Valley Water) directors, purports to "limit" Valley Water's directors to four terms, but doesn't
  mention that they are <u>already</u> limited to <u>three</u> terms. Measure A, if passed, would actually extend, not
  limit, the years the directors could remain on the Board.
- Over the last 100 years, many improvements in the health, success, and lifespan of the U.S. population
  can be linked to improvements in water quality. Providing safe drinking water was one of the most

# **CITY NEWS & UPDATES**



# **Campbell City Council**

**April:** A developer has approached the City with a proposal for his vacant office building in the downtown area. He would like to put in 100% affordable housing on his site, using SB35 and The Density Bonus to allow him to supply zero parking due to being within 1/2 mile of the light rail. SB 35 is meant to increase housing supply in cities that are not producing enough housing by streamlining the approval processes. Very few cities in the State have met their goals. SB35 encourages cities to either increase housing on their own or be forced to accept housing development. It applies only to the specific income levels not being built for. For example, if a city is building enough market-rate units to meet RHNA, but not enough low-income units, a project can only add low-income units to qualify for quickened approval.

#### **Los Gatos Town Council**

April 24: Councilmembers approved an ordinance–Military Equipment Funding, Acquisition, and Use Policy–after a public hearing presentation by the Police Department. The police are now required to annually provide the Town Council a listing of current inventory of military equipment as well as seek approval for purchases of new items. Military items already in the Department inventory include robot, drone, tear gas, rifles and ammunition. The police have purchased these, given that there have been increased risks to the community and officers in recent history. Risks cited include the mass shootings at the Gilroy Garlic Festival and the VTA Bus Yard, group robberies of multiple businesses, and officer injuries in social unrest protests.

Town staff and council members discussed the potential fiscal impacts of the Draft 2040 General Plan on the Town's finances in the future. Concerns include adequate funding of needed infrastructure improvements as the population grows, and the possible depletion of Town funds. A previous Fiscal Analysis was reviewed. A motion to obtain a new Fiscal Analysis failed.

# **Monte Sereno City Council**

**April 5:** Council discussed in detail the progress of the design of the City's new Community Center as reported by the Ad Hoc Finance Committee. The Center is being designed to be a showcase for energy efficiency, air quality inside and out, and water conservation. Among other uses, it is planned to serve as an EOC–an emergency center for use during a major fire or earthquake, etc.

**April 19:** After a lengthy discussion of State Senate Bill SB9 requirements, Council directed staff to prepare an ordinance to revise Municipal Code standards, which were approved in January but need changes. SB9 requires us to have ministerial approval of up to two housing units per lot, and ministerial approval of a one-time, two-lot subdivision (Urban Lot Split), resulting in properties changing zoning from one residential unit to four. The SB9 mandates promoting housing density are complex. One community concern is that Monte Sereno's current limit of 800 sq. ft. for additional dwelling units is impractical. Further changes in housing requirements are mandated by our Regional Housing Needs Allocation (RHNA), which requires Monte Sereno to add 193 new housing units from 2023 to 2031. Fulfilling the SB-9 ordinance can be a pathway to meeting RHNA requirements. Areas for zoning for multi-family dwellings, including low income units, are being inventoried on Vineland Avenue, Karl Avenue and Palos Verdes Drive.
