#### IN MEMORIAM - DALE HILL



We have recently lost a beloved and long-time LWV leader, Dale Hill (1928-2022). As a 50+ year LWV member and the first recipient of our Southwest Santa Clara Valley League's Helga Ruby Award, Dale was our "tribal memory." She could remember everything! Dale recruited, inspired and mentored so many of us and was always able to give sage advice and recall what we needed to know no matter how far back that was.

As a League member and friend Dale was so down to earth and unassuming that it is amazing to know all that she had achieved. She started her very active life by graduating Phi Beta Kappa from UC Berkeley, followed

by a Physical Therapy Certificate from UCSF. She and her husband Bob had three sons, seven grandchildren, and four great-grandchildren. Dale was never satisfied just belonging to a group—her natural leadership abilities and hard work always took her to the top. Among other positions, she was president of our League from 1971-1973 and VP for Management and Training on the State Board of the League of Women Voters of California from 1981-1985.

Dale was also active in our local Association of University Women and on the Board in the 1960's and 1970's. She served on the Los Gatos Planning Commission, the Los Gatos Union School District Facilities Committee, the Live Oak Adult Day Services Board, the Library Board of the Town of Los Gatos, and as President of the Friends of the Los Gatos Library. At the County level, Dale

chaired the Santa Clara County Charter Review Committee, was a member of the Santa Clara County Open Space Task Force and served as the Forewoman of the Santa Clara County Grand Jury.

How could one person achieve so much? Our communities recognized her achievements with the following honors and awards:

- 1976 San Jose Mercury News Woman of Achievement in Community Service Award
- 1978 AAUW Named Grant Honoree
- 1990 Santa Clara County Human Relations Commission, Award of Special Recognition
- 1990 Los Gatos Senior of Distinction
- 1991 San Jose Junior League "Silver Bowl Award" for Volunteer Recognition
- 1997 Live Oak Adult Day Services, Board Leadership Award

This is a picture of a highly accomplished public person, but Dale was so much more than that. She was a warm, loving person, and a great friend. She was truly one of our all-time very best members —a special person. Dale recently passed away peacefully in the presence of her family. She is survived by her children Barry, Allan, and Lorin, as well as eleven grandchildren and great-grandchildren.

#### **CITY NEWS & UPDATES**



#### **Campbell City Council**

Campbell is in the process of adopting Objective Residential Design Standards consistent with state law. Having the Objective Design Standards will enable the City to provide significant control over site layout and architectural design of new housing projects. It currently has limited or no control over them. The process includes numerous avenues of outreach to the community for feedback on the new Design Standards. The first phase will focus on priority housing types (townhomes/rowhomes, multi-family and mixed-use) for identified Housing Opportunity Sites.

**October:** During the month's Council meetings no new topics were introduced which fall within those areas of special interest designated by our League. However, work and public input continues on the Objective Residential Design Standards to coincide with the adoption of the new General Plan & Housing Elements, due in March, 2023.

#### **Los Gatos Town Council**

**October:** A resident group's referendum gathered the required number of signatures to suspend the Land Use Element and the Community Design Element of the adopted 2040 General Plan. Consequently, the Town Council voted to continue the use of the 2020 General Plan's Land Use Element and Community Design Element. This enables Town staff to proceed with their current work issuing building permits, reviewing subdivision maps, etc., without interruption. The Town will notify the California Department of Housing and Community Development about progress. The other elements in the adopted 2040 General Plan remain unaffected.

The Town Attorney outlined three actions councilmembers must consider in the next few months: (1) rescind the Land Use Element and Community Design Element of the adopted 2040 General Plan and develop them anew; (2) hold a special election in 2023 for all residents to vote on the two elements as they are written in the adopted 2040 General Plan; or (3) hold the vote on the same issue instead in the 2024 general election to avoid the cost of a special election.

Town staff reported they anticipate completing the Housing Element in the first half of 2023. It will be submitted to the California Department of Housing and Community Development for review and correction prior to bringing it to the Town Council for adoption. The Housing Element is the plan for meeting the Regional Housing Needs Assessment (RHNA) for Los Gatos for 2023-2031. It is not part of the Town's 2040 General Plan. However, the two documents should be in alignment with one another.

#### **Monte Sereno City Council**

**October:** On the occasion of its 75th anniversary, the Santa Clara County Fire Department (SCCFD) presented a report on its services to the Monte Sereno Council. M.S. does not have a fire department of its own; it contracts services from SCCFD. Fifty-nine percent of Fire Department responses to unique incidents in Monte Sereno are emergency medical (EMS) calls. Others include: customer services (24%); responses to fire alarms (7%); fires (3%); hazardous conditions (2%); and rescues (0.3%). Calls for emergencies in all categories are randomly distributed throughout the city, which reflects its mostly residential character. The SCCFD is well positioned with fire stations and equipment to respond to Monte Sereno emergencies in a short amount of time, even though the city has no fire department of its own.

At its October 18, 2022, meeting the City Manager reported that Monte Sereno has reached its goal of receiving 225 written notices by property owners stating that they intend to create an accessory dwelling unit (ADU) on their property in the next seven years. These 225 property owners are entitled to a 50% discount on building permit and plan review fees if they are issued a building permit for the creation of a new ADU by the end of 2029. It is not too late for property owners to sign up for a wait list. Details are being worked on. Encouraging ADU's is part of Monte Sereno's process for achieving agency mandates for increasing municipal housing densities.

During the next seven years, Monte Sereno residents may schedule a City representative to visit their home to answer questions regarding building an ADU on their property.

#### **Saratoga City Council**

The General Municipal Election of the City of Saratoga will be held on Tuesday, November 8, 2022, for the purpose of filling three Council Member seats and submitting to the voters the following Ballot Measure regarding City Council term limits:

"Shall the City of Saratoga adopt an ordinance establishing term limits for members of the Saratoga City Council, limiting individuals to serving two terms and specifying the duration of various types of partial terms that are considered a term for the purposes of term limits?"

**October:** On October 5th the Saratoga City Council reconsidered and confirmed findings pursuant to Assembly Bill 361 of the continued public health officials' recommendation to social distance and to therefore continue the option of holding City of Saratoga Brown Act meetings by teleconference and move to the hybrid option for future meetings beginning with the 7:00 p.m. session on November 2, 2022.
