GENERAL ELECTION: NOVEMBER 8, 2022

Mail-in Ballots will be sent out the week of Oct. 10, 2022



In addition to voting on candidates for federal and state offices, Santa Clara County (SCC) voters will be voting on 1 major county-wide office, one Congressional District 16 office, 1 newly configured CA Assembly District 28, SCV Water Board seat 7, local candidate forums and ballot measures.

The Leagues in Santa Clara County are co-sponsoring these one time, virtual, county-wide or newly-configured district Candidate Forums. You must register for each one separately in order to attend.

# WHERE, WHEN, AND HOW TO VOTE: November 8, 2022

#### **Vote In Person or By Mail**

All registered voters can vote using a vote-by-mail ballot instead of going to the polls on Election Day. Mail-in Ballots are being sent out by the SCC Registrar of Voters starting the week of Oct. 10, 2022.

Mail-in Ballots can be returned in the postage-paid envelope in one of three ways: via the US Post Office, via an official, secure Drop Box, or in person at a polling center.

Go to a Voter Center (open 4 to 11 days before the election) if you:

- Make a mistake and need a replacement ballot or you lose your ballot!
- Didn't receive your ballot and need one!
- Need material in another language or need accessible voting equipment!
- Register and vote on the same day!

As of 2020, Mail-in-Ballots are <u>automatically mailed</u> to every registered voter in the state of California.

The postcards will let voters know that their vote counts and to check with their county registrar to make sure their registration is still active. Research has shown that this personal touch has made a big difference in voter turnout in past elections.

What can the League of Women Voters—and you—do to improve our elections? The LWV of SCC is sponsoring **two webinars** on "State of the Nation: Threats to Our Election Systems/Security and How We Can Better Engage Voters."

On October 8, 2022, keynote speaker Kim Alexander, President of the California Voter Foundation (CVF), will explore what some major election problems are and offer possible solutions. In response to growing threats and harassment of election officials, Kim and CVF are leading a nationwide, nonpartisan network of leaders across multiple sectors working to support and protect election officials and election administration. Current priorities include improving election workers' safety and security, curtailing election mis- and disinformation, increasing funding and support for election administration.

One of the promising approaches to improving elections, Ranked Choice Voting, will be explored more in-depth at a second event on still-to-be-confirmed October 22nd or 29th. The five LWVs of Santa Clara County support using RCV for all County offices—Board of Supervisors, District Attorney, Sheriff, and Assessor—and wrote this August 10, 2022, letter to the County Board of Supervisors recommending its use.

# "Water is the messenger that's delivering the bad news about climate change ... to your front door."

In fact, a recent survey reported that water supply and drought constituted the most important environmental issue facing the state. And 71% of voters surveyed recently called California's water shortage "extremely serious."


Expensive projects like dams, whose construction and operation exacerbate greenhouse gases and lose substantial water amounts to evaporation, are not the best solution. Water expert Jay Lund has estimated evaporation from California's existing reservoirs and canals at about 2,000,000 acrefeet/year (2maf/y). Furthermore, dams silt up as they age, losing capacity. Algal blooms are also a growing problem.

So, instead of looking to dams or imported water, we can look to local sources. San Francisco Bay Area could save about 915,000 af/y just from water efficiency, reuse and stormwater capture, according to the Pacific Institute. This means water that we don't have to import more from other parts of California. (Pacific Institute totals for all California water savings statewide: efficiency—from 2.0 to 3.1 maf/y; reuse—from 2.5 to 2.8 maf/y; urban stormwater capture—from 580,000 af/y to 3 maf/y.)

Clearly, we can do well with just efficiency, reuse and stormwater capture.

#### **National**

"LWV of Missouri sued Missouri to stay the enforcement of a law which criminalized voter engagement efforts, violating equal protection and the fundamental right to vote. Anyone who assists with more than 10 voter registration applications who fails to register with the state or be a registered voter is subject to severe criminal sanctions. The law prohibits "soliciting" a voter to obtain an absentee ballot, denying Missouri voters the help they need to vote and stifling LWV and NAACP voter registration activities. Read more HERE."

#### State

"The deadline for bills to pass both houses is midnight, Wednesday, August 31. Recent bills supported by LWVC:

*Criminal Justice Reform:* The Racial Justice for All Act (AB 256) would permit people harmed by convictions tainted by racial bias to vacate the conviction. The California Mandela Act (AB 2632) would place limits on solitary confinement beyond 17 hours.

Campaign Finance Reform: SB 1439 would extend to 12 months the period in which local elected officials may not accept contributions over \$250 from parties with an interest in a local decision and would require public disclosure of contributions before the local decision is made. AB 775 would preclude the use of pre-checked boxes to sign people up for recurring campaign contributions.

*Climate:* If Gov. Newsom signs SB 922, it will exempt certain projects from CEQA, including bike lanes and bus or rapid-transit projects. SC Resolution 53 declares a Climate Emergency.

Housing: AB 1466 is now law. It requires county recorders to remove racist language from deeds. AB 2817 would provide \$1billion rental assistance to unhoused citizens for permanent housing, based on pilot projects showing that rental subsidies of \$200-\$500 per month result in stable housing.

Education: AB 469 is now law. It requires the Student Aid Commission to help all students complete the Federal Application for Federal Student Aid (FAFSA)."

#### **CITY NEWS & UPDATES**



#### **Campbell City Council**

**August:** The City released the Public Review Draft of the 2023 Housing Element for a 30-day public comment period (June 9 - July 11). The draft is available on the City's website.

Presently there are no candidates running in two of the three districts up for election to the City Council. The remaining district had only one candidate (the incumbent). Candidate filing ended on August 17. The Council discussed options for either canceling the election in districts with zero or only one candidate or allowing the election to proceed, which would thereby allow for write-in candidates. A write-in candidate needs to get 50% + 1 of the write-in votes after getting 20 valid signatures to be eligible. There was much discussion about single-issue candidates possibly being elected by the write-in system. If the election is canceled, the Council would have a very short time to make an appointment after the date of cancellation. The Council sent staff back to get more information before it would make the decision about going ahead with the election or canceling it.

The Council did agree to keep the \$300 fee for a candidate to place a statement in the Voter Guide. The City pays the rest of the \$2,400 fee. A chart was shown in which Los Gatos and Saratoga require the candidate to pay the entire fee. The Registrar of Voters is asking for the fee to be increased to \$2,700 in its present budget.

Campbell is in the process of adopting Objective Residential Design Standards consistent with state law. The adoption is proposed to coincide with the adoption of the new General Plan and Housing Element in March, 2023. Having the Objective Design Standards will enable the City to provide significant control over site layout and architectural design of new housing projects. It currently has limited or no control over them. The process includes numerous avenues of outreach to the community for feedback on the new Design Standards. The first phase will focus on priority housing types (townhomes/rowhomes, multi-family and mixed-use) for identified Housing Opportunity Sites.

#### **Los Gatos Town Council**

**June - August:** Los Gatos Town Council did not meet in July and the following summarizes items of interest to our membership that were covered in Council meetings held in June and August.

Town Councilmembers decided to maintain an existing ban on cannabis businesses in Los Gatos. In June, a public hearing was held with cannabis business consultants, Town staff, and residents. The consultants reported that their community survey of residents showed a lack of support for the sale of recreational cannabis products which typically account for 90% of total cannabis sales. Medical use sales generally comprise only 10% of the total. Town staff reported the increased cost of expected law enforcement needs would not be fully recoverable by revenue collected through sales tax and business license taxes.

After public hearings, the Draft 2040 General Plan was adopted by a 3-2 vote of the Town Council. The Environmental Impact Report was certified. Housing was the main element of concern. The General Plan aims for adding more than 3,100 housing units over the next two decades. This projected growth would be through: (1) increased development of high-density residential neighborhoods; (2) lot splits enabled by SB9; and, (3) more Accessory Dwelling Units (ADUs). Growth is limited in the hillsides amid concern for safety in high-fire-risk areas. A further concern was expressed regarding the increased costs to Los Gatos for infrastructure improvements and Town services needed to support this growth.

#### **Monte Sereno City Council**

**July:** The Monte Sereno City Council announced that three Council positions need to be filled in the November 8, 2022, election. To declare oneself a candidate, the city's website instructions would have had to be acted upon before the August 12 deadline.

California requires all local governments to prepare an updated Housing Element every eight years. The City is currently preparing its update for the years 2023-2031. It must include a plan to accommodate an additional 193 new housing units. The City prefers these units be in the form of Accessory Dwelling Units (ADUs). This type of home, rather than apartments, large houses, etc., will help maintain the rural character of Monte Sereno and should best meet the needs of current and future low-income residents.

The Council made it clear that it objects to mandated "one size fits all" housing policies. It said, for example, that State Senate Bills SB9 and SB10 both would strip away parts of local control of housing and zoning. The Council is continually working toward the goal of meeting the housing needs of the community.

A special meeting was scheduled by the Council to have been held at 7 p.m., July 21, to consider a possible reduction in building permit fees for projects that create an ADU; and, to update the planned community-wide outreach program for encouraging ADU creation.

During the next seven years, Monte Sereno residents may schedule a City representative to visit their home to answer questions regarding building an ADU on their property.

**August:** During August, focus remained on developing the City's 2023-2031 Housing Element which is open for public review until September 8. The detailed draft is posted at <a href="www.AtHomeinMonteSereno.com">www.AtHomeinMonteSereno.com</a>. It will be discussed at the Council's meeting on September 8. In order to achieve the housing goals mandated by the State of California, the City is conducting a campaign to motivate citizens to plan and declare Accessory Dwelling Units (ADU's) on their property. For a review of that effort, refer to the comments above under the July meetings report.

The Council was looking forward to its annual August picnic in Vasona Park. This popular, family-oriented event is for neighbors and civic leaders to relax in the summer sun. Earlier, on August 2, some Monte Sereno neighborhoods celebrated National Night Out.

Around August each year the Council reviews the progress of its Ad Hoc Committees. Each committee is formed to accomplish a specific task. Currently those committees scheduled to complete their task by the end of the year are: Veterans Memorial; Climate, which addresses concerns about climate change; Housing Legislation; and Operations and Outreach.

#### **Saratoga City Council**

The General Municipal Election of the City of Saratoga will be held on Tuesday, November, 8, 2022, for the purpose of filling three Council Member seats and submitting to the voters the following Ballot Measure regarding City Council term limits:

"Shall the City of Saratoga adopt an ordinance establishing term limits for members of the Saratoga City Council, limiting individuals to serving two terms and specifying the duration of various types of partial terms that are considered a term for the purposes of term limits?"

**August:** At its August 3 meeting, the Council approved an "Argument in Favor" for the City's Term Limit Ballot Measure to be presented for voter consideration on the November 8, 2022, General Municipal Election ballot. Then, at its August 17 meeting, it approved a "Rebuttal Argument", to be used if any "Argument Against" the City's Term Limit Ballot Measure happens to be submitted.

The Council reconsidered and confirmed findings, pursuant to Assembly Bill 361, of the public health officials' recommendation to continue social distancing for COVID and to therefore continue the

option of holding City of Saratoga Brown Act-compliant meetings by teleconference.
