Last Month's Program: **Reconnecting after the Election**




Our Book Club: Due to the holidays, our next Book Club Meeting is not until January 20 but it is time to get your library requests in for the upcoming books.

Homelessness in Anoka County

Many people are slipping into homelessness now due to job loss from the pandemic and other factors. LWV ABC member Sue Dergantz volunteers with Family Promise in Ramsey, helping those experiencing homelessness find more stable housing. Here's what Sue says about how we can help:

"Right now Family Promise in Anoka County families are being housed in hotels for social distancing reasons. Donations of money would be welcomed or prepared meals for the families. That could be coordinated with the executive director, David Frei. (763-568-7349)

Once families are placed in permanent housing, there are many need to be met as far as furnishing their new home: bathroom, bedroom, kitchen items galore are needed.

One year I gathered some friends that were willing to do Christmas shopping for the families. I had each family write down on a wish items needed and this wanted. If clothing, sizes were noted... It was a real success! The county has gifting for families in need, but they don't have the freedom of actually getting what they want.



Family Promise is always in need of personal care products, cleaning supplies, sometimes sessions clothing. Again, that could be coordinated with David.

Highlights of LWV ABC Board Meeting Minutes, Nov. 23, 2020

We discussed the issue of League's non-partisan position. Do we go too far to appear non-biased? Are our values being compromised? Are we giving too much of a platform to very minority parties? We decided to set up a group to work on this issue.

The board members who have been working on revisions to our bylaws gave us a report of their work so far. This has not been done in awhile, and many things have changed in the past couple of years. Bylaws are necessary to handle some situations that come up. They studied the idea of who has the authority to make some decisions, the board or the membership? We decided to look to the national and state leagues' bylaws and used them as a template.

Join us for a presentation and discussion

In response to an excellent suggestion in the last Advocacy and Program for Action Team (APAT) meeting, LWV Minnesota will host two 1 hour Zoom presentations/discussions to discuss the LWV Minnesota 2021 – 2022 PPFM Strategy. These meetings will be held at 7:00 PM on Thursday, December 17, 2020 and 7:00 PM on Thursday, January 7, 2021. This presentation will feature Nick Harper, LWVMN Civic Engagement Director and Paul Huffman, LWVMN Redistricting Coordinator. The information presented will support the objective of enabling local Leagues and individuals to engage in those aspects of redistricting that most interest them, in a manner and with a level of commitment that works for them.

The key areas we will discuss include:

- Estimated timeline for state and local redistricting activities
- Current status and strategy for legislation to address state-wide (congressional and legislative) redistricting;
- Focus on local redistricting efforts, both for local redistricting and to influence; legislators to reflect local interests in state-wide redistricting;
- Tools for mapping and support/training to be available;
- State alliance for redistricting and opportunities to development local partnerships;
- Opportunities for local Leagues and individual League members (and non-members) to participate in and support the PPFM Campaign.

Since this is only an hour we will not be able to go into great detail on any single aspect of the plan for the next 2 years. Due to the importance of local engagement and action, we will schedule meetings in January to discuss local redistricting and communities of interest in greater depth.
