# Join us for our February Monthly Program Meeting

*County Government in the Metropolitan Area* – A study by the Council of Metropolitan Area Leagues (CMAL)

**Date:** Monday evening, February 14 **Time**: 6:30 Social, 7:00 Program **Where**: It's a virtual meeting, via Zoom – Zoom link will be sent to members in an email. Because this is a consensus meeting, only LWV ABC members may participate in the voting.

Vice President Julie Trude will provide an overview of *County Government in the Metropolitan Area*, a study that was conducted by CMAL to update CMAL's position on this subject. The study committee, led by Mindy Greiling (LWV Roseville Area) engaged in research regarding the accountability, visibility and accessibility of county governments as well as the relationship between county government and other levels of government. Other LWV ABC members who participated in producing this report are Dee Ann Christensen and Wes Volkenant.

Hear county comparisons and participate in consensus questions that will establish CMAL's position on county government. Help LWV ABC develop their input to the study with your vote on the consensus questions. Input from members is critical for LWV ABC to develop our position on this study.

# An Update on Redistricting

Let's begin with some key dates, past and forthcoming, for 2022:

- Monday, January 31 2022 "Short" Legislative Session will convene.
- Tuesday, February 1 Precinct Caucus evening
- Monday, February 15 Legislative proposal for redistricting Congressional and Legislative boundaries is due. (Since the Senate is controlled by the Republicans and the House by the Democrats and each has a proposal that favors their own party's chances for the next decade, an agreed-upon proposal is unlikely.)

**Monday, February 15 (or shortly after)** - With no single Legislative proposal in place, the Judicial panel of 5 Minnesota judges, appointed by the State Chief Justice, will release its Congressional and Legislative plan, which will be the Minnesota redistricting from 2022 to 2032. As the judicial panel has already conducted public hearings and solicited input from interested parties, it is likely that the panel will release its determination very quickly after the Legislature fails to submit a single proposal to the Governor.

There were two excellent *MinnPost* articles in the past six weeks that **I recommend for your reading prior to February 15**. The <u>first by Peter Callaghan</u>, looks at who the five-member judicial panel is composed of, and what some of the considerations they will have been considering these past few months.

The Senate and House Republican and the Senate and House DFL each drew up maps they submitted as Senate and House Majority and Minority proposals to the judicial panel already. There were over one hundred proposals submitted besides those four. The judicial panel, earlier this month, chose to have four proposals argued/discussed orally before them. One of those (Wattson) is closely connected to LWV-MN this year. Another was presented in the interests of Communities of Color. And there were proposals than effectively were the Democratic State Party and Republican State Party's proposals apart from those of their, should we say, self-interested legislators. This is an excellent article with access to map proposals that you can compare to the judicial panel's final result.

None of these proposals divvy up Anoka County and northern Hennepin County the same way neither in Congressional terms nor in terms of the legislative districts. Once known, the cities and then the school districts and counties can begin their process of drawing up precincts, perhaps wards, and even commissioner districts by the end of April.

So, I'm on pins and needles already. I hope that after you explore this further yourself, your appetite for our new political future will be whetted, as well.





## Help Register New Citizens to Vote!

In 2022, Citizenship Ceremonies continue to be held at RiverCentre in St. Paul. Each Citizenship Ceremony day, approximately 1,200-1,400 people became citizens through numerous 15-20 minute ceremonies of about 65 citizens each. The League of Women Voter will have to have 8 tables for League members to register voters out in the hall where new citizens exit following their ceremony. Masks are required.
