

Calling for the Census

Do you remember getting an email from LWV ABC in mid-April, offering you a chance to help inform and remind people about filling out the Census. Alyssa Kreuzel, LWV ABC member and Community Engagement Specialist for the City of Fridley, is working with the State Demographer's office to organize Census reminder calling for Anoka County. Cindy Wetzel, LWV ABC member from Columbia Heights is organizing LWV ABC volunteers. This hasn't been a smooth process, but since the Census Bureau is working to get a three month extension we will have time in the months to come.

The calling is done from your home, using a dialer that shows the person you're calling a different number, keeping yor phone number private. Cindy will mentor you in using this simple process. Calls are placed one afternoon and one evening a week; callers can work as many hours they want. Thanks to the LWV ABC members who have already volunteered, more volunteers are needed once they get things sorted.

Following is Cindy's letter with the basic information on this project. Please contact her if you are interested in working on this project – her contact info is at the end of the email.

Dear Members,

While in-person voter registration events, legislative meet-and-greets and every other face-to-face event has been put on hold or outright canceled, an opportunity has come our way to help with the 2020 Census in Anoka County—from the comfort of our own homes!

Alyssa Kruzel, the Community Engagement Specialist for the city of Fridley, is working with the State of Minnesota Demographer's Office to organize at-home phone banking for the census. They will will provide the callers with the voter registration list for Anoka County. Volunteers would contact the households on the list to encourage them to complete the census. Calling can be done either via telephone or computer/tablet. All phone numbers will be masked—both the number you are calling and the number you are calling from. The Demographer's Office will provide each caller with a script. We would only be talking about completing the census and NOT helping them fill out the form. We will be able to provide information about who to contact for assistance in completing the census.

This phone banking could be accomplished if we have 10-15 people calling one day and one evening/week for 2-3 weeks. Each session would be approximately 2-3 hours. The League of Women Voters-ABC is just one organization that is being approached for volunteers.

This project is in the early stages of its organization. But because the completion date for the census has been pushed back to July 31 due to the pandemic, we have some extra time. As they become available, I will let you know more details.

Please consider volunteering for this project. All levels of participation are happily accepted! We all know how vital an accurate and complete census count is for Minnesota. Here is a chance to stay safe, stay at home and stay connected.

Scaling Vote at Home Processes for Safe and Secure Elections

The Webinar, "Scaling Vote at Home Processes for Safe and Secure Elections" was presented May 5, 2020, by the Humphrey School of Public Affairs as a class for their Certificate in Election Administration Program. Doug Chapin, Director of Election Research at Fors Marsh Group hosted Amber McReynolds, CEO of the National Vote at Home Institute (and former City Elections Director in Denver, Colorado).

Ms. McReynolds shared a slide show titled, "Delivering and Strengthening Democracy". She had four main slides:

- 1. In-person Voting has had issues over time
 - a. long lines, machine breakdowns, running out of ballots, etc.
 - b. significant challenges for election officials
 - c. fixing bad policies
- 2. Time to Act is Now
 - a. ensure every voter can vote in a safe, secure, accessible way
 - b. decisive, immediate action is needed
 - i. only @160 days remain before ballots are sent overseas, such as for the military
 - c. political leadership and will are needed
- 3. Support (implementation); Train (election officials on best practices); Provide (guidance); Advise (election officials on strategies)
- 4. Vote at Home (she put up a US map on the status)
 - States that are fully Vote at Home (in-person option is provided): Washington, Oregon, Utah, Colorado, Hawaii
 - b. Transitioning to full Vote at Home: California
 - c. No Excuse, Permanent, Mail Option: Montana, Nevada, Arizona, Virginia, New Jersey
 - d. Several states use a No Excuse Absentee Ballot system that need to be rerequested each election: Minnesota, Wisconsin, Illinois, Iowa, Nebraska, Kansas, Oklahoma, New Mexico, North Dakota, South Dakota, Idaho, Wyoming, Alaska, Michigan, Ohio, Pennsylvania, Vermont, Maine, Florida, Georgia, North Carolina

States that require an excuse for an absentee ballot do not identify the pandemic virus as a valid excuse to request a ballot.

During the Q & A period, we learned only Colorado, of the five Vote at Home states does not provide a pre-paid postage return envelope. The Postal Service is indicating it will deliver

absentee ballots without postage, but it then bills the office receiving election materials. In a question about fraud, she noted the rarity of voter fraud, and there's no evidence vote from home increases its incidence. Homeless, transient voters can still vote in-person under the open, pre-election period in many states. They also often have "home" P.O. Box addresses at which they can receive their government mail.

This was an enjoyable webinar. Amber McReynolds is very involved in the 100-year anniversary of women's suffrage. She co-authored a new book with Stephanie Donner, "When Women Vote," which takes interviews with women and ties in not only 100 years of women voting, but takes a look at election infrastructure, and suggests we have a long way to go for better voting, advocating changes in the infrastructure.

I looked - the book is available in paperback through Amazon for \$14.95. I would advocate the League purchase two copies to circulate among interested LWV-ABC members.
