



## Highlights of LWV ABC Board Meeting and Annual Retreat April 25, 2022

The Membership Chair reported on a DEI Roundtable Meeting she attended that featured the Hennepin County Elections Voter Outreach Director as guest speaker. The Outreach Director focused on working with underserved populations to give them access to voting. They will be publishing a Voter Tool Kit to help people register to vote. We need to think about outreach to homeless people in Anoka County, to try to make contact and encourage them to vote.

The Program Committee outlined the topics for our upcoming membership meetings. Our May meeting will be a student presentation at the Andover City Council chambers, which will be video recorded by QCTV. A possible subject for our June meeting will be environmental topics, and we may connect with Transformative Circle on a Juneteenth celebration at the Coon Rapids Dam as well.

We then discussed the Action Chair position on the Board. We really do not have a common understanding of what the Action Chair's duties are. After doing some research on how other Leagues handle this issue, we decided that the Action Chair would not have the same restrictions on political activity and nonpartisanship as the President and Voter Services Chair.

All league members are welcome to attend programs, but only delegates may vote or serve on the board. Votes occur on bylaw amendments, position changes and whether to support new studies. Currently, there is an open one-year board position with CMAL.

## **CMAL Proposed County Government Position 2022**

CMAL supports measures to ensure accountability and visibility of county government. (1975, 2022)

CMAL believes that accountability and visibility of a governmental body, such as a county, are obtained by:

- ✓ Effective communication of its policies and procedures to residents of the jurisdiction;
- ✓ Public access to the budget process where priorities and policies are set, including an opportunity for the public to give timely and meaningful input;
- Offering members of the public opportunities to provide timely and meaningful input into policy development, county initiatives and capital projects, including, by way of example, one-on-one meetings with county commissioners, virtual and in-person town meetings, and open houses;
- Provision of ample and easily accessible notice of the location, time, date and agenda for county board meetings, county board committee meetings, county board work sessions and county advisory committee/commission meetings;
- Posting on its website minutes or discussion notes from county board meetings, county board committee meetings, county board work sessions, and county board advisory committee/commission meetings;
- ✓ Posting on its website video recordings of county board meetings and county board committee meetings;
- Dissemination of information on the procedures for appointment to advisory committees/commissions, as well as posting the number of members for each committee/commission and the identity of current appointees;
- Ensuring public access to county board meetings, county board committee meetings, county board work sessions and county advisory committee/commission meetings, plus the opportunity for members of the public to make public comment at county board meetings and county board committee meetings;
- Regular communication between county government and municipalities and between county government and other levels of government.

CMAL also recognizes the responsibility of residents to become adequately informed.

CMAL views the Metropolitan Council as the regional planning and coordinating body, while the counties are viewed as administrators, implementers and enforcers of regional policy. CMAL believes that counties should be involved in the initial planning and policy-making stages of Metropolitan Council activities in order for counties to carry out their eventual implementation.

CMAL supports measures to improve cooperation and communication between the Metropolitan Council and county government in the metropolitan area.

CMAL believes that county government should post general information on its website about funds received from or through the Metropolitan council and how such funds are used.



## **LWV ABC Proposes Redistricting Maps to Anoka County Board**

LWV ABC members actively engaged in preparing and submitting proposals to the Anoka County Boar to urge a more effective redrawing of new district boundaries following the 2020 census.

Past practice by the Anoka County Board for this every-10-years activity had been to make minimal changes. Alternatively, League members proposed maps that provided a new outlook recognizing the differences in communities and combining communities of interest — and urged adopting a new plan that would be superior to modifying the current plan at its edges. The League's plans were prepared following a vigorous review of population data and Anoka County's communities.

At the county board workshop on April 12 Commissioner Schulte acknowledged the receipt of LWV ABC's proposals, but erroneously dismissed them as not meeting established redistricting criteria. In that meeting and in future redistricting discussions of the county-presented maps, the commissioners seemed to focus on incumbent protection and making minimal changes.

The commissioners' discussions occurred in county board workshops and in a county board meeting where there are no provisions for public comment. Commissioner Meisner then offered a time for public comment at the Property Records and Taxation Committee on April 19 in advance of the County board's April 26 meeting where a final decision would be announced; and it was noted that the public could submit written public comment for the April 19 meeting.

In the end, the commissioners advanced yet a further version of their maps, with still minimal changes to previous district lines, at their April 26 meeting, and their Map C passed on a 6-1 vote.

While none of the maps presented by the Anoka County commissioners met the League's desired outcome of valuing communities of interest while adjusting for population\*, some public visibility and creating awareness of the absence of public input was achieved. The League is further motivated and enlightened to continue pursuit of transparency in governmental decision making.
