## Transition of the Banfill-Locke Center for the Arts LWV ABC Meeting on August 9

We met at the historic Banfill-Locke House in Fridley on August 9 for an update from Executive Director Abby Kosberg on changes in store for this arts organization. They will be losing their home at the Banfill-Locke House, but Abby described planning that’s underway for locating a new space, new funding, new partners, and expanded arts



services to the communities.

North Suburban Center for the Arts is the new (and old!) name of the Banfill-Locke Center for the Arts. Anoka County has helped to support this arts organization since 1988 but that funding ends on December 31 and the organization is losing its home at the Banfill-Locke House. Abby's challenge is to lead this organization into a new space and new funding, which will be challenging!

The fire station sits at the corner of East River Road and 77th Way NE.”

**Digital Billboards**

New LWV ABC member Rachel Mero has set up an opportunity for LWV ABC to share messages about Voter Registration Day (Sept 28) on the big digital billboards along Hwy 10 in Blaine. The billboards will be up for 2-3 days leading up to and including the 28th. Some cities and other organizations with digital billboards may run this as well.

**Libraries**

**Newspapers**

## **ABC Members Study Anoka County Government**

Interviewing Anoka County Board Chairman Scott Schulte last week, Dee Ann Christenson was happy to hear him compliment the CMAL League of Women Voters for studying metro area county governments to better inform the public because, he declared, people just do not know what counties do, "it's the hidden level of government." Further, he hoped to learn something from the completed report, as, "I support best practices," he stated. If another county is doing something in a better way than Anoka, then we should learn from them, he concluded.



Even though the summer weather entices us to enjoy the outdoors, Wes Volkenant (study group chair, treasurer, CMAL representative), Julie Trude, (VP, CMAL representative), and Dee Ann Christenson, (program chair), worked together to answer dozens of questions about Anoka County government operations, procedures, public responsiveness, their work with residents on parks and roads and with legislators on their priorities. As regular observers of Anoka County Government, Wes and Dee Ann are familiar with many practices, but initially the study seeks to find what can anyone find through published sources. For example, most of us could find how to contact our commissioner or when and where does the board meet.

Moving to the second phase of the study, the team will interview commissioners and administrative staff to learn more. Do you wonder how much a commissioner is paid? Are they considered part-time? How do commissioners get input from the public as they make policy decisions? Will they adopt an ethics code? At what meetings can a resident ask questions or make comments? Are there recordings of committee or board meetings? Will practices altered for Covid remain? How do they decide what a priority is for the budget or for lobbying? Who influences their decisions?

Dee Ann's recent interview of Board Chair Scott Schulte focused on how he collects public input, how the board sets lobbying and budget priorities, how the county works with neighborhoods on road projects, and how the Board works with cities and the Met Council. Julie is seeking to interview County Administrator Rhonda Sivarajah about operations and processes. Wes will interview Commissioner Mike Gamache to discuss accountability, public input on parks and other topics.


All study groups will have their information compiled into one report this fall with publication anticipated in early 2022.

**Highlights of the August Board Meeting**

The Board heard from the Voter Services Committee about our preparations for National Voter Registration Day, which occurs on September 28th this year. A new marketing tool this year is a digital billboard. It looks to be an exciting new way to get our message out, and is not very expensive. We also discussed how to handle the Meet the Candidates forums that we will be doing this Fall for two school board elections. Should we hold them with a live audience, or go with a taped, no audience, format. We decided to gather more information before making a decision on it.

The Program Committee reported on our plans for topics for our upcoming membership meetings. Our September meeting will cover redistricting issues brought about by the results of the 2020 census. The committee is also working on a program about policing in Anoka County. In November, we could have Anoka County Sheriff James Stuart speak on issues such as, the forensic lab, the need for a new jail, and budget issues. Then in January we could hold a panel of city and county police officers discussing these issues.
