### Why is Redistricting Important?



- Redistricting is about representing <u>community</u> <u>interests</u>
- It determines:
  - What <u>voices</u> are heard
  - What (policy) interests are served
- Group or community voices that are <u>diluted</u> or <u>isolated</u> may not be heard and their interests may not be served
- Think Policy not Party





## How are Maps Drawn in Minnesota?



### Redistricting Elements




- People Who make the decisions and draw the maps
  - In Minnesota the people drawing the maps are the same elected officials that will benefit from the maps – Legislators, County Commissioners, City Council members
- Principles What needs to be considered to make a map "fair" (Hint: It's more than just the legal minimum)
- Process How the maps are drawn
  - How is public input, involvement and review part of the redistricting process?
  - Minnesota is among the worst in the country for public input and involvement in redistricting



## Where Do We Go From Here?



### 2021 – 2022 Redistricting Timeline



- Fall 2021 MN Legislative hearings on revision of state maps
  - House Committee for CD6 on 9/13
  - Senate Committee for CD3 and CD6 TBD
- October 11- 20, 2021: Special Redistricting Panel hearings (input to Supreme Court)
- October 2021 January 2022: City/County Governments decide on local redistricting process
- 2/15/22: Court Issues Final Redistricting Order
- February April 2022: Local Redistricting Hearings
- 3/29/22: City redistricting complete
- 4/26/22: Other local redistricting complete



#### Options for Action



- **State**: Provide testimony (written or verbal) to legislative redistricting committees
- Courts: Provide testimony to Special Redistricting Panel (court of currently serving judges) regarding interests on current and potential maps



### Options for Action - Local



- Postcard/letter/email campaign to local elected officials responsible for redistricting (counties and cities with wards)
  - Ask what plans are for conduct of redistricting
  - Advocate for public <u>input</u> before maps are drawn and public <u>review</u> of draft maps
  - Suggest defining redistricting principles that place priority on minority representation and communities of interest above political boundaries
  - Make suggestions consistent with "good practices
  - Be polite and persistent
- Partner with other community organizations to prepare to provide comments on existing and proposed maps before and at meetings



#### LWV MN PPFM Focus Areas



- Today: Influence 2021 2022 development of state and local district maps through litigation, advocacy and supporting community mobilization of partners
- Future: Target 2026 for legislature and constitutional amendment to reform redistricting in Minnesota
  - Engage, educate, and mobilize <u>communities</u> to advocate for public involvement, transparency and consideration of community interests in redistricting
  - Educate and advocate change legislature to for long term change that reduces to potential for gerrymandering redistricting in Minnesota before 2030!
