President's Letter - May 2024

## Dear LWVSC Friends,

I was recently browsing for information on the LWV New York State website and came across a wonderful section, "Civics Education in New York State". More than just a basic statement on why civics should be taught to NYS students, it's a complete curriculum for teachers. The sections include:

- Structure of NYS Government
- Individual Rights & Responsibilities in NYS
- Voting in NYS
- The Public Policy Process (Laws) In New York
- Influencing NYS Government
- Participating in Political Action in Your Local Community

Each topic includes lesson plans, worksheets, how-to's, and resources that a teacher could use as a basic curriculum for the classroom or that anyone interested in learning more about New York State government could use as a learning tool.

Since I've been involved in our Citizenship Mentoring Group, both teaching citizenship classes and as a tutor, I've become much more aware of how little many US citizens actually know about civics. Part of the problem is that it's often not taught in the earlier grades, which would give students a good head start on learning some of the basic concepts in government. Civics education appears to begin only in high school when NYS Civics is taught to students about to graduate.

Immigrants applying for US citizenship are required to master 100 civics questions about the United States. The questions range from current leaders, parts of our government, duties of the president, important places, people and events. This is hard information for them to learn, often due to language issues, but they do seem to remember this information and pass at the rate of 91% according to government figures (2022). However, several studies also seem to be in agreement that only 4 in 10 Americans could pass the US citizenship civics exam today.

We've seen, especially in the last number of years, the problems that a lack of understanding of government can cause. Are Americans learning enough to judge issues critically, to vote in an informed way, and to participate in your democracy as engaged citizens? And more worrisome, do they care?

What Do You Know About Your Constitution?

Immigrants who want to become citizens must answer civics questions as part of the naturalization test. The civics test is an oral test and the USCIS Officer will ask the applicant up to 10 of the 100 civics questions. An applicant must answer 6 out of 10 questions correctly to pass the civics portion of the naturalization test. Below is a sample of the civics questions that relate to the Constitution.

- 1. The idea of self-government is in the first three words of the Constitution. What are these words?
- 2. What do we call the first ten amendments to the Constitution?
- 3. How many amendments does the Constitution have?
- 4. What are the two parts of the U.S. Congress?
- 5. How many U.S. Senators are there?
- 6. We elect a U.S. Senator for how many years?
- 7. The House of Representatives has how many voting members?
- 8. We elect a U.S. Representative for how many years?
- 9. Why do some states have more Representatives than other states?
- 10. What is the highest court in the United States?
- 11. Under our Constitution, some powers belong to the federal government. What is one power of the federal government?
- **12.** Under our Constitution, some powers belong to the states. What is one power of the states? (See the answers on page 6)

#### The New York Equal Rights Amendment

On Nov. 5, 2024, we will go to the polls to elect a president, congressional representatives and local officials. Also on the ballot will be a proposed amendment to the New York State Constitution, to ensure equal protection under the law for all New Yorkers.

New York Constitution has a limited equal protection clause – it applies only to those experiencing discrimination based on "race, color, creed or religion." The NY ERA would expand those protections to include, for example, sex, gender, age, disability, ethnicity – in other words, all New Yorkers.

The NYS League of Women Voters is working in partnership with the New Yorkers for Equal Rights Coalition to educate voters and to advocate for passage of the amendment. A simple explanation of the amendment's purpose and what it entails is in this flyer from the coalition:

"Right now, New York's State Constitution does not protect all New Yorkers – for example, pregnant New Yorkers, women, LGBTQIA+ people, those with disabilities, older adults, and people from different countries and cultures.

"We need a constitutional amendment so our rights and freedoms are protected – no matter who is in office.

#### "The NY ERA would:

- "Explicitly prohibit discrimination by the government based on a person's ethnicity, national origin, age, disability, and sex including their sexual orientation, gender identity, and gender expression in addition to pregnancy and pregnancy outcomes.
- "Add to existing protections based on race and religion.
- "Ensure New York's Constitution includes the strongest legal protections for all New Yorkers."

But, do we need an amendment? Don't New York's laws protect people's rights and freedoms? Yes. But, as we have learned in recent years, rights that we have relied on for decades can be diluted or even eliminated by a simple majority of a legislature or a court.

On the other hand, it is very difficult to amend New York's Constitution. It is not affected by political whims the way laws, acts or regulations might be. This amendment is as close as we will ever get to a guarantee that "our rights and freedoms are protected – no matter who is in office."
