Guide to Absentee Ballot Voting for Westchester County New York State Elections, June 23, 2020

Do you have concerns about going to the polls to vote because of COVID-19?? With a new Executive Order by Gov. Cuomo, all registered New York State voters **will automatically receive an absentee ballot application in the mail, with pre-paid return postage.** This is the application only - not the ballot itself! The temporary order applies only for the June 23 primary elections, which will include New York's federal, state, and local primary elections.

You may still **DOWNLOAD THE APPLICATION** and return via mail, fax, e-mail or in-person if you do not want to wait for the application form to be automatically mailed to you. If you cannot download and print a form, send a letter via mail, fax or e-mail with your request for the application, including the following information:

- 1) your name and date of birth
- 2) an address where the ballot is to be sent
- 3) the reason for the request
- 4) the address where you are registered

1. How to complete an absentee ballot application:

The NYS Election Law is modified to allow for electronic application, with no requirement for in-person signature or appearance to be able to access an absentee ballot.

A voter must check the box on the existing application for "temporary illness or physical disability." The request is for "Primary Election only".

2. Complete and return the signed application form to WCBOE:

Upon completion, the application or letter of application must be: emailed, faxed or mailed to WCBO (June 16th) or delivered in person no later than the day before the election (June 22nd)

Upon receipt of your application for an absentee ballot at WCBOE, delivery of absentee ballots to voters will be by mail or in-person, regardless of how the application was submitted.

3. Upon receipt of the ballot, complete and return your ballot to WCBOE by mail or in-person. No completed ballots will be accepted via email or fax.

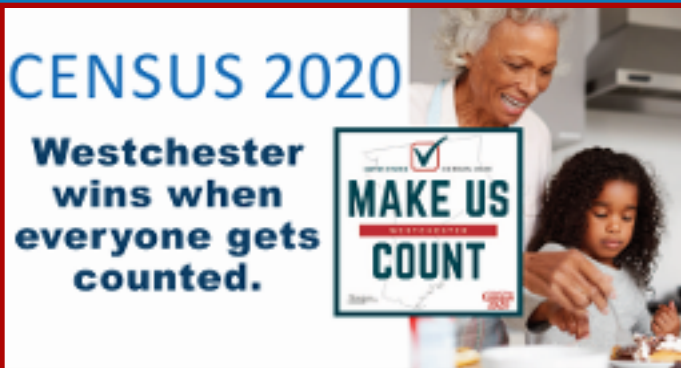

Westchester County Update

- Total County response is currently at 48% versus the final 2010 census response rate of 67.9%.
- North Castle and Scarsdale saw their percentages increase by .5%; while North Salem and Buchanan were on the low end with increases of only .1%.
- Two thirds of our municipalities now have response rates of 50% or higher with 22 in the 50s and 8 now in the 60s.
- On the lower end, only 3 municipalities are still in the 30s and 10 are in the 40s.
- On the high end, the Village of Croton is doing exceptionally well, and is only 6.4% away from their 2010 response rate, where every other municipality is at least 9% away.

2020 Census Operational Update

The U.S. 2020 Census is underway and more households across America are responding every day. Over 70 million households have responded to date, representing over 48% of all households in America.

In light of the COVID-19 outbreak, the U.S. Census Bureau is adjusting 2020 Census operations in order to:

- Protect the health and safety of the American public and Census Bureau employees.
- Implement guidance from federal, state and local authorities.
- Ensure a complete and accurate count of all communities.

The Census Bureau temporarily suspended 2020 Census field data collection activities in March. Steps are already being taken to reactivate field offices beginning June 1, 2020, in preparation for the resumption of field data collection operations as quickly as possible following June 1.

In order to ensure the completeness and accuracy of the 2020 Census, the Census Bureau is seeking statutory relief from Congress of 120 additional calendar days to deliver final apportionment counts.

Under this plan, the Census Bureau would extend the window for field data collection and self-response to October 31, 2020, which will allow for apportionment counts to be delivered to the President by April 30, 2021, and redistricting data to be delivered to the states no later than July 31, 2021.

The Forums will be recorded on Zoom to replay widely, and plans are to carry them live on local cable stations.

With many states still scheduled to hold primary and local elections between now and November, and with election changes announced almost every day, it's never been more important for voters to know when and how they can make their voices heard.

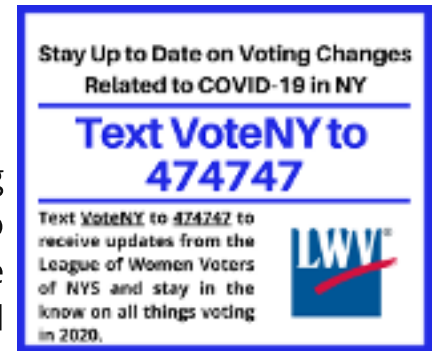

New Rochelle Elections Postponed

New Rochelle School Board and Library Trustees elections have been postponed until June 9 per Governor Cuomo's executive order, which reads, in part, "Voters shall vote in our local school and library elections only by absentee ballot, to be provided to all qualified voters by each school district." The LWVNR will try to hold a virtual candidates forum prior to those elections; candidate names and budgets TBA.

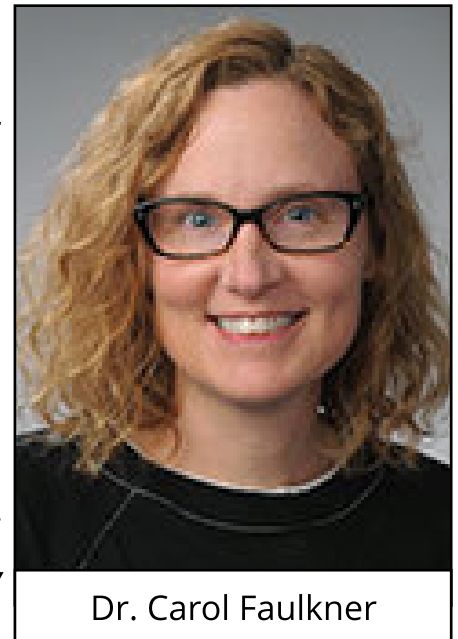


LWVNR Radio Show on WVOX Will Talk With Historian on the Role of African-American Women in the Suffrage Movement

The Ballot Box is the monthly WVOX 1460 AM radio show of the League of Women Voters of New Rochelle. Co-hosted by LWVNR members Tamar Tait and Nina Luban, the show features local, state, and national electoral issues and relevant civic matters. It airs live on the third Wednesday of the month from 9 am -10 am.

On April 22, 2020 The Ballot Box hosted Dr. Carol Faulkner, author, Syracuse University professor and 19th century American history specialist.

Dr. Faulkner's scholarship focuses on women, gender, sexuality, and social activism in 19th-century America. She provided listeners with historical background about the tensions between Caucasian and African-American suffragettes, discussed her 2011 book, *Lucretia Mott's Heresy: Abolition and Women's Rights in Nineteenth-Century America*, describing the connection between

Quakers and the suffrage and abolition movements, and explored some of the insights contained in her newest book, *Unfaithful: Love, Adultery, and Marriage in Nineteenth-Century America*, about marriage and other 19th-century reforms that occurred in the shadow of the suffrage and abolition movements.

Dr. Faulkner returns for a follow-up discussion on The Ballot Box on May 20th at 9:00 am to discuss the political status and history of 19th-century American women. How women exerted political power vis a vis the federal government without the vote - prior to the ratification of the 19th Amendment - is a chapter of our history that The Ballot Box aims to explore in greater depth. A deeper understanding of what "political power" means beyond the right to vote is especially important in an era currently witnessing assorted attacks on voter rights.

Update on Federal Elections Funding

On April 27 the State Board of Elections announced that the Governor would be amending the budget to allow for the spending of CARES Act stimulus funds for election operations in New York State

We are thrilled with this announcement and that our advocacy efforts have paid off!

Although this \$20 million in federal funds will have a positive impact on election operations in our state, the state is still required to commit a 20% match to receive the funds. The League continues to believe that this 20% match is too onerous for our state during this difficult financial time. We will continue to advocate that our Congressional members should remove this 20% match and increase the total amount of funding for states to use for election operations during the continuing COVID-19 outbreak.

How the Spanish Flu Almost Upended Women's Suffrage

"Everything conspires against women suffrage. Now it is the influenza."

— A suffragist quoted in the *New Orleans Times-Picayune* in 1918

One hundred years have passed since the 19th Amendment was ratified and added to the Constitution. The year 2020 was meant to be *one of celebration and commemoration*. Then the pandemic came. Centennial plans ground to a halt and events were scrapped as an extraordinary era of social distancing was ushered in.

Except, it had all happened before, during the Spanish flu, which arrived in 1918 and complicated plans for women's suffrage then, too. Suffragists found themselves making their case amid the panic of a pandemic. Illness was everywhere, gatherings were banned and canceled plans became the norm.

In October 1918, Carrie Chapman Catt, the president of one of America's national women's suffrage movements, lay sick in bed in New York.

"She was stricken with influenza," wrote Catt's friend and *biographer, Mary Gray Peck*, referring to the Spanish flu pandemic that was rapidly tearing across the country and, by some accounts, killed close to *200,000 people in October alone*.

"Chained to her bed like St. Lawrence to the gridiron. She looked and was extremely ill."

Catt was, however, concerned with issues beyond — but not unrelated to — the pains of the flu, according to Peck.

The invisible, unpredictable force of the pandemic risked derailing her carefully planned campaign to secure women's right to vote. The 19th Amendment was, at that moment, hanging by a thread in Congress. And the national suffrage movement, led in large part by two organizations — Catt's National American Woman Suffrage Association and the National Woman's Party — had managed to drum up immense momentum only to see it quickly dissipate as the country shut down public gatherings and ordered people to stay home. *NY Times, 4/28/2020*

Coronavirus: New Rochelle pairs struggling restaurants with residents in need

New Rochelle is pairing desperate restaurants with less fortunate residents as the COVID-19 crisis continues to cause economic despair.

The city is providing struggling residents with gift cards they can use at local restaurants, paid for largely by developers. A pilot program included six restaurants helping feed 300 residents. Now the effort is expanding to include more than 20 restaurants and more than 1,000 people.

The program is dubbed NourishALL — to sound like New Rochelle. The city is partnering with L + M Development Partners, RXR Realty and 10 community-based organizations to support restaurants that have faced a steep decline in business and residents who are feeling economic pressure, including food insecurity.

Mayor Noam Bramson called the program an innovative public-private partnership aimed at helping the city's most vulnerable residents. The program is also [accepting donations from the public](#).

RXR, New Rochelle's master developer, [is supporting the endeavor through its \\$1 million COVID-19 Relief Fund](#). It is also helping small businesses and nonprofits connect with volunteers to help access various federal relief funds. Other developers have pitched in as well.



Financial Relief for Artists

ArtsWestchester has announced a new **Artist Relief Fund** that will award grants of \$500 to individual Westchester artists who have suffered a loss of work due to Coronavirus 2019 (COVID-19). These funds are available for individual professional artists who live or maintain a studio in Westchester County. Artists must be at least 18 years old and be able to demonstrate a realized loss of income due to COVID-19. Artists will be required to supply proof of residence, or proof of studio space in Westchester, along with a W9. All artists can apply, regardless of immigration status, but must meet all other eligibility requirements and be able to supply required documents.

ArtsWestchester teaching artists, past grantees, and artists who have received public art commissions through ArtsWestchester are all eligible to apply. Artist Relief Fund awards are a one-time grant. Artists who receive a grant through this program may not apply for additional funding. If more funds are made available, ArtsWestchester may reopen the application to past awardees. Applications will be accepted beginning May 1st: To find out how to apply for a grant ArtsWestchester is funding the Arts Relief Fund through a GoFundMe campaign; they will continue collecting donations indefinitely and distributing grants to artists as contributions come in.
