Dear Members of the Concord Select Board, Town Manager, and Moderator:

The League of Women Voters of Concord-Carlisle Board (LWVCC) appreciates the work of the Select Board and Town Manager Stephen Crane in keeping Concord citizens safe during these extraordinary times in the midst of the COVID-19 pandemic.

Democratic government depends upon informed and active participation of its citizens, even in the midst of a pandemic. With that thought, I write to share concerns about three issues involving Concord's Town Government response to the pandemic that have come to our attention. Now that this new public meeting mode has been in place for over a month, we respectfully request that it is time to review the Temporary Policy in light of experience and lessons learned. We write to you in a cooperative spirit and with the important goal of continuing the strong involvement of Concord citizens in the welfare and goals of our Town.

First, Governor Charlie Baker's March 12, 2020 "Executive Order Suspending Certain Provisions of the Open Meeting Law" enabled Massachusetts cities and towns to temporarily suspend some provisions of the Open Meeting Law and establish guidelines for public meetings and public hearings. Concord's guidelines -- "Temporary Policy Directive and Guidelines for Public Meetings and Public Hearings Conducted via Remote Participation Due to Covid-19 State of Emergency" -- were issued on April 1st without public notice, public input, or a formal public vote of the Select Board. The unsigned policy was announced on April 2nd by Town Manager Stephen Crane at the end of the Select Board meeting. It was posted on the Town's website and then sent to Town boards and committees on April 3rd. While this policy was enabled by the Governor's emergency declaration and as an extension of the Select Board's March 19th Declaration of Emergency, we are concerned about the policy's effect on the work and roles of Town Boards and Committees, and the critical role of Concord citizens in the governance process.

Second, the LWVCC is concerned with Concord's narrow application of the Governor's Executive Order, choosing to limit public meetings during the pandemic to only those deemed "...to meet a statutory deadline or for emergency purposes." As an example, the Finance Committee's last public meeting was March 9th, and another meeting was not held until May 4. As a result of not having met for almost two months, the Finance Committee has fallen behind in its work to prepare for both the hearings and the June 22nd Annual Town Meeting. The Finance

Committee also hasn't been given the opportunity to review proposed budgets and other financial articles in light of the anticipated change in the Town's financial picture caused by the pandemic. Town Moderator Carmin Reiss said at the April 23rd Select Board Meeting that the Finance Committee was "eager to get going," but was only recently allowed to do so.

Third, the Select Board's posted agendas do not list an opportunity for public comment. The current format for Select Board virtual meetings, broadcast over Minuteman Media Network only, precludes real-time public comment at the end of the meetings. The Town has attempted a substitute for real-time public input—requesting the public submit comments before the meeting that will be included in the minutes. We believe that is insufficient and in addition is not verifiable. It is also a significant change from normal Select Board meeting procedures. We note that there are no published minutes of Select Board meetings since February 27th, which further exacerbates the inability of the public to be informed of the proceedings. We believe the conduct of meetings should be revised to allow Concord citizens to log in online and be heard as part of the meeting. The change in focus for the Select Board—from conducting regular business, including pre-town meeting discussions—to issuing emergency declarations and changing statutory deadlines is also troubling.

For reference and for comparison purposes, we attach recent agendas for the Select Boards in Westford and Acton, both of which have been robust and include information for remote access by the public.

The League of Women Voters of Concord-Carlisle appreciates your responsibility and goal of keeping Concord citizens safe during the COVID-19 pandemic. We realize that these actions were taken with appropriate reasons and rationale. We respectfully request that you take the opportunity to reassess some of the ramifications of the Temporary Policy.
