### From the President

LWV Positions on Gun Safety

The LWV of the United States' position is to protect the health and safety of citizens through limiting the accessibility and regulating the ownership of handguns and semi-automatic weapons. The LWVUS supports regulation of firearms for consumer safety.

Do you remember when we had to get under our desks in case of an atom bomb attack? Well, I do. It is nothing compared to what our children, and perhaps grandchildren, are experiencing now. We have many things to discuss and learn about as a group, but this issue stands front and center for me right now. Is this the new norm? I agree with the Martin Luther King, Jr. statement about being "creatively maladjusted", refusing to accept school shootings as the norm. I am devasted, grieving, and trying to process the loss of children to gun violence in our schools and on our streets. Why are we choosing guns over children and why is there inactivity on Capitol Hill? We owe these slain children something.

- Ban assault weapons
- Require universal background checks for the purchase of guns
- Fund peace and violence prevention programs in local communities
- Have rigorous investigation of "Swatting." This is calling in threats of school shootings.

I have been a member of the Children's Defense Fund for decades. They report that firearms are the leading cause of death for children in our country. Just try and process that. There have been more mass shootings than days in the year in 2023 (CDF, March 31, 2023). The Children's Defense Fund calls to #Protect Children Not Guns. We too can call or write our state legislators and congressman to work for the four advancements in gun legislation.

Lisa Marshall, Director of Advocacy and Organizing, New Yorkers for Clean Power

Lisa joined the NYCP team after serving as Program Director of HeatSmart Tompkins, New York's first and most successful Clean Heating and Cooling community program. As HeatSmart Director, Lisa implemented education and outreach about heat pumps and other building energy efficiency measures as well as providing direct support to households, businesses, and municipalities implementing building decarbonization. Under her leadership, HeatSmart Tompkins doubled previous program participation and dramatically increased the proportion of low-to-moderate homes getting heat pumps installed.

Prior to HeatSmart Tompkins, Lisa worked as a community organizer with the climate organization Mothers Out Front where she built and supported multiple local organizing teams around

New York State. As a community organizer, she recruited and trained volunteers and helped them to shape, execute, and win local climate campaigns. She also collaborated with allies on multiple statewide campaigns and mobilizations. Within Mothers Out Front, she helped to architect and launch a multi-state "Beyond Gas" campaign.

A long-time member of the Renewable Heat Now campaign team, Lisa has been at the forefront of advocacy for building energy efficiency and heat pump adoption policy at the state level where she advocated effectively for bringing affordable, equitable building electrification to scale through education and outreach, messaging, lobbying and building grassroots pressure on elected officials and state agencies.

Lisa's long-standing interest in climate change began decades ago when she wrote her first high school research paper on global warming. In graduate school, her research focused on changes in soil biogeochemistry due to climate and desertification. It wasn't until moving to NY's Southern Tier and buying a home that was leased to a gas company, that she became directly involved in climate and energy advocacy. Lisa holds an M.S. in Earth Science from Dartmouth College and a B.A. in Geology from Claremont McKenna College (via Pomona College).



### **Climate Legislation Under Attack**

This week, Senator Parker and Assemblymember Barrett, introduced <u>S6030</u> which would have a disastrous impact on NY State's Climate Leadership and Community Protection Act (CLCPA). The

Volume 27, Issue 4 CLCPA measures greenhouse gas (GHG) emissions using a 20-year time frame. Heat trapping methane emissions, which account for approximately one-quarter of global warming effects today, present the greatest planetary harm in the first 20 years after release.



This measurement standard is a critical feature of the law. To the left is a map of methane emissions by county in NYS in 2018, 2019, and 2020.

Senate Bill 6030 would adjust New York's greenhouse gas emissions accounting system. If enacted it would measure emissions using a 100-year calculation, which would mask the actual damage to our climate.

This change would delay harmful emissions reductions and prolong unacceptable conditions that pollute, provoke extreme weather and could potentially trigger irreversible climate effects. The role of human generated GHG must be addressed aggressively and cannot be delayed. The NYS League strongly opposes the recently proposed bill and wrote a memo of opposition which you can read <a href="here">here</a>. Read more about the issue <a href="here">here</a>.

Later this week, the Governor announced that S6030 would be taken out of budget negotiations, but that does not mean that the bill can't move once the budget has passed. We will continue to monitor this issue.
