## **LWVDE Acting on Public Policy Issues**

# LWVUS Launches People Powered Fair Maps<sup>TM</sup> (PPFM) Project Nationwide.



"We conclude that partisan gerrymandering claims present political questions beyond the reach of the federal courts," the chief justice wrote in the 5-4 majority decision the *Rucho* case. The case addressed challenges to partisan gerrymandering in Maryland and North Carolina.

When LWVUS leadership heard the Supreme Court decision, they agreed on the need for LEAGUE ACTION. Their concern led to a commitment of \$500,000 for the first year of a 50-state plus DC project dubbed "People Powered Fair Maps<sup>TM</sup>" (PPFM). Our national staff is seeking grants and donations to support a multi-million-dollar,

multi-year project. The goal is to set the stage for a sweeping state-by-state redistricting effort that will begin in 2021 following conclusion of the 2020 Census.

The project was kicked off with a "convening" of representatives from state Leagues near Dulles Airport in October. Advocacy Chair Sandy Spence (*pictured at left*) was appointed to attend for LWVDE. She became so enthused about the project that she convinced Linda Barnett to take on her role as Advocacy Chair. Sandy will chair a new portfolio of the Advocacy Corps to address LWVDE's role in the Census and Redistricting.

She has already announced the program at the Sussex semi-annual meeting and will meet in Kent and New Castle soon to recruit a statewide committee. An initial group will work with her on a plan for LWVDE's work in helping ensure a complete count in Delaware's Census in 2020. (See separate article on the Census.)

That work will set the base for intensive work on planning and implementation of redistricting our state legislature. Developing maps for revised districts based on the new Census data will start after the Census Bureau releases data to the state on March 31, 2021.

"This is an exciting opportunity for League members to learn and act to help ensure a complete Census count and to develop "people powered fair maps" for Senate and Representative Districts in Delaware," Spence says with great enthusiasm. "We need all kinds of skills from statistical analysts, survey developers, public speakers, and Excel record keepers, traditional and social media whizzes, trainers, and those who enjoy writing letters to the editors, testimony, or any other interests you can bring to our work."

## The Countdown to the 2020 Census has begun!



Leading up to, on, and after Census Day (April 1, 2020), LWVDE plans to work in coalition with multiple partners to help get everyone counted. We'll do this as part of our work on the LWVUS People Powered Fair Maps<sup>TM</sup> (PPFM) project. Interested? Contact <a href="mailto:sandyspence325@gmail.com">sandyspence325@gmail.com</a>. Each of us is an important source of information about the 2020 Census. It is up to us to ensure that our friends and family know the facts and are not deterred from participating in the 2020 Census. Here are some facts:

• The Constitution requires counting all *persons* – not just all *citizens*. The citizenship question will *not* be on the 2020 Census form and individual data won't be linked to any of these records.

In fact, the Census Bureau is not allowed to release individual data or personal responses to anyone, for any purpose—including to other government agencies or law enforcement. This means filling out your census form

is still safe and secure. The Brennan Center for Justice has an excellent report on confidentiality at <a href="https://www.brennancenter.org/our-work/research-reports/federal-laws-protect-census-confidentiality">https://www.brennancenter.org/our-work/research-reports/federal-laws-protect-census-confidentiality</a>.

- Among its many purposes, the Census is used in redistricting Congressional, state and local legislative bodies, including school boards.
- According to Sen. Tom Carper at a recent news conference, "Delaware is closing in on a million people. And we are

very close to a magic number that would enable us to have not just one U.S. representative, but two."

- A correct census could not only allow for more representation in Congress, but also bring more funding into the state.
- Census data is used in distributing more than \$675 billion in federal funds annually.
   Delaware gets approximately \$2,000 per citizen. In 2010, approximately 5,000
   Delawareans did not fill out the census form -roughly \$10 million of federal funding that did not come into the state.
- Responding to the Census will help ensure that our state and local governments get our

fair share of federal funds for programs like Medicaid, SNAP, Head Start, unemployment benefits, Section 8 housing vouchers, programs for seniors and veterans with disabilities, and school lunch programs.

• It also helps ensure that our communities have enough money to build roads, hospitals, and schools.

Accurate, comprehensive data is also used by private industry for such purposes as helping determine where companies bring new jobs.

The U.S. Census Bureau is recruiting thousands of people across the country to assist with the 2020 Census count. Interested? Go to https://2020census.gov/en/jobs.html.

## **Identifying the Concerns of Delaware Women**

A project is just getting underway called Delaware Women's Voices. Its goal is to identify important issues that impact women's lives and to pinpoint areas of need.

This is a nationwide project, under the auspices of the National Association of Commissions for Women (NACW), whose mission is to sustain, strengthen and advocate for women's commissions in their work to promote equality and justice for all women and girls and ensure they are represented and empowered in their communities.

In Delaware, the project is sponsored by the Office for Women's Advancement and Advocacy, a state agency within which the Delaware Commission for Women is housed. The goal is to have all Delaware women 18 years of age and



older take a survey where their views can be recorded. Here is the link for you to use to take the survey: <a href="https://bit.ly/owaasurvey">https://bit.ly/owaasurvey</a>. The findings from the project will be compiled and shared with the public and with Delaware's elected officials. In addition, Delaware's findings will be pooled with the findings from other states around the country; the outcome will be a report prepared by NACW and delivered to the President, Congress and the nation outlining what the women of the United States have identified as their concerns. The national report is expected to be published in July 2020 in time for the 100th Anniversary of the adoption of the Nineteenth Amendment.
