

League of Women Voters of Falmouth ANNUAL MEETING MINUTES 2023

May 20, 2023, Coonamessett Inn, Gifford Street, Falmouth

The meeting began with a breakfast buffet attended by 40 members and guests. Annual Meeting Chair Maro Titus then introduced the Program Speakers Kim Fish (Falmouth Housing Coordinator) and Victoria Bowen to speak about Affordable/Attainable Housing in Falmouth.

Kim recapped the Affordable Housing definition established by HUD which is based on the area median income for Barnstable County of \$115,600 for FY2022. If affordable housing in a town is less than 10%, developers may propose 40B projects that are exempted from the local zoning code provisions (density, setbacks, building heights etc.) provided that 25% of the units built will be set aside for sale or rent at affordable rates in perpetuity. 40B developments tend to favor ownership over rental, and 2-3 bedroom units over smaller units, exacerbating the shortage of smaller rental units in town. There are subsidized loans/rents for those meeting the criteria, but currently 48% of those employed on Cape Cod commute from off-cape because of the shortage of housing on-cape. Recent changes in the Falmouth Zoning Code (accessory dwelling unit, mixed retail/commercial overlay district) are intended to stimulate affordable housing development.

Victoria spoke about her search for rental housing. She is a Falmouth native, a manager at Falmouth Hospital and volunteers at the Falmouth Service Center and with Falmouth Hospice. She is single and searched for rental housing for over 6 months before finding housing in Bourne. She was not eligible for the affordable housing lottery as a single person (the lottery aims to fill bedrooms in each unit and there are few/no one-bedroom units). She notes that her discretionary spending and volunteer service will migrate closer to her new residence, and that even well-paid people struggle to find housing in Falmouth.

There were a number of questions from the floor, and Select Board member Doug Brown added significantly to the conversation. Kim will develop a Housing Page for the Town Website which will gather information into an easily accessible site. She suggested that people interested in this topic volunteer for the Town Committees that address it: Planning, Affordable Housing, ZBA, Community Preservation and others. Judy Ziss spoke about the recent LWVF program on Housing and Senator Moran's proposed legislation that addresses this topic. Kim is in the process of reviewing all Town-owned properties for their suitability for housing developments.

Maro Titus opened the business meeting and introduced Judy Fenwick as Parliamentarian.

The minutes of the 2022 Annual Meeting as printed in the program were approved.

The Treasurer's Report was tabled and will be reviewed/approved by the Board of Directors within 60 days.

Maro Titus and Tracey Chapman presented a gift to Denise Morreale in appreciation for her 10 years of service as Observer Corps Chair. Many of the Observers had sent in anecdotes about Denise's role as chair and mentor. Denise spoke about her nearly 30 years of history with the League on many committees and with the Observer Corps.

Janet Lauer, First Vice President continued with comments on the past year of activities, including the formation of the DEIB and Communications Committees, two candidate nights and many public programs (which are listed in the program). She noted that this is LWVF's seventieth year.



Janet read the proposed new Transportation Position into the record (page 3 of the program) and Maro Titus gave some background on how this was developed through the 2022-23 Local Study. Kathy Mortenson moved that the new position be adopted, which was seconded by Richard Johnson and the meeting approved the new position.

Janet read into the record the proposed increase in membership individual dues from \$50 to \$55, noting that all of those funds are paid to the state and national Leagues. Misty Neimeyer expanded upon the proposal, noting that student, additional household member and accessible membership rates would not change. A question from the floor asked why it was not raised more to provide funds for our own use; Misty explained that many members give above the membership level and we would continue to depend upon that for our own operating expenses. Maggie Sweasy moved that the \$55 rate be approved, Kathy Mortenson seconded the motion, and the meeting approved the change.

Janet read the Nominating Committee report, noting a number of changes made after the Program was printed. These changes are reflected on page 3 of this report -- "Board of Directors 2023-2024".

Judy Fenwick moved that the nominations be approved, Maggie Sweasy seconded and the meeting approved the new slate of officers and board members.

Meghan Hanawalt thanked outgoing secretary Karen Dacey for her service as well as others leaving the Board, and thanked Maro Titus for planning and organizing the Annual Meeting.

Directions to the Board: Judy Fenwick lamented the fact that "Falmouth in Focus" had not recently been updated. She noted that other groups in town had relied upon it. She asked that the Board work to re-publish it and volunteered with Joan Boyer to work on that effort. Joan suggested that be the Local Study for 2023-24. Kathy Mortenson moved that updating and publishing Falmouth in Focus be the 2023-24 Local Study with Judy Fenwick as Chair. It was seconded and approved by the meeting.

Kathy noted that she and Jackie Webster had recently gathered bulletins, annual reports and old versions of Falmouth in Focus to donate to the Falmouth Historical Society archives.

Raffle tickets were drawn and prizes were given to Judy Fenwick, Ed Dewitt, Doug Jones and Harvey Fishman.

Readers for these minutes were selected as Maro Titus, Sylvia Szulkin and Mary Fran Buckley.

Larry Moore reported on a fundraiser he had held to benefit LWVF, with Jane Scarborough leading a discussion on Democracy. The amount raised will be in the Treasurer's Report.

The passing of long term members Alice Carey, Meghan Jones and Barbara Woll Jones was noted.

Karen Epstein made a motion to adjourn, seconded by Sylvia Szulkin and Maggie Sweasy, which the meeting approved.

LWVF LOCAL STUDY REPORT 2024

LWVF Local Study 2023-2024- FALMOUTH IN FOCUS UPDATE

At the May 2023 LWVF Annual Meeting Judy Fenwick suggested that the iconic LWVF publication, *Falmouth in Focus*, should be updated. This has become the 2023-2024 LWVF Local Study, "Falmouth in Focus - Update." The last edition of *Falmouth in Focus* (fifth edition) dates back to 2010. An electronic version, titled *Know Your Town*, and listed as the 2019 sixth edition, can be found tucked away in the recesses of the LWVF website.

The Study group began its weekly meetings in late January 2024 with section reorganization, research, and content updates, which will conclude in mid-May.

We are requesting a second year for the Study with the following goals: a first draft to be ready in mid-June; weekly editorial meetings to start in July; and several drafts to yield a final publication-ready document by September

We will concurrently be having discussions on: 1) publication strategies: print and/or electronic; 2) target audiences; 3) distribution methods; and 4) funding sources for publication/distribution.

COMMITTEE REPORTS 2024

LEGISLATIVE

Legislative Committee members review the list of bills the Massachusetts League has decided to support and, as a group, select their own priorities from among them. Advocacy generally consists of contact with our own legislators or with members of legislative Committees considering legislation on which we have taken a position. The Committee Chair and sometimes other members send emails or make phone calls to voice our support for a bill.

This year we have emphasized bills relating to affordable housing, gun control, facial recognition technology, and death with dignity. We also took positions on bills regarding rural transportation, hybrid public meetings, and use of campaign contributions for a candidate's childcare expenses. In addition, we have occasionally continued support of



priorities from previous years such as Common Start and immigration. While the Massachusetts legislature meets over a period of two years, much of the activity gets pushed close to the end of the second year of each term.

The Massachusetts League has a team of volunteer Legislative specialists, each of whom focuses on a subject. Local League members who are concentrating on bills in a focus area receive information from these specialists and can seek assistance from them. The specialists also provide alerts regarding pending legislation, and we respond as appropriate.

In addition, each year the Legislative Committee presents a program for the public, usually in March, and we invite our three legislators to attend. This year's program was on March 21. As it turned out, the Massachusetts Senate was in session the evening of our program so Senator Susan Moran was unable to join us. Nonetheless, we did have a lively public program with both Representative David Vieira and Representative Dylan Fernandes on board. As in the past, the program, which included a Q and A session, was broadcast live by FCTV.

We were delighted this year to find that our Legislative Committee, which previously had only four members, has doubled in size. While everyone is not active, we welcomed a new group of capable and enthusiastic members who are providing important contributions. Stay tuned – or come join us. Advocacy is rewarding and is also fun.

CIVICS

The Civics Committee was founded several years ago to serve as a resource for the Falmouth Schools as they implement a civics law enacted in late 2018. That law, entitled "An Act to Promote and Enhance Civics Engagement," requires that students participate in one student-led, non-partisan civics project in eighth grade and also in high school. Among other things, the law is intended to help students learn "to analyze complex issues" and to "reason, make logical arguments and support claims using valid evidence." It also aims to help them "engage in civil discourse" and "consider differing points of view." These are all skills future voters need if they are to understand issues and know how to evaluate sources of information so that they can distinguish between fact and fantasy.

In Falmouth High School, students do their civics project in the spring of sophomore year as part of their U.S. History curriculum. Social Studies Chair Michael Feeney has purposely set the timing to coincide with Town Meeting in case students want to advocate for or against a proposition on the Town Meeting warrant. Students work in small groups or individually and, at the end of their projects, they make classroom presentations. One or two League members often visit a classroom to serve as an audience for these presentations. You don't have to be a member of the Civics Committee to participate in this way. We have been told that the students appreciate our presence. We have not yet directly supported the eighth grade projects but we expect to extend our scope for the 2024-25 school year.

We have engaged in other support activities as well. We adapted a guidebook prepared by the Needham League to fit Falmouth and Barnstable County. We then made the guidebook available to Mr. Feeney, and we are told it is considered a valuable resource. We also try to make the public aware of the student projects so that town officials and citizen volunteers respond to students when they are contacted. (Contacts are complicated by the school rule that students may not make emailed requests themselves. Instead, their teachers must make these requests for them.) One year we provided material for an <u>Enterprise</u> article, and this past year we provided information to the Chair of the Select Board so that she could help publicize the need for community input when students seek it.



We have been extraordinarily lucky that Mr. Feeney is the Department Chair. He has been welcoming to us and guided us in our efforts. And so we were very pleased when we learned that he recently received the Charles Mitsakos Award for Outstanding Supervisor given by the Massachusetts Council for the Social Studies. In his relationship with our committee, he has continually demonstrated the strong attributes for which he was honored by his colleagues in selecting him for this award.

In the League, an interest in civics goes with the territory. If you want to get involved at the school level and sit in on a classroom presentation, please let us know. And if you want to join our committee, we would love to welcome you.

MEMBERSHIP

We are starting a new Membership Year with 154 members. This includes 130 primary members, 4 of which are student members, and 24 additional household members. In this past 2023-2024 membership year, we have 14 new members join our league! Many new members joined due to member meetings and events and our amazing league programming.

At the 2023 Annual Meeting, the membership voted to increase dues to \$55 for individual memberships; additional household members remained the same at \$25; this was to bring dues up to the same level due to State and National for each member. The \$25 membership rate is still available, and student memberships are still free for full or part-time enrolled students. It was also suggested at the meeting during a discussion about increasing the dues to above what is owed for State and National dues. At this meeting, it is proposed to raise the dues to \$65.

Upcoming future changes at the National Level to Membership - The National League has been working on a major project to change the membership system, incorporate all of the local leagues, decrease the administrative burden on local league volunteers, and give members more of a range of options in due costs, with the hope of increasing membership and increasing diversity, in the form of pay what you can options, and increasing the percentage annual dues that goes to the local leagues to go towards local programming and local work. While there will be significant changes and a new interface, these look like new positive changes that will assist our Membership Committee, give more options for dues, and give a higher % of dues to our local league, which will help raise funds for our programming. Suggested dues will increase to \$75 per individual member and \$112.50 for a household membership; however, there will be a pay-as-you-go option to as low as \$20, and individual leagues can choose to set that lower and cover the cost. Our local league would receive 20% of all membership dues paid. These changes will likely not take effect till around February 2025 for new members and will not impact most league members until dues renewals the following year in May 2025. Information will be shared as the National League is rolling out the new websites and plans.

This summer, for the first time, along with the LWV MA, we are hosting a Falmouth Road Race team, with 5 runners working to fundraise to support our two leagues! This is an amazing opportunity to fundraise for our local league, raise awareness about the LWV, and potentially recruit members! Look for opportunities to help fundraise for our team, support our runners, and cheer them on in August!





LWVF COMMITTEE REPORTS (CONTINUED)

NATURAL RESOURCES

The Natural Resources Committee is led by a Steering Committee of Denise Morreale, Kathy Mortenson, John Carroll, Sally Palmer and Richard Johnson. Pam Polloni, Rosemary Carey, Bruce Woodin, Deb Warner and Sam Patterson are also members of the committee.

In 2023 the Massachusetts Department of Environmental Protection revised the Title 5 septic law to be more strict on Cape Cod, expanding the mandate for Innovative/Alternative (I/A) Septic Systems. The Natural Resource Committee decided that I/A systems needed to be more broadly understood, and we began by scheduling a site tour of the Massachusetts Alternative Septic System Test Center (MASSTC) in Sandwich to learn about their work. We went in June and were guite intrigued: we went hoping that such a tour would be appropriate for our fall program and a larger attendance, but decided to might be physically challenging for many. Instead, we invited Brian Baumgaertel (the director) and Brian Horsley (specialist) to present their work at a public meeting in the fall. A Urine Diversion Pilot program was on the warrant for November Town Meeting and it seemed important to educate a broader audience about this and other I/A systems. The presentation was held in October and was well received and well attended. The Green Center in Falmouth (Earl Barnhardt and Hilda Maingay) had been advocating for years for urine diversion, and was working with MASSTC to develop the pilot program: several members of the committee signed up for a tour of the Green Center later in October, and have become advocates for urine diversion. The Falmouth Water Quality Committee was also involved in vetting the pilot program and we attended several hearings on those discussions. Funding for the Pilot Program is on the Spring 2024 Town Meeting Warrant. Two sticking points are: what urine diverting toilet brand/model could be approved by the State Plumbing Board, and what would happen to the collected urine, which is too strong to be disposed of at the town's wastewater treatment plant. It seems likely that those issues may be resolved before April Town Meeting

OBSERVER CORPS

An Observer for the League of Women Voters of Falmouth is a League Member who attends a public Town Government meeting, makes notes on what happens at the meeting and reports back to the League. Considered the eyes and ears of the League, the Observer Corps are dedicated to ensuring compliance with the Open Meeting Law. The Observer is there only to Observe, not to speak to issues or answer.

On February 27, 2024, two reports were presented; Carol Rador on the Planning Board and Carol Chittendon on EDIC. The remaining reports will be read in June 2024.

The report readings always generate excellent discussions and are a great way to get a good understanding of what the observed committees have been addressing throughout the year.

We have designed flyers when they are requested. However, physical flyers on local bulletin boards are probably the least likely way of attracting notice for our events, because the boards are overwhelmingly crowded. We ask the sponsoring committees to take over the task of posting flyers; we will continue to design flyers, when requested.

In addition to these publicity outreach efforts, we have continued publication of the monthly *Bulletin*, with eleven issues each year. Members of the Board and leaders of the committees have been very helpful in providing content for the Bulletin. The Bulletin is distributed by e-blast, posted on the website, and maintained there in an archive. Eight copies are also printed and mailed out each month to members, by special request.





VOTER SERVICE

In September 2023, The Voter Service Committee held its first meeting to establish an agenda for 2023/2024. The Committee's discussion included an original proposal to celebrate voting rights as related to the US Constitution through community participation at a public event entitled **We The People**. This eventually developed more specifically to be funded by a \$400 **Scharfman Grant**, hosted at a booth at Arts Alive Weekend on the Library green the weekend of June 14,15,16, 2024 and the inclusion of original pieces of art created by Falmouth High School students under the guidance of High School art teacher, Jane Baker. The discussion of appropriate readings and song selections continues at the time of this report. It was decided that there would be three monetary awards of \$200, \$100, and \$50 honoring three student submissions. All artwork, due to space limitations, will be displayed as photographs. In addition, at the conclusion of the event, the photographs of the artwork would continue to be displayed in the Falmouth Library for two more weeks. Local citizens attending the event will be able to try their knowledge at the test given to new citizens, receive a free copy of the Constitution, write postcards to friends and family with a reminder to get out and vote, take home cards with the vote 411.org QR code, and enjoy a presentation of the Preamble.

On November 14, 2023, the Committee hosted a special informational meeting **all about voting machines** with focus on the assessment of current concerns questioning the outcome of elections and its impact on our Democracy. **Larry Moore, founder of Clear Ballots**, presented the factual data on how voting machines work, how security is enforced to protect our ballots, and how voters are invited to witness the inspection of voting machines at their polling place days before the election. In addition, Mr. Moore presented more abstract concepts of innovations yet to come, and the impact and power of positive messaging.

The Voter Service Committee was represented at the **International Women's Day Breakfast** in Hyannis in March 8, 2024, with an informational table offering assistance on voter registration and other pertinent information related to voting.

Candidates Night was held in the Hermann Room of the library on Wednesday evening, April 24. Although initially eleven candidates were invited to participate, by the time of the event, seven candidates remained, four vying for three seats on the School committee and three competing for one seat on the Select Board. In addition, a few uncontested candidates were present and were invited to introduce themselves and speak briefly. Mindy Todd moderated the panel discussion of contested candidates using the league's prepared questions as well as a select few from the audience. In the future I would recommend soliciting questions from the community ahead of time and using them as the source of all questions. The more residents have input, the more they are motivated to participate. In preparation for the event, on April 5th, invitation letters with the empty chair policy attached and a request to respond by April 12th, were emailed to all candidates. On April 12th, confirmation letters with Candidates Night Guidelines were emailed to the candidates. A program was crafted to include a tear off for writing questions, an ad was placed in the



Enterprise, a short and long version of a press release were completed. A flyer advertising Candidates Night was posted in various spots around town. All publicity was previewed by Bob and Tony of FCTV before publication. An email blast resulted in new volunteers who assisted with the reception table and serving as time keepers. The reception table offered guests information on when, where, and how to vote, a card with a QR code for vote 411, specifics on early voting, and a program with space for writing a question. A separate display offered a preview of an upcoming event, We The People, about our US Constitution and voting, copies of the test given to new citizens, and copies of the Constitution. The Bay Room of the library offered overflow space for viewing Candidates Night on a large screen TV. The event was televised live on FCTV's channel 6, as well as FCTV's Roku and Apple stations. There were some technical difficulties but the follow up by FCTV after the event ensured that the community has multiple opportunities to view Candidates Night on TV before the upcoming election on May21, 2024.

The committee started the year with a Meet and Greet program held at WHOI's new building Thursday, September 21 from 6pm-8pm. Committee member Meghan Hanawalt secured facility and organized the presentation, set up and delivery of the program. The turnout was great, and attendees were able to sign up for membership, ask questions about committees and enjoy light refreshments and snacks. Many League members attended, participated, and contributed slides and explained the work of their committees.

In November, the committee organized and delivered a film screening program during the month of November. Committee member Travis Mapp provided the welcome, vision, mission and goals, Eileen Mattingly served as the program lead and Meghan Hanawalt provided the closing. Misty Niemeyer provided popcorn and snacks for the event and Mary Fran Buckley assisted with securing the library for the event. Members Sandy Faiman Silva and Donald Gibbons led organization of the committee discussion and finalization of questions for submission to the Voter Services Committee Chair Felicia Broderick. The committee raised the idea of partnering with the Federal Reserve Bank on a research initiative to learn more about exploring wealth disparities across Massachusetts. The committee is poised to explore the following things during the 2024-2025 programmatic year: educating black and indigenous people of color about civic duties, promoting the League's Vote 411 feature, celebrating Women's History Month and Economic Inclusion in the library during the 2024-2025 program year.
