Steering Committee Report

Since 2017, the League of Women Voters has been supporting and lobbying to get an urgent immigrants’ right legislation passed. Early this month it happened, as the Massachusetts House passed An Act Promoting Rule of Law, Oversight, Trust and Constitutional Treatment (PROTECT). Now, we have to work on the state Senate.

Our Falmouth Legislative chair, Judith Ziss, could tell you many stories of how long one has to fight to get things through the state legislature. One of my jobs was lobbying Beacon Hill and Capitol Hill about the need for research funding for the university where I worked; it could be surprising how often you needed to reinvigorate that idea. I can’t imagine promoting research in the current atmosphere.

I read about the PROTECT passage in an email from Jennifer Muroff, of the LWVMA, congratulating members of the Legislative Action Committee for the work they had done meeting with, calling, emailing, and texting their representatives to promote this law. Its eventual passage will do several things to make the legal environment safer for undocumented people in our community. Some provisions need to be spelled out.

The law bans new and renewal of 287(g) agreements. Those actions gave custom and immigration enforcement to local law enforcement officials—something they don’t usually have. These agreements can be narrow, just for enforcement officials in jails, more broadly to include warrants, and very broadly to include all law enforcement. This could mean a longtime worker who is supporting his family and paying taxes could be stopped by anyone and end up in immigration custody. That will be less likely in our state, if this passes the Senate.

Once an individual is in custody, every agency must have multilingual resources that explain individual civil rights and how people

can contact legal service. The agencies must have competent interpreter services.

If the Senate approves this law, immigrants in our state should have a much firmer footing in our legal system.

Editor’s Note: The following are major provisions of the PROTECT Act (An Act promoting the rule of law, oversight, trust, and equal constitutional treatment):

It prohibits law enforcement inquiries into an individual’s immigration status unless it is directly related to a criminal investigation.

It bars the use of state and local resources, funds, or personnel for civil immigration enforcement.

It limits the sharing of data with federal immigration authorities.

It creates protection against the warrantless arrest of immigrants in courthouses.

It requires the Governor and Attorney General to publish multilingual guidelines on how manage interactions with ICE.

It provides improved access to legal counsel and interpretation services for detained individuals.

Candidates for town-wide offices are required to collect 50 signatures from Falmouth registered voters.

Candidates for Town meeting member are required to collect 10 signatures from Falmouth registered voters.

LWV Lawsuit to Protect the Vote

The following public statement was released on April 2 by the League of Women Voters of Massachusetts:

BOSTON, MA – A coalition of voting rights organizations filed a [lawsuit](#) today in the US District Court for the District of Massachusetts challenging President Trump's March 31 [executive order](#) concerning mail-in voting. The Constitution explicitly states that only Congress and the states can set the rules for elections. Nevertheless, the order attempts to displace states' mail-in voting laws by transforming the US Postal Service from a neutral mail carrier to an arbiter of who may cast a ballot by mail.

The order also requires the Department of Homeland Security to build and give to each state a list of citizens eligible to vote. Given that federal databases are out-of-date and unreliable, this risks mass disenfranchisement of eligible voters.

The suit was filed by the League of Women Voters of Massachusetts, the League of Women Voters, Association of Americans Resident Overseas (AARO), US Vote Foundation, OCA - Asian Pacific American Advocates (OCA), and Delta Sigma Theta Sorority, Inc.

They are represented by the American Civil Liberties Union (ACLU), ACLU of Massachusetts, Brennan Center for Justice, Legal Defense Fund (LDF), Asian Americans Advancing Justice (AAJC), and LatinoJustice PRLDEF.

The plaintiffs and their counsel released the following statement:

"This executive order is an illegal and danger-

ous attempt by the Trump administration to eliminate accessible voting options and subvert our democracy by seizing control of election administration from the states and Congress. If implemented, it would disenfranchise eligible voters across the nation.

"Attempts to end voting by mail are part of the Trump administration's larger strategy to undermine elections and subvert the will of the people. The US Constitution is clear: the states and Congress — not the president — set the rules for our elections. President Trump tried to make an end-run around the Constitution with another executive order last year and was promptly rebuffed by multiple courts. History will repeat itself.

"This executive order would upend countless state laws and procedures regarding mail-in voting. It could deny eligible voters, including voters with disabilities, US citizens living abroad, and military members and their family members, the right to vote by mail — and unknown numbers will be disenfranchised without that option. Far from improving elections, this executive order would create chaos for election officials, erode public confidence in our elections, and block Americans from exercising their most fundamental right and responsibility as citizens — voting. By taking the administration to court, we are standing up for the rule of law and the promise of our democracy."

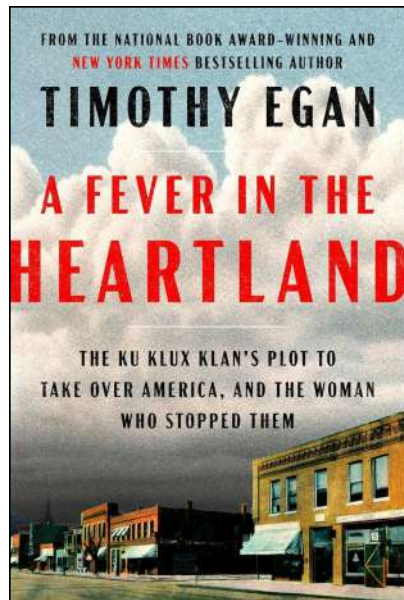

LWVF Book Club

Join the FLWV book club!

The newly formed Falmouth League book club will meet in the Bay Room, main branch of the Falmouth Public Library, Tuesday April 14 at 1:30 p.m. The discussion of the current selection, *A Fever in the Heartland* by Timothy Egan, will be led by League member Linda Jeffries-Summers. Join the group to listen to, or join in, the discussion. The next club selection will be made at the end of Tuesday's meeting.

A Fever in the Heartland documents the rise of the Ku Klux Klan in Indiana during the 1920s. The successful recruiting campaign was led by D.C. Stephenson, who rose to the title of Grand Drag-



on in the Klan due to his successful efforts in Indiana. He enticed men from local Protestant churches, the police force, judges, and legislators to join the Klan. Their goal was to “control America by peaceful methods.” However, their methods were anything but peaceful. Cloaked in white robes with headgear that covered their faces, the new Klansmen terrified businesses and non-Klansmen with beatings, fiery crosses, hangings, and death threats.

The northern Klan hated all people of color,

as the southern Klan had. In addition, the new Klan railed against Catholics, Jews, Asians, and some Eastern Europeans, as they sought to put their members into political offices throughout the state of Indiana. With Klan member judges and prosecutors who were allowed to pack a jury, there seemed to be no hope in stopping this terrorist group. Stephenson had made tremendous inroads politically and within white Protestant churches, whose leaders proclaimed the good deeds the Klan performed while overlooking their terror campaigns. The number of new recruits soared.

No one was willing to stand up to Stephenson for fear of reprisal. One exception was a seemingly powerless woman, Madge Oberholtzer. She is Egan's hero in this dark chapter of American history.
