#### NATURAL RESOURCES COMMITTEE PRESENTATION

The Natural Resources Committee typically presents a public program in November but the Covid Pandemic prohibited public gatherings this year. Instead, the Committee prepared a video presentation and released it on YouTube. The presentation on "Falmouth's Progress Toward Sustainability" can be viewed by following the link on our LWVF webpage:

The presentation covered many topics important to the League. Progress towards certification as a Green Community was addressed as well as examples of the types of grants this certification would allow the Town to get to improve energy efficiency. Zoning history related to large ground mounted solar arrays was summarized along with a discussion of the most recent and future additions to this energy resource in Falmouth. The town wind turbine stalemate was also discussed. Much of the presentation summarized the work of the Coastal Resiliency Action Committee and their work with the Woods Hole Group to assess the vulnerability of the shoreline and low-lying areas to coastal flooding and erosion due to climate change. We introduced the several studies and presentations made by this group, with examples of key findings, and links to the documents and presentations. These included the Vulnerability Study and the Surf Drive Study. The latter presented a series of mitigations which might be made for Surf Drive, with a timeline suggesting when each intervention would become necessary, related to sea

level rather than date. WHOI/MBL prepared similar studies for Woods Hole with the same consultant, and these findings were introduced in the presentation. The source documents are mentioned in the presentation as well as in the introductory text on the YouTube link. We encourage those who have not yet watched the presentation to do so, and then explore the links for more information.

It is a very powerful program and I was moved to email Karen Mazza for permission to share this experience with our Falmouth League. Six members of the Cape Cod Community address the experience of racism on Cape Cod and how it affects people of color in the community. Through their sharing, the audience was informed of the work that is being done through their organizations to address racism. I came away with the realization that many of us want to be a part of this work.

The LWVMA has identified developing an Action Plan to encourage understanding of racial justice issues by Massachusetts Leagues as a **State Program Planning Priority**. In **partnering** with League of Women Voters Cape Cod Area chapter, our local Cape Cod chapters of No Place for Hate, NAACP, MLK Group, Amplify POC and other action-oriented groups we can move forward with greater speed.

Thank you for your kind comments on our recent program, "How is Racism Experienced on Cape Cod". We are glad that you also found it to be very powerful and we are happy to have you share the link to the video with LWV Falmouth. We intend to do a Part II follow-up video, spending more time on what we can do about racism. Perhaps this conversation will lead to some collaborative efforts. I am Co-Vice President for Program with Jeanne Morrison and Jeanne is the primary organizer of the panel and program that we featured on the video. This program is one of several that we are sponsoring as part of our League's goals to support DEI in our League and pursue action steps that follow from it. As always, we enjoy our collaboration with Falmouth.

Thanks for sharing your comments. Denise, I am glad you found the program useful. I'd love for us all to work together on some initiatives especially for DEI work. I was involved with Barnstable No Place for Hate planning the Youth listening program which Karen also assisted with. Falmouth No Place for Hate is interested in partnering with BNPFH on some of the recommendations that have come out of the youth surveys. That piece was a natural bridge to our panel discussion on race. I think Cape Cod and Falmouth LWV have an opportunity to partner with groups in our communities that are working to be part of the solution. I wanted to be sure that you all received this important guidance from LWVUS regarding the use of images without a license, as we have just wrapped up this exact issue with one of our local Leagues. On the advice of LWVMA's pro bono counsel at Goulston & Storrs, one of our local Leagues just paid a \$750 fine to avoid a lawsuit over an alleged license violation for two images owned by the Associated Press. # LEGISLATIVE COMMITTEE

In December, as the extended session of the Massachusetts legislature was drawing to a close, the Committee reviewed and emailed two advocacy letters to the appropriate legislators urging passage of an Act Relative to Work and Family Mobility (S.2641) and the Safe Communities Act (H.3573/S.1401). Both bills were pending before one or both legislative Ways and Means Committees. Alas, so far as I as I can tell, neither bill was released from committee before the session ended so our work will have to continue.

Both letters emphasized the special importance of passing these bills now in view of the Covid-19 threat. I signed the Safe Communities Act letter on behalf of the Legislative Committee. While I mentioned League support of the bill in the driver's license letter, I signed it in my own capacity because it included personal views and also relied heavily on the broadcast I attended virtually by the "Driving Families Coalition" roundtable. While I expressed my own sympathy for the plight of immigrants, the letter emphasized the importance of the law for the safety of everyone, regardless of one's views on immigration. Afterwards I forwarded copies of the letters to Jen Muroff who heads up immigration advocacy for the Massachusetts League of Women Voters and who had advised me of the roundtable. She responded, asking for permission to share the letters with the Safe Communities Coalition, and, of course, I said "yes."

We are now busy planning the Legislative public program for March. Susan Moran, David Vieira, Dylan Fernandes, and Town Clerk Michael Palmer have all agreed to participate and FCTV has agreed to run the program live and to provide technical help. The program is a work in progress but, as of now, we are expecting it to focus on voting with emphasis on the 2020 primaries and elections as impacted by Covid-19 - and any lessons learned for the future.

## LOCAL STUDY

The new local study is an assessment and updating of LWVF local positions which are listed in the purple LWVF 2020-2021 Membership Directory starting on pages 23 thru 26. If you read through the positions, you will find a need for this review. Land Use is the position updated recently. Also the Town of Falmouth Charter Review Committee presented charter updates voted on in the Falmouth Town May election.

However, transportation, water quality, education, Falmouth Town Budget, affordable housing, and environment are in need of review. ## **REPORT ON TRANSPORTATION CLIMATE INITIATIVE: CLEAN TRANSPORTATION FOR RURAL COMMUNITIES**

\*There was a lot of information relayed by 10+ different speakers during the webinar. I have included my notes, along with interesting ideas and statistics. Further processing of this information as the TCI rolls out will be important to undertake.

Josh Ostroff, Partnership Director of Transportation for Massachusetts, (Website is https://www.t4ma.org )was the Coordinator of the Webinar presented 11/10/2020. Presenters included secretary of Energy and Environmental Affairs, Katie Theoharides, State Senator Adam Hinds, Executive Director of the Franklin Regional Council of Governments, Linda Dunlavy and several other experts.

There were 21 co-sponsoring organizations, 165 active participants, with 300+ registered, including several elected officials and the press. Senator Adam Hinds offered opening remarks, echoed by other elected officials. Most of the participants were from Berkshire County, followed by Middlesex, Worcester...with a few from Barnstable County. Poll question: how many miles is your closest grocery store? Most answered 0-2 miles.

Focus of presenters was on rural areas of MA and the effects of climate change on clean transportation initiative. Transportation Climate Initiative (TCI)'s mission is to reduce emissions from transportation that contribute to climate change, and to improve quality of life for MA residents. Transportation is the largest source of air pollution of any aspect of the MA economy (waste, electricity, fuel, etc). MassSave program, an offshoot of RGGI, has been the primary reason why MA, under Gov. Baker's leadership, has resulted in a top ranking for pollution control in the nation.

Cap gets smaller over time, which reduces pollution annually, and eventual overall emissions decrease across the multi-state region as a result. Known as "MassSave for Vehicles."

Daily vehicle miles per household in Falmouth (pre pandemic) 50-60 miles/day, which is slightly better than most of the State, which is (prepandemic)70+ miles/day. Not every gallon of fuel has the same carbon content. Even though this is a multi-state initiative, each state will determine its own investments.

Rural communities have higher percentage of older adults and people with disabilities.

Several Non-Transportation Solutions Proposed, including:

- ⇒ Electric vehicle subsidies
- ⇒ Increased funding for expansion of public and micro-transit
- ⇒ Create and improve rail access
- ⇒ Expand broadband access to increase viability of working from home
