#### MESSAGE FROM THE STEERING COMMITTEE

The Steering Committee meets monthly before each Board Meeting. Our January discussion was concerned with ongoing issues and new topics that then need to be discussed by the wider Board meeting a week later. In January we focused on continuing items: How to include youth members that LWVMA and National will not charge to our chapter. Our by-laws include persons age 16 and up. A small committee will work through the idea of a 5 hour social action commitment with a write up in lieu of dues for that group. Also, how to be open to membership from many for whom \$50 membership dues is a hardship. In that event we suggested indicating all dues requests as \$50 or whatever people are willing to pay. We would include a suggestion for those so able to donate additional funds above their dues. This reflects our desire to honor our DEI (diversity equity and inclusion) commitment for membership. Secondly, we proposed a need to repeat our earlier calls to members to check on wellness but also ask for consideration of serving on committees and on the Board, which will have several openings for 2021-22.

A new discussion addressed the issue of members from three adjacent communities (Bourne, Mashpee, Barnstable) and how to respect their participation and include information relevant to their communities. We are excited to welcome them and encourage them in to join the Board and committees. Representation from all over the Upper Cape brings us great opportunities to do the League's work!

#### NATURAL RESOURCES COMMITTEE PRESENTATION

In the last session, a comprehensive Climate Roadmap Bill (S.2995) was passed comfortably by the Legislature in Boston, but then vetoed by Governor Baker at the very end of the session. The current legislature passed it again (now known as S9) and Governor Baker had until Sunday, February 7 to sign, veto or amend the bill. Baker is said to have somewhat different Climate objectives, so it was not unexpected that he sent it back to the legislature. He asked for revisions to the emission reduction goals in the timeline to be less stringgent.

#### Briefly, the bill proposes:

Aggressive 5 year emissions limits, with specific plans for meeting and measuring these goals. These are broken down into six high priority sectors of the economy: eg transportation, industrial processes, etc. The State would be required to set numerical benchmarks for components of these limits, such as electric vehicles, heat pumps, energy storage, etc. It sets a net zero greenhouse gas emission limit for 2050, and requires 50% reductions by 2030 and 75% by 2040. It codifies environmental justice for frontline communities and low/moderate income individuals. It prevents wood-to-energy from qualifying for renewable energy incentive for a 5 year period. It would expand adoption of stretch energy codes by towns and would reassign energy code development to the Department of Energy Resources. It would align MassSave reporting and standards with climate policy and with precedents set in California, driving down emissions from common household and commercial appliances. The bill encourages and streamlines the development of off-shore wind utilities, prioritizes low-income communities for the state solar incentive program, and updates the state solar energy laws to encourage municipal and

business solar installations. It would incorporate climate concerns into Department of Public Utilities regulations, provide new funding for green energy job training, and reform natural gas safety standards and fines.
