Steering Committee Report

The Falmouth League, with FCTV as cosponsor, presented Candidates Night on April 30, before a packed Hermann Room audience. After an introduction by first vice president Janet Lauer, Falmouth Town Clerk Michael Palmer addressed the audience, emphasizing the importance of town elections.

Mr. Palmer reported that the annual town elections do not get the attention and turnout that national elections elicit — for Falmouth town elections the turnout is about 20%. These elections are for candidates who serve on committees that have a direct effect on our lives. The candidates are people with whom we have contact every day on Main Street, in the grocery stores, and other local spots.

Mr. Palmer challenged the audience to spread the word about the upcoming election and assist folks or neighbors who may need assistance in getting to the polls. He stressed that "We can do better than 20%!"

In-person voting will be Tuesday, May 20, at your local precinct. Early in-person voting, at town hall, is May 10, May 12

Legislative Committee Report

I am more than happy to report that the Legislative Committee now has eight members, and I confess that I am not entirely confident that I am not missing somebody. My predecessor, Margaret Cooper, long-time member Kerry Walton, and I have been joined over the past years by Helen Bresnahan, Colleen Cunningham, and Annie Holden, and now, by our two newest members, Deanna Jaroche and Jan Rook. We met at my house on Monday, May 5. When I say "we" I should explain that the "we" was four of us. However, because the four included our two newest members, the meeting was an exceptionally valuable opportunity to explore their interests and how thev reinforce and supplement the work of the Committee.

As most of you know, the Legislative Committee is an advocacy organization, working to promote the legislative priorities of the LWVMA as listed on its website under the heading "League-Supported/Opposed Legislation 2025-2026." We plan to continue to support three bills whose predecessors we have supported in the past. They are:

- An Act relating to End of Life Options/ Death with Dignity (H. 2505/S.1486);
- An Act to implement the recommendations of the special commission on facial recognition technology (H.1946/S.1053); and
- An Act relative to immigration detention and collaboration agreements, with the intent of ending or prohibiting such agreements (H.1588; S.1122).

We also plan to advocate in support of these five bills:

- An Act regarding free expression (pertaining to access to materials in public and school libraries) (H.3594/ S.2328);
- An Act ensuring access to equitable representation in immigration proceedings (H.1954/S.1127);
- An Act to promote safe firearm storage education (H.548/S.397);
- An Act enforcing accessibility for voters with disabilities (H.820/S.504); and
- An Act promoting access to counsel and housing stability in MA (H.1952/S.968).

We will oppose a bill calling for a national constitutional convention due to the risk that we could lose the constitutional protections we currently have.

We are providing this summary to LWVF members to give you an idea of what we are doing. We believe these are all issues of general importance, as are the many other issues addressed in other important bills that are not on our list. Now, with eight members on our Committee, we probably can expand the scope of our advocacy by a few more bills. If you know of a bill supported by the LWVMA that you would like us to support, we are open to suggestions.

Defend Due Process

The following is adapted from a message from the League of Women Voters of Massachusetts:

We wake to the news of yet another family being terrorized by Immigration and Customs Enforcement (ICE), and we know folks are being forcibly removed throughout all of our cities and towns. ICE is arresting and detaining people without warrants. Immigration infractions are civil, **not** criminal. Anyone charged with a crime in Massachusetts is already held accountable through our criminal justice system. While we understand the state constraints around reining in a federal agency, **NOW is the time to raise our voices and urge all electeds to demand enforcement of due process protections guaranteed by the U.S. Constitution**. Our federal delegation has demonstrated their commitment to human rights, but we can no longer turn a blind eye to daily ICE abuses – we MUST act now.

Suggested Script:

"Dear [Insert Elected Official]:

News this morning of yet another family torn apart: a harrowing tale of a Worcester mother taken by federal agents who did not present a warrant. The federal government is violating due process and the rights guaranteed by the US Constitution. Protecting due process for immigrants protects it for every one of us.

The League of Women Voters believes in the individual liberties guaranteed by the Constitution of the United States. We oppose major threats to basic constitutional rights—including arresting people without a warrant. The League supports due process for all

the right to humane treatment and that no person or group should suffer legal discrimination.

Please work with local, state and federal officials and demand that Immigration and Customs Enforcement (ICE) stop violating due process rights guaranteed by the US Constitution. We urge you to take immediate action to protect residents of the Commonwealth from further terror.

LWVF Awarded Scharfman Grant

The LWV of Falmouth received a Scharfman Grant to assist in funding a Get-Out-the Vote project focused on two goals. The first is to recruit new members who will bring different perspectives and new energy. Secondly, the grant will provide funding for the GOTV materials to ensure that the cost involved does not deter participation.

The project will take shape in the structure of casual coffee hours focused on voter education—everything related to voter registration and voter opportunities—as well as hands-on activities involving writing to voters all over the United States.

This is a nonpartisan effort to get people registered to vote and to inform voters of very specific information about upcoming elections. In addition, and most importantly, the new LWV members will also compose their own script sharing why they think it's important to vote.




