Advocacy Update

The CT General Assembly adjourned June 9. A Special Session was then added. Accomplishments Include: **Early Voting:** the General Assembly passed HJ 59 for necessary 2nd time. In 2022 we will vote whether to amend the state Constitution to allow for Early Voting.

No Excuse Absentee Voting:

The General Assembly passed HJ 58. The Assembly elected in 2022 and seated in 2023 must pass the provision again. The earliest this will come before the voters is 2024.

CT Voting Rights: SB 5, CT Voting Rights bill. Provisions include: (1) Restoring voting rights to people on parole; (2)Make use of drop boxes for return of absentee ballots permanent;(3)Two hours of unpaid time off for state elections and specified special elections if requested in advance:(3)Expanded automatic voter registration.

Bottle Bill: Now Public Act 21-58, expands types of beverages subject to recycling, increases the handling fee, and increases the bottle deposit. For background see: <u>LWVCT</u> **Action Alert**

Prison Gerrymandering

Ended: Substitute for SB 753 passed and the governor signed the bill into law as Public Act No. 21-13. Incarcerated persons will be counted in their home location instead of the prison location.
