October 2025

The November 4 elections are approaching fast. LWVJC will host 5 candidate forums in October for lowa City, Tiffin. Coralville, and North Liberty city council/mayoral elections, as well as a forum for the ICCSD school board election. See more details in the Vote Services article and the calendar in this month's Voter. City/school elections are extremely important yet typically have a very low turnout of voters - county-wide, 2023 city/school elections turnout was just over 25%. Think about what is on the ballot in your local elections - street repairs and maintenance, housing, emergency services, libraries, public transit, community medical services, local schools and more, are all on the ballot. City Councils and school boards determine how your tax dollars will be spent to provide the services you want and need. Do you really want just 25% of the voters to decide this for you? There are many options for you to vote, including by mail, early in-person, and at your polling place on election day (details here: https://johnsoncountyiowa.gov/november-4-2025-city-and-school-election). So please make your voting plan, attend/watch the forums to learn about the candidates, and then vote (and encourage your friends and family to vote as well).

The League of Women Voters of Iowa has published our 2026 Legislative priorities focused on advocating for voting rights, education, government transparency and accountability, reproductive rights, human trafficking, the environment – especially water quality, and gun safety. The detailed flyer is included within this month's **Voter**. With the increased emphasis on water quality in the 2026 priorities, it is serendipitous that our Making Connections event on October 8 is about *All Things Water*. Bonnie Boothroy has graciously agreed to host us in her home for a casual social get-together combined with an opportunity to learn more from Dr. Larry Weber, Professor of Civil and Environmental Engineering at the University of Iowa, who will share his expertise on water quality and answer our questions.

We had a great turnout of over 90 people at our Fall Reception and Membership Drive September 3 at the First Presbyterian Church in Iowa City. Thank you again to everyone who helped organize this successful event, and to all that attended. Our next membership meeting will be our December Luncheon and Legislative Preview on Saturday, December 6, 11 – 1:30 at the Holiday Inn Coralville-Iowa City (formerly the Radisson). EDUCATION

Join us on October 16, 6:30 – 8:00 pm at the lowa City Public Library for "Pumping the Brakes on Government Surveillance", the second program in the 2025-26 League Lecture Series.

ACLU of Iowa spokeswomen Becca Eastwood and Erica Dubin-Barz will delve into how state and local governments are surveilling their own residents, often without their consent. They will talk about privacy rights, surveillance technology lowa governments have adopted in recent years, legitimate concerns about this technology, and what we can do to push for change. Eastwood serves as Deputy Policy Director and Erica Dubin-Barz as Community Engagement Manager for ALCU of Iowa.

Future education programs will tackle the patchwork nature of childcare for working parents in Johnson County, the health and environmental consequences of lowa's deteriorating water quality, and how the lowa Legislature's dismantling of home rule is affecting governance at the local level.

VOTER REGISTRATION

League of Women Voters Johnson County held 6 registration events in September. On September 7, we tabled at FilmScene (Chauncey) in conjunction with the "Join and Thrive Club Fair". September 16, National Voter Registration Day, we tabled at the Iowa City, Coralville and North Liberty Public Libraries and on September 17 and 18, we tabled Kirkwood Community College. In total, we registered 42 new voters, completed 4 Absentee Ballot Request Forms and provided 11 QR Codes for people to register online. In addition, we fielded many questions mainly regarding an individual's registration status and voter ID requirements.

This is a busy time for the Voter Services team. It is our goal to host a candidate forum for contested races in Johnson County. We feel strongly that this gives voters the opportunity to hear directly from the candidates and make informed choices at the ballot box. On November 4, the focus is on school and city elections. Early voting begins on October 15.

The deadline for filing was September 19 for all but IC Council which was August 26. Here are the contested races for which we will host candidate forums in October: Iowa City Council, Coralville City Council, North Liberty City Council and Tiffin City Council. The ICCSD school board is also a contested race. The forums will be live streamed on the League's Facebook page and recorded and made available on our website following the events. There is an important ballot measure to be decided during the November 4 election. It is to authorize imposition of a local option sales and services tax in the cities of lowa City, Coralville and North Liberty at the rate of one percent (1%) to be effective on July 1, 2026. Each city has determined which projects they will direct the revenue toward. Fifty percent (50%) of the revenue must go to property tax relief. The local option sales tax does not affect expenditures on everyday items, such as groceries, utilities, gasoline, rent, prescription drugs, etc.

We hope to see many of you present in person at these forums. Your attendance helps the candidates be aware of the issues that are important to their constituents. Democracy is not a spectator sport!

MAKING CONNECTIONS

We will start this year's *Making Connections* series on Wednesday, October 8, with a focus on water quality issues. Larry Weber, Professor of Civil and Environmental Engineering at the University of Iowa has agreed to share his expertise and answer our questions. Weber leads the Iowa Watershed Approach, a five-year, statewide research project to enhance Iowa's flood resilience and water quality. He is also the co-founder of the Iowa Food Center. He was one of the 16 water quality scientists who contributed to the Polk County Central Iowa Water Resources Assessment and will share how this informs water quality in Johnson

County. Copies of the Executive Summary of the report will be available to those who attend.

If you are interested in learning more about the reduction of water sensors on lowa waterways, we recommend a September 18 <u>Gazette</u> article "lowa is at Risk of Losing Most of Its Water Quality Sensors: Here's Why it Matters". Here is the link: "<u>Water Sensors"</u>. Bring your concerns and questions. This is a member only event.

ADVOCACY

The mission of Advocacy is to inform, empower and activate voters. Through that process, the goal is to sustain a representative and responsive local and state government. Last year's lowa legislature championed a platform that did not always seem reflective of most voters in lowa.

So, what do lowans think?

Progress lowa released an exit poll during the 2024 election showing where lowans' top priorities were at the ballot box. The poll was conducted by Public Policy Polling (PPP) and the results show that lowa voters heavily favor progressive policies and solutions, including repealing lowa's 6-week abortion ban, raising the minimum wage and supporting public education.

lowans may have voted for Trump again, but you can still see shades of purple through the policies they support," Policy Analyst for PPP Jim Williams said. "The data from our poll shows that lowa voters support funds for public schools over private, access to health care and their abortion rights, and economic policies that favor working families over wealthy corporations."

While President Trump received 56% of the vote in Iowa, many progressive policies in the poll received even more support from Iowa voters:

- 59% think public tax dollars should be spent to fund public schools only.
- 66% support stricter firearms carry regulations, i.e. limiting concealed carry, requiring permits or background checks, and safety training.
- 87% say it is very important to maintain Social Security and Medicare.
- 57% think the Governor and Iowa legislature should increase funding for public schools.


- 57% prefer their tax dollars be used to adequately fund public services like education, infrastructure, and clean water over saving a few hundred tax dollars on their taxes.
- 81% believe the minimum wage should be increased.
- 79% of lowa voters agree that politicians have been too focused on private personal issues.

Voters are clearly frustrated with politicians and eager for solutions to the wide array of social, environmental, educational, and medical challenges in lowa.

The LWVJC Advocacy Committee will continue to encourage voters to stay aware of legislative actions, discuss the potential solutions, and make voices heard in their communities and at the ballot box. In this moment, our democracy is demanding that from each of us.

T VOTING

Promote equal access to voting and ensure all votes are counted. Adopt automatic voter registration. Pass a constitutional amendment allowing lowans with felony convictions to vote after time served. Promote open primary elections. Join the National Popular Vote Interstate Compact.

TRANSPARENCY & CITIZENSHIP

Demand government accountability and transparency by requiring all amendments and bills discussed in committee to be available to the public prior to a vote. Demand timely processing of Freedom of Information Act (FOIA) requests. Encourage direct citizen participation by requiring virtual committees and subcommittees.



EDUCATION

Provide oversight and track public funds being used for non-public schools. Require any non-public school receiving public funds to meet the same standards as public schools. Fully fund public schools. Continue to expand access to affordable childcare. Restore statewide special education and disability services.



REPRODUCTIVE RIGHTS

Guarantee access to the full range of women's reproductive health services. Repeal the six-week abortion ban. Make contraception available without prescription and promote programs that help prevent unplanned pregnancies. Ensure Medicald services are comprehensive and accessible. Set policies that attract maternal health professionals and address the state's OB/GYN deserts.



HUMAN TRAFFICKING

Increase state funding for victim services; develop strategies to prevent human trafficking, domestic violence, and sexual assault; and enact "Safe Harbor" legislation to protect victims from criminal prosecution.

WATER

Prioritizing, protecting and improving lows water quality and ensuring its sustainable management. Enact policies that safeguard clean water and address challenges of health risks, pollution, overuse and climate change.

GUN SAFETY

Ban assault rifles and military-grade weapons for civilian use. Enact background checks on all gun sales, close gun show loopholes, require gun safety locks, repeal lowa's "stand your ground" law, and oppose laws that allow carrying guns on school


