LWVMA Haddad, Creem Keynote LWVMA Day on the Hill

Two of the highest ranking women in the state legislature—Rep. Patricia Haddad, Speaker Pro Tempore of the House, and Sen. Cynthia Creem, Assistant Senate Majority Leader of the Senate—will be the keynote speakers at the League's annual lobby day Tuesday, Oct. 24.

Day on the Hill's theme is *Moving the Needle on League Priorities*, and the event will focus on legislation in four areas identified as priorities at the League's convention last April:

- Elections: Automatic Voter Registration bill
- Climate Change: Carbon Pricing bills
- Immigration: Safe Communities bill
- Criminal Justice Reform: Comprehensive reform legislation

Day on the Hill is in the Great Hall at the State House. Registration and coffee begins at 9:30 a.m. and the program runs from 10 a.m. to noon.

Hundreds Attend "Extreme Events and Climate Change" Forum at New England Aquarium

What We Know and What We Can Do

September 14, 2017–A sold-out crowd filled the Aquarium's Simons IMAX® Theatre for "Extreme Events and Climate Change: What We Know and What We Can Do," cohosted by LWVMA and LWV-Boston, the New England Aquarium, and UMass Boston School for the Environment.

Dr. Ellen Marie Douglas, UMass Boston, was the speaker in the first forum on "Extreme Events and Climate Change" co-sponsored by the League of Women Voters of Massachusetts and a number of other organizations held on September 14, 2017, at the New England Aquarium.

She laid out the evidence for the causes of climate change, its impact on sea level rise in Massachusetts, and efforts to overcome the devastating changes in store for the region through mitigation and adaptation.

Dr. Douglas also reviewed data on the increased temperature of the planet, increased CO₂ emissions, the cost of hurricane Harvey, and the increase of the global populations exposed to hurricanes. She listed 11 extreme events—floods, ice storms, "Halloween" blizzard-- in New England since October 1996. While hurricanes are not frequent in New England, the area does have two to three northeasters every year. This is currently an area of active research

What does this mean for the Boston area? There are four main effects:

- 1. By 2070, there will be over 90 days a year with temperatures over 90 degrees correlated to CO₂ emissions
- 2. Very cold days will decrease, but extreme storms will continue
- More rainfall.
- 4. Sea level rise due to expansion of warmer water, melting glaciers, increased ground water extraction, and ice sheet melting, which may be the most important factor. Coastal areas that will be most at risk to sea level rise are East Boston, South Boston, and Charlestown.

It is not all bad news. The good news is that the United States has learned lessons from prior extreme events, Boston and the Commonwealth have embraced the building stretch code (Acts of 2008), the first cap and trade agreement in New England, and the Boston Climate Action Plan.
