LWV LEXINGTON OPENS 2019/20 FIRST FRIDAY SERIES WITH LEXINGTON PUBLIC INFORMATION OFFICER SEAN DUGAN

What is my trash day, given the holiday or unexpected snow date? When will yard waste be picked up? What is the schedule for Patriot's Day? If you have questions about Town of Lexington plans, events, and services, we have the answers for you.

On October 4, 2019, the League of Women Voters of Lexington will host the first in our 2019-2020 First Friday forum. Our speaker will be Sean Dugan, Lexington's Public Information Officer (PIO), a new position in Town since January 2019. Sean comes to us having worked previously in the Information Technology field in Concord and Framingham. His work in Lexington includes updating the town website providing easier access to information and using multiple communication platforms to reach town residents. Sean will also answer your questions about how/where to find information you need.

League of Women Voters of Massachusetts Climate Emergency:

Resolution Unanimously approved by LWVMA Environmental Action and Advocacy Committee, May 22, 2019 for submission to the LWVMA Convention, June 7-8, 2019.

Whereas on October 8, 2018, the United Nations released a special report that projected that limiting warming to 1.5 degrees Celsius this century will require an unprecedented transformation of every sector of the global economy over the next 12 years; and

Whereas on November 23, 2018, the U.S. Fourth National Climate Assessment was issued, which detailed the massive threat that climate change poses to the American economy and underscored the need for emergency climate action at all levels of government; and

Whereas the death and destruction already wrought by global warming of approximately 1.1 degrees Celsius above late 19th century levels demonstrate that Earth is already too hot for safety and justice, as attested by rising seas, increased and intensifying wildfires, floods, diseases, droughts and extreme weather; and Whereas one million animal and plant species are now threatened with extinction, according to a sweeping new United Nations report, driving the sixth mass extinction of species and – if reached – would require 10 million years for recovery; and

Whereas the impacts of climate change and ocean acidification include increasingly a rise in sea levels resulting in flooding and the displacement of thousands of coastal businesses and residences, damage to marine ecosystems and food sources, extreme weather events, devastating wildfires, and introduction of new vectors for infectious disease, increased asthma and other human health-related problems; and

Whereas climate change has a disproportionate effect on communities that typically have fewer resources for adapting to climate change and so consequently are the most vulnerable to displacement, adverse health effects, job loss, property damage and other effects of climate change; and

Whereas the world's leading climate scientists predict that serious impacts of climate change will catastrophically worsen if prompt action is not taken to curb emissions; and Whereas restoring a safe and stable climate requires a "climate mobilization" on an extraordinary scale at all levels of government to reach net zero greenhouse gas emissions; and

Whereas in the absence of effective federal engagement, it is the responsibility of the individual states and municipalities to take immediate leadership actions to address climate change; and

Therefore, be it resolved, We as delegates of Massachusetts local Leagues assembled at the 2019 LWVMA Convention call upon the LWVMA Board and local Leagues to advocate for declarations of 'Climate Emergency' and urgent relevant action by state and local governments.

Climate Strike for the Planet's Future

On Friday, September 20, 2019, members of the Lexington League joined more than 300 Lexington High School students and other supporters in the community in observing a youth-led international Climate Strike. For two hours the students left their ordinary classes and gathered on the athletic field to draw attention to the climate crisis the planet is facing and to advocate for curbing the use of fossil fuels and other actions to building a sustainable future. Senators Mike Barrett and Cindy Friedman and Representative Michelle Ciccolo attended the rally, as well as members of the Lexington Select Board and the Lexington School Superintendent Julie Hackett Hackett. Members of the League staffed a voter registration booth.

The local strike was supported by the Lexington Global Warming Action Coalition (GWAC), Minuteman Indivisible, the First Parish Climate Action Team and the Hancock Environmental Action Team, as well as LWVLexington. It was coordinated with the Boston Youth Climate Strike held on the Boston Common at the same time, for which the state League was an official sponsor, and forms a part of an international Climate Strike promoted by Bill McKibben's 350.org. 350.org is an international environmental organization addressing the climate crisis. Its goal it to end the use of fossil fuels and transition to renewable energy by building a global, grassroots movement. Safety and justice for people across the globe is a critical part of 350.org's mission.

The Lexington League was proud to add our support to the rally and to the global effort to spur action to preserving our planet.

Senate President Spilka Keynotes LWVMA Day on the Hill

Senate President Karen Spilka will be the keynote speaker at the League's Day on the Hill Lobby day Thursday, Oct. 17.

Day on the Hill, *Time to Act*, will focus on legislation in four priority areas:

- Election Day Registration
- The climate crisis
- Education funding reform
- Women's reproductive rights

Day on the Hill is in Room 428 at the State House. Registration and coffee begins at 9:30 a.m. and the program runs from 10 a.m. to noon. Then League members will visit their own Senator and Representative.

Register for the lobby day here. The LWVMA office will notify legislators to expect visits from their League constituents who register before Oct. 11 after the morning's program. League members can also make their own appointments with their legislators.

National League Action on Gerrymandering

LWVUS is launching a 49-state + DC campaign to end partisan gerrymandering: **The People-Powered Fair Maps Campaign.** Earlier this month the national League hosted an internet town hall forum which is accessible through the national website. The work will look different in each state. The national board has authorized half a million dollars to launch this campaign, and every state League will receive some of that funding through grants. Remember, to our embarrassment, "gerrymandering" is named after a Massachusetts legislator, Elbridge Gerry, who made the practice famous in the 1700s!)

NEW & IMPROVED VOTE411 HAS EVERYTHING VOTERS NEED AHEAD OF 2020

WASHINGTON 9/23/2019 – Tuesday was National Voter Registration Day (NVRD), a holiday established in 2012 to celebrate democracy and register hundreds of thousands of voters annually. The League of Women Voters, the largest on-the-ground NVRD partner organization for the eighth year in a row, will host more than 500 voter registration events in local communities tomorrow.

"In 2018 we reached ten million voters, and with such a pivotal election on the horizon, we want to make sure the public has everything they need to participate in 2020," said **Chris Carson, president of the League of Women Voters board of directors**. "Don't let a registration deadline prevent you from casting your ballot. You can get started right now and make sure your registration is up to date on VOTE411."

The League of Women Voters Education Fund powers <u>VOTE411.org</u>, the newly redesigned election information site where voters can find everything they need to vote, starting with registration, seeing what is on their ballot, checking their polling place, voting hours, and much more.

"Voters are just months away from casting the first ballots in the 2020 elections," said **Virginia Kase, CEO of the League of Women Voters**. "Now is the time to make sure your voter registration is up to date and the League will be hosting events around the country to help voters prepare for next year's critical election cycle."

Thousands of organizations, companies, and celebrities hit the ground in communities around the country to register tens of thousands of new voters on one single day.

"The League of Women Voters will celebrate its 100th Anniversary next year," said **Jeanette Senecal, senior director of mission impact for the League.** "The best birthday gift we can imagine is that all voters check their voter registration status and encourage friends and families to do the same."
