

## **EQUAL RIGHTS ADVOCACY (ERA) COMMITTEE:**

Women's History Month film festivals went well. Thank you to Elk Rapids Cinema for showing the Basis of Sex; to the State Theatre for showing 3 movies by women directors; and to the Bay Community Theatre showing 3 movies featuring strong women.

Future projects ...... Request LWVLC march in 4<sup>th</sup> of July as suffragists to commemorate the 100 year anniversary of passage of the 19<sup>th</sup> Amendment. Consider taking films about the ERA, Alice Paul, suffragists, voting rights, etc. to local high school government/civics classes before the 2020 election.

Jan Frazee has been participating in a weekly conference call on the ERA. There is concern that other states will not ratify the ERA unless Congress removes the deadline for its passage. We are urged to call Washington to ask for "immediate hearings to remove the deadline for ratification of the ERA".

**Farm Labor Task Force:** LWVMI has been tracking the progress of two bills in the Michigan State House, HB 4083 and HB 4090. They are called the Local Government Sanctuary Policy Prohibition Acts. The bills would ban a county or local unit of government from enacting or enforcing any kind of law or policy that limits or prohibits local officials, law enforcement officers and employees of those entities from "communicating or cooperating" with federal officials concerning the immigration status of an individual in the state of Michigan. President Judy Karandjeff will testify in opposition when these bills come up in committee. The Task Force encourages attendance at the Michigan Association for Infant Mental Health Biennial Conference in Ann Arbor May 5-7. The topic for the Policy Luncheon is "Immigration Advocacy – What You Need to Know and What You Can Do To Help". We welcome two new members, Jody Betten and Anne Rogers. ## "We Will Meet Again"

To celebrate Women's History Month on March 6, 2019, the LWVLC Equal Rights Advocacy Committee, chaired by Jan Frazee, hosted members and guests at an hour-long showing of "We'll Meet Again—The Fight for Women's Rights," a film about four women who changed history, and each other.

To view this segment of the PBS series, we joined moderator Ann Curry, to undertake a journey with two women, as they searched for colleagues who had forged a path for equal rights. One, among the first female commercial pilots, searched for her mentor to thank her. A second, a veteran feminist, sought the woman who organized a hunger strike to pass the Equal Rights Amendment in Illinois.

Who were these women who, as Jan Frazee said, were "intelligent, brave, and willing to push the envelope" in the 1970s and 1980s?

Captain Lynn Ripplemayer worked as a TWA stewardess when cockpits were full of pornography, and the legal concept of 'sexual harassment' was yet to be invented. More than anything, she wanted to fly—as a pilot not a passenger. At age 25 she went back to school to study physics, and earn 1,000 hours of jet-time flying a Twin Otter at Air Illinois. There, she met Emily Jones, already a pilot, who became her mentor. Emily convinced Lynn she, too, could be captain of an air ship. Years later, Captain Lynn became the first woman to pilot a jumbo jet across the Atlantic.

Zoe Nicholson founded a feminist press and opened a women's bookstore—an oasis of safety and struggle as women sought equality under the law. When she read about all of her heroes—Alice Paul, Martin Luther King, and Gandhi—their stories, she said, "struck Middle C in my heart." So, the day Sonia Johnson called, Zoe answered. Sonia, excommunicated from the Mormon Church for challenging patriarchy, was a champion of the Equal Rights Amendment. A national leader, Sonia organized a hunger strike in the Illinois state capitol rotunda at Springfield, as the legislature debated becoming the 36th state to ratify the constitutional amendment. There, Zoe joined Sonia and five other women who fasted for 37 days—water only—alas, to no avail. Illinois legislators finally ratified the ERA 36 years later, in June 2018, becoming the 37th state to do so. Women will enjoy equal protection under the Constitution when the 38th state ratifies.

Following the screening, Jan Frazee invited us to call-out the names of women who changed our lives. More than 30 names tumbled forth: Lois Gibbs, Barbara Reinert, Elaine Maternowski, Marilyn Becker, Eileen Wolcott, Jo Rundio, Ruth Bader Ginsberg, Sally Neal, Claudette Byers, Julia Brabenec, Jean Rundquist Lauren, Louise Bramer, Kathy Frerich, Chris Hettenbach, Ann Mazurek, Erin Connolly, Margaret Simpkins, Mrs. Margaret Charles Smith, Jo Bullis, Bella Abzug, Eva Petoskey, Vina Mikesell, Corrine Donahue, Elsie Zimmerman, Betty Weaver, Ann McInnis, Sandy Marinelli, Katsi Cook, Ann Schmittling, Marian Kromkowski, Helen Milliken.

Then we were issued an invitation—for Women's History Month in March 2020—a year away. Next year we will celebrate the 100<sup>th</sup> anniversary of the 19<sup>th</sup> Amendment giving Women the Right to Vote. To honor that occasion, each of us was invited to elevate a singular woman who has changed our lives, and to tell that story. Further, we were invited to express our story using any of the literary, visual, performing, applied, or decorative arts or crafts that best conveys its meaning. What fun! We look forward to March 2020 when "we will meet again."

## "The Sixth Great Lake is Groundwater"

Everyone knows Michigan is the only state surrounded by the Great Lakes, the world's largest freshwater system. We remember all five with the acronym H.O.M.E.S. But, according to acclaimed author and environmental policy advisor, Dave Dempsey, there is a 6th Great Lake: Michigan's groundwater. Unseen and undervalued, our groundwater, equal to Lake Huron in volume, replenishes 40% of Great Lakes water and cannot be ignored.

Michigan is the only state that lacks statewide septic regulations. We have more private wells than any other state, yet we allow sewage and toxic plumes to contaminate our water. Some counties, like Benzie, have led with their own septic regulations, but without statewide minimum standards we are taking our most precious resource for granted. Last year, after a day of listening to experts urge protection for Lake Leelanau, the County Commissioners there voted against taking any action that might restrict property owner rights and financial interests, so septic regulations were not adopted.

Michigan also ranks 50th in government transparency. We're the only state that hasn't required financial disclosure or allowed FOIA (Freedom of Information Act) requests of our lawmakers. This has allowed monied corporate and private interests to flourish behind closed doors. Last year's lame duck session swiftly and callously cemented those public-private agreements despite (or because of) the newly elected Governor who opposed them.

So it seems that water issues and governance issues are linked. The Flint water crisis, allowing Nestle to bottle our water for \$200 a year, letting Enbridge keep Line 5 operating while they build a tunnel, and a lack of septic regulation are a few of the issues that threaten Michigan's water. And all represent legislative decisions which place private financial interests over environmental considerations.

Despite recent federal proposals to slash GLRI (Great Lakes Restoration Initiative) funding by 90%, Governor Whitmer seeks to improve our stewardship of the Great Lakes. Leelanau County commissioners will take up local septic issues again in 2019. So we have a new chance to make a difference in Michigan.

Michigan already leads the nation as a destination choice because of our water. Climate change is expected to increase the desirability of our location. The importance of protecting the water and the public health dependent on it is paramount and this priority is enshrined in our constitution.

The Great Lakes epitomize the very essence of Michigan and its economy, but Pure Michigan must be more than a slogan. We need actions and laws that will actually protect all six of our Great Lakes!

## Will Kasson and Empire Townships Adopt a Mandatory Septic Inspection Ordinance to Help Protect Surface and Groundwater?

During March and April, Kasson and Empire Township boards will be considering passage of a unified well and septic inspection ordinance. It is our hope that both townships will join Glen Arbor and Cleveland Townships in better protecting our surface and groundwater from septic pollution by adopting a unified inspection ordinance. This mandatory septic inspection ordinance also includes drinking well inspections since malfunctioning septics can pollute nearby drinking water. The price for an inspection is \$300 to \$500, the cost of which in most cases can be rolled into the property sale.

A point of sale or time of transfer of ownership triggers an inspection. The ordinance would apply to the entire township and inspections will be administered by the health department on behalf of the townships. Older systems, which may not meet current codes, are grandfathered in as long as they are still functioning. Septic systems that are not functional must be repaired. If the system cannot be repaired, then a new system would need to be installed and the latest sanitary building codes would apply. Information on multiple financing resources is available through the county planning department. The county health department, planning department and local zoning administrators have assisted in this project to ensure all potential concerns regarding the ordinance have been well thought out and carefully reviewed prior to presenting the ordinance to the townships.

- ✓ The Board does not recommend any updates.
- ✓ The Board does not recommend any concurrence with any local position.
- ✓ The Board does recommend a new study on the Structure and Process of the Michigan Legislature limited to exploring the ramifications on democracy, if any, posed by lame duck sessions and developing guidelines, if warranted, regarding the type of bills and how such bills should be handled in a lame duck session.
