
## "Changing Values for Community Safety"

**C**riminal justice reform and discussions on how to keep our communities safe in a just manner have become major topics of concern around the country—and within the League of Women Voters. The national, state, and local levels of our organization are all asking questions and educating ourselves about the problems, root causes, and innovative solutions.

*The League of Women Voters of Monterey County voted to make criminal justice at the local level a 2021-2022 issue for emphasis.* We start with a stellar panel of leaders in Monterey County law enforcement. Future LWV general meetings will provide perspectives from other stakeholders in our community.

At this November 10 General Meeting, **Pacific Grove Police Chief Cathy Madalone**, **Marina Police Chief Tina Nieto**, and **Monterey District Attorney Jeannine Pacioni** will speak to us about some of their experiences and insights, and what they think is important for us to know as citizens as we work together to create healthy, safe, just communities.


**Salinas Valley Basin** LWVMC is represented on the **Salinas Valley Groundwater Basin Sustainability Advisory Committee** by **Beverly Bean**, who fills the "Environmental" seat.

With redistricting underway, our League received appeals for members to join local educational redistricting commissions. **Tama Olver** has been appointed LWVMC's representative on the **Monterey County Office of Education's**


**L**ike many LWVMC members, I am an avid reader. Fortunately, our local libraries have reopened for browsing and borrowing. That's where I found, **"Thank You for Voting, Young Readers' Edition"** by **Erin Geiger**. In language accessible to students in middle grades and up, this book discusses franchise expansion, voter suppression, gerrymandering, and the Electoral College. It concludes with a rousing call to action showing how young people can encourage voter turnout. I have just started listening to the audio edition of the original adult version of this book.

In recent years I've enjoyed two books featured at LWVMC general meetings (formerly called "Lunch & Learn" presentations when we met in person and organized food service). In 2019 author **Robert Cooney, Jr.** spoke to us about the suffrage movement. Cooney's history **"Winning the Vote"** includes abundant archival photos. You can now find copies, donated by our League,



at the **Monterey Public Library, Monterey County Free Libraries Seaside Branch**, and the **Steinbeck Public Library, Salinas**.



★★★ **November Election Hero Day & December Human Rights Award** ★★★

**T**he first Monday in November was designated in 2020 by the non-partisan **National Conference on Citizenship** as **Election Hero Day** to express appreciation for election officials and staff, poll workers and the voters themselves.



The COVID pandemic highlighted the essential role that election workers play in a democracy.

In the past year these public servants have demonstrated dedication and flexibility, sometimes working 20-hour days to process record numbers of absentee ballots, while confronting numerous challenges, including health risks and a shortage of poll workers. In some areas they even faced harassment. Ultimately, they enabled more than 150 million citizens to cast ballots safely and successfully.

## LWVMC Member Profile: Juliet Oliver



**J**uliet Oliver, who is in her senior year at **York School**, first learned about the League of Women Voters in her United States history class. *“We learned about the suffrage organizations formed to help people get the right to vote and the League was included in that,”* she recalls. Curious, she says she *“reached out to the local League and asked for more information.”*



Juliet enrolled at York School midway through her eighth grade year, when her family moved to this area from **Kingsburg**, in California’s Central Valley. *“My mother was **Director of Training for Seminis Vegetable Seed**, but she’s retired now,”* Juliet says, *“and my father is the managing engineer for **Central Valley Meats**.”*

At that time, Juliet wasn’t sure whether she qualified to be a member of LWVMC at her young age, but she wanted to find some way to volunteer. *“At first, I had a conversation with **Marianne Gawain** and she suggested that I talk to **Sharon Miller**. Then I went to a meeting with the League’s **Redistricting Committee** and later I attended a couple of other meetings on redistricting, both with the League and with **Monterey County**,”* she says.

Since moving to our area and enrolling at York, Juliet has led a very active life with myriad interests.



Now Juliet, along with two other York School students she recruited, is hosting community meetings to inform Monterey County residents about the redistricting process. **Sharon Miller** is mentoring the group. At these meetings, Juliet says, *“we teach them about the process work needed to submit community of interest testimony.”* She wrote an article for the **September LWVMC Voter** that further describes this project.

She did some volunteer work with **Return of the Natives**, a land restoration group based in **Moss Landing**, and later served as a poll worker for the 2020 election.



Playing and performing music is still another of Juliet’s passions. *“I play orchestral percussion and marimba in the **Youth Music Monterey Honors Orchestra**,”* she reports, *“and I’m also playing in the **Carmel Bach Festival’s Young Artists Showcase**.”*

**York School**  By early October, Juliet and her fellow students had hosted a brief **mapping tutorial** for League members and one online community meeting for some **Pebble Beach** residents. They were preparing an in-person meeting for York School. *“Then we’ll do some more meetings around the County, some online and others in person,”* she explained.

After she graduates from York next spring, Juliet says she hopes to major in math in college and then possibly earn a graduate degree in the sciences.

As she progresses with educating Monterey County residents about redistricting, Juliet has been very encouraged that the League’s Board considered and now has approved having a student membership. She expects she won’t be the only teenager joining. When she told her York School classmates about the redistricting process, she was delighted to see how many of them were enthusiastic about helping with her project.

Since so many LWVMC members list recruiting younger members as an essential goal for our chapter's future, attracting capable and energetic young people like Juliet Oliver seems like a wonderful bit of good luck.

★★★ Update on Redistricting In Action ★★★

**O**ur LWV of Monterey County Redistricting Committee meets monthly, in the interim attending via Zoom the California State Redistricting Commission meetings (especially Zone E, which includes Monterey County) and the Monterey County Advisory Redistricting Commission for the Board of Supervisors.



The deadline for the adoption of new district maps is late December for the state and county.

The local agencies have a little more time, so **there is still an opportunity for you to participate** by submitting your ideas, suggestions, or draft maps—electronically, by mail, or even by phone.

As mentioned by **Marianne Gawain** (see page 2), we stay in touch with cities, schools, and other government agencies that are drawing new district boundaries, and several of our members have been asked to serve on those agencies' redistricting boards.

Go to the website of the agency you are interested in redrawing district borders, or contact me or Co-Chair **Bev Kreps** with your questions or to receive the Zoom link to attend committee meetings.

Your voice needs to be heard now so that your vote counts later!
