"LWV Positions on Ballot Measures"

Helen Hutchison, Recent Past President, LWV California



Helen Hutchison will be Guest Speaker at our **October 14 Virtual General Meeting**. She will briefly explain each of the twelve **Propositions on the November California General Election ballot**, and the "**Vote with the League**" recommendation to vote "Yes" or "No" or why the LWVC is "Neutral" on each. A question and answer session will follow her presentation as time permits.

In brief, the Propositions before us on the California ballot are: **14 Stem Cell Research; 15 Schools & Communities First; 16 Opportunity for All; 17 Restore Voting Rights; 18 Voting Rights for 17-Year Olds; 19 Property Tax Breaks; 20 Rollback on Criminal Justice Reforms; 21 Local Governments & Rent Control; 22 Rideshare & Delivery Drivers; 23 Kidney Dialysis Clinics;**

24 Consumer Data Privacy; 25 End Cash Money Bail.

★ **PRESIDENT'S MESSAGE OCTOBER 2020** ★

Among the fourteen or so Measures we are about to find on our doozy of a ballot are three tax increases, educational bonds for school districts and a local community college, and revenue increases for individual cities. These are the ones we will talk about. But first let me mention there are also several broad social improvement measures and several specifically benefiting small groups. You and **Voters Edge** are about to become friends.

My concern is with the revenue measures. Our various governmental groups face difficulties meeting urgent needs before even trying to address whatever will emerge as the "new normal" once the spread of COVID is under control. The federal government created a trillion dollar tax deficient hole with the recent tax revisions. Then it added two trillion for direct novel virus related relief. Our national debt now surpasses our current national income.

Counties and cities are now burdened with needs far exceeding available revenue. They are looking to tax everything they can. The hotel room tax hits people who didn't get to vote on it. Isn't there something in our past about that? Normal tax revenue streams are now often half of normal.

There is little hope things will improve much within the next six months, and some say a year or two will pass before our new normal becomes clear and revenue flows normally once again.

Meanwhile, there are lots of people who are suffering as a result of job loss, inability to pay for housing and absolutely no discretionary spending funds. Children may turn out to be the longest suffering population of all. And under this condition increased taxes are being proposed?

We are aware that ballot issues often pass or fail by a small margin. There is often a small cohort that with its considered vote tips the scale to the victor. I like to think that these voters are the ones who

really took the time to study the questions and decide if and where we should let the burden land.

And that is why your thoughtful opinion is so sorely needed this year. You, we, are the ones who must decide whether our government gets funded more fully now in these critical times to meet broad compelling needs. Or you, we, can decide to leave the burden where it lies and come back to it in better times. And who pays then? It is the ultimate question.

The Marina campaign for extending its **URBAN GROWTH BOUNDARY to 2040** is underway with **Measure Q** on the ballot.

For twenty years the Urban Growth Boundary (UGB) has protected agricultural land and open space, prevented urban sprawl and helped revitalize the urban core. The UGB also helped the city pursue its housing needs by building in areas where services and infrastructure already existed. Furthermore, there is sufficient undeveloped residentially designated land already within the UGB to more than meet Marina’s population forecasts for the next twenty years.

According to Marina documents, the current UGB approved by voters in 2000 successfully protected the city’s quality of life and small town character by concentrating growth within or adjacent to existing developed areas. The **League of Women Voters of Monterey County (LWCMC)** applauds the success of this program and heartily **encourages the voters to extend it another twenty years.**

LWVMC has a long established land use position to support smart planning and development. Specifically, the policy supports continuing evaluation of:

1. Area wide **planning and growth management policies and programs** for the entire Monterey County area.
2. **Preservation of open space** by public acquisition of land.
3. Short and long-term measures to **control growth and provide for orderly development** that is consistent with environmental protection.
4. A **planning process** which is well-coordinated, based on, adheres to, and implements the appropriate General Plan, and provides adequate information for timely, well-informed decisions.

Every aspect of the UGB in the past 20 years, and the proposed next 20 years, fits current League policy. We applaud Marina’s restrained yet effective progress in concert with this policy and encourage other agencies in our county to follow its example of good land management.

RE: Coastal Permit Application - California American Water Coastal Development

The **League of Women Voters of Monterey County** (LWVMC) in a letter to you dated October 16, 2019 urged the **CA Coastal Commission** (CCC) to deny the **California American Water** application for a Coastal Development Permit for intake slant wells and desalination infrastructure because the **Pure Water Monterey Expansion** (PWM X) is a vastly superior environmental alternative water supply project. By comparison with PWM X, the intake wells and desalination project shows numerous disadvantages related to environmental impacts, environmental justice, cost, and size.

Since then, the Pure Water Monterey Expansion has been under political attack by a number of its own Monterey One Board members. Their goal was to prevent the PWM X from going forward. On April 27, 2020 the **Monterey One Board of Directors** voted, by a one vote majority, to deny the **Marina Coast Water District** (MCWD) request to increase its weighted vote from 2 to 3, based on increased population. The only reasons that were given by Board opponents were that other agencies in Monterey One Water might deserve changes in their number of votes. The guidelines for changes are prescribed in their **Joint Powers Agreement** (JPA) and the process exists for them to apply to the Board for such changes. This process was followed by MCWD. The only other request from the Board was that the staff make a recommendation on MCWD's request prior to bringing this to a vote. Clearly the staff must recommend in favor of MCWD or violate the JPA.

It is clear that this vote denied MCWD its appropriate representation. According to the Joint Powers Agreement forming Monterey One Water, the request from Marina Coast Water District was completely valid. The Directors violated their own bylaws, as stated in the JPA.

The League is extremely concerned about representation and voting rights at all levels of government. Disenfranchisement of the population, represented by Marina Coast Water District, goes against the democratic norms that govern us at the local, state and national levels.

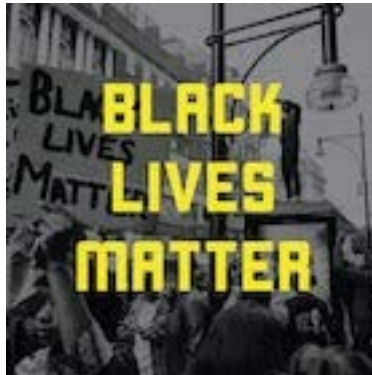
At the same meeting, the Monterey One Board proceeded to vote to NOT certify the Supplemental Environmental Impact Report for the PWM X (again by a one vote majority). This vote would have failed if MCWD had its increased weighted vote. There were no valid reasons given for denial of certification. Their own experts assured the Board that the SEIR met all requirements of CEQA. In addition the Board vote against certifying the SEIR violated its own previous policies on the Expansion. Under threat of legal action, the Monterey One Board, at a later meeting, granted the MCWD request.

The Coastal Commission should be aware that these efforts against PWM X are meant to influence your vote on Cal Am's desalination project. The League urges you to deny the California American desalination project permit because PWM X is the superior project.

LWVMC SUPPORTS CALIFORNIA RACIAL JUSTICE ACT

Responding to a **Call to Action from LWV of California**, we contacted **Senator Anna Caballero** urging her to support **AB 2542 (Kalra), the California Racial Justice Act**. This act asserts civil rights in the courtroom by prohibiting racial discrimination in convictions and sentences: nothing in California law currently says that. In fact, the courts have accepted racial discrimination as "inevitable" and "unfixable," and even called it "harmless error." The California Racial Justice Act rejects those views and seeks to directly confront racism in our criminal courts.



The bill will specifically address: intentional bias directed at the defendant by an attorney, judge, juror, law enforcement officer or expert witness; racially coded language used in court (for example, prosecutors comparing the defendant to an animal in closing argument); racial bias in jury selection; racial disparities in charges in convictions; and racial disparities in sentences.

The California Racial Justice Act will allow a defendant to file a motion at trial or following conviction challenging racial discrimination in their case based on one of these five grounds. If the defendant proves the discrimination occurred, then the case will be sent back for a new trial, or the judge can adjust the charges or sentence in the interest of justice.

AB 3070 (Weber) Anti-Discrimination in Jury Selection

This is a companion bill that further addresses racial bias in jury selection. Prosecutors in

California remove Black and Latinx jurors at disproportionate rates and people continue to be convicted by juries that do not reflect the diversity of this state.

These are some of the reasons given by prosecutors to remove Black and Latinx jurors that courts currently accept as "race-neutral": The juror expressed distrust of law enforcement or the view that law enforcement is racially or economically biased; the juror said they support the Black Lives Matter movement; the juror had been stopped by police and believed it was racial profiling; the juror has a family member who has had contact with the criminal legal system; the juror wore their hair in dreadlocks or braids.

AB 3070 will put in place a new procedure to enforce the prohibition against racial bias in jury selection, using an objective standard to assess racial bias and includes implicit bias. The bill makes presumptively invalid excuses now routinely given by prosecutors to remove Black and Latinx jurors that are clearly implicate racial bias, such as those reasons described above.

Racial bias in our criminal courts denies individuals a fair trial, is an affront to the dignity of the Black, Latinx and other people of color, and harms the integrity of our criminal legal system. AB 2542 and AB 3070 are important bills to advance civil rights in the criminal courts and racial justice in California.

The League of Women Voters Monterey County supports both bills.

★ ★ ★ YOUTH VOTER SERVICES REPORT ★ ★ ★

Our League has been reaching out to high school and college students this fall with information about voter registration, ballot information, voting by mail or in person, and ballot tracking. We have made contacts with many local schools, and used **Zoom** to make presentations.

We have been helping students and teachers be aware of the fact that **16- and 17- year-olds can pre-register to vote**, so that their voter status

becomes official on their 18th birthdays. We have been getting the word out that **young people too can work on voter registration and at the polls**, not just older or retired adults.

If you know of any motivated young people within your circle of family and friends, get them involved with the LWVMC by referring them to, or by contacting, any of us on the Youth Voter Services team or the Board.

At this hectic stage ahead of the November 3rd state and national general election we have so far:

Hartnell Community College, Salinas

Made a presentation via Zoom to the **Associated Student organization** at **Hartnell College** about the LWV, voter registration, sources for voter information, available poll work, all about vote-by-mail, how to check to see if your ballot was counted, and an invitation to serve on **LWV Youth Advisory Committee**.

Monterey Peninsula College, Monterey

We made a similar presentation to the **MPC's Associated Student group**, including pertinent website information.

California State

University Monterey Bay, Marina

After our discussion on Youth Voter issues with **CSUMB's Director of First Year Seminar**, an announcement was made to CSUMB faculty that we were available to make presentations on youth voter issues.

Sharon Miller and **Carol Kaplan** have made three presentations to CSUMB classes so far.

Monterey High School, Monterey

After we contacted them, the **Monterey High's College and Career Counselor** sent messages to students to assess their interest in working with our League. 22 students responded enthusiastically. We followed up with information on how 16- and 17- year-olds could pre-register themselves, how they could help older friends and family register to vote, and additional voter information.

Voices of Monterey Bay, Monterey and Santa Cruz Counties

We contacted **Editor Joe Livernois** of Voices of Monterey Bay to ask for possible volunteers from the **Young Media Voices Project**. **Sharon Miller** conducted phone interviews with two of the young journalists.

LWVMC MEMBER PROFILE: PAMELA STEWART



Pamela Stewart is new to LWVMC, having joined last January, shortly after retiring and moving to this area. She's now become one of our new **Board Members at Large**.



Born and raised in **Manhattan Beach**, Pamela remembers the League chapter there putting on programs before each election that detailed every issue on the ballot. That's what she now says she likes best about the League, *"getting both sides out, informing people about both sides of all the questions."*

Although she belonged to a League chapter briefly during her college years, in the 1970's, Pamela then joined the **U.S. Air Force** and started what she describes as *"bouncing around"* different spots, both in the U.S. and around the world, for the next 30 years.



She finished her undergraduate degree in **Physics** at **East Carolina University** in **Greenville, NC**, and then went on to earn a **master's degree in Aeronautical Science** from **Embry Riddle Aeronautical University**. *"Its main campus is in Daytona Beach, Florida,"* Pamela explains, *"but it has an extension campus on nearly every military base."* Because of her frequent transfers, she studied at several of those campuses while finishing her master's degree.

While serving in the Air Force, Pamela started out in technical intelligence and was then sent to Germany as a munitions/aircraft maintenance officer. *"Then I worked in the U.S. in space acquisition, managing the contractors,"* she says. *"Most of my time in the military was spent in joint assignments. That means I was working with other U.S. agencies and other branches of the service. That gave me a different perspective in life."*

She retired as *"a full bird Colonel"* and then spent several years in civilian jobs. Her last one before retiring was as a contractor working for **NASA Ames** in Mountain View.

Pamela is a licensed **Instructor** and **Air Transport Pilot**, but says that she *"managed that myself,"* not through Air Force training. She has many passions in life, including world travel, skiing, biking, riding a motorcycle, dancing and hiking. She's particularly glad that she moved to her new home in **East Garrison** right before the COVID-19 pandemic hit. She can walk just two blocks to hike in Fort Ord and she loves biking on the beach rec trail.

Unfortunately, because of the current quarantine, Pamela isn't able to follow her usual schedule. *"I love to travel and did a lot of it pre-COVID. I'd be gone two to three months in the fall and another two months in January and February to ski. There are always more places to see and wine and food to taste,"* she says, adding that *"I am so glad I could live here in Monterey Bay if I have to be quarantined."*

Pamela says that her main reason for joining **LWVMC** was *"to offer services to the group that's trying to educate younger people and get them to vote. I'm interested in getting them pre-registered when they get their first driver's license, then registered to vote at 18."*

Her goal of making sure young people vote will likely be a bit harder because of the pandemic, but if there's anything Pamela Stewart learned during her long years in the U.S. military, it's to set a goal and never quit.

We Remember John Pearse



Distinguished scientist **John Pearse** passed away last July. John and his wife **Vicki** were household members of the **LWVMC**. In his long career as a **Marine Biologist**, John touched many lives in many important ways. As **Professor Emeritus of Ecology and Evolutionary Biology at UC Santa Cruz**, he was an inspiring professor who received top honors for his contributions.

For his intellectual excellence, he was honored by being elected **President of the California Academy of Sciences**. Perhaps less obvious than these contributions were his individual impacts on untold numbers of aspiring marine scientists.



In retirement, John founded an educational program for high school students which grew into **LiMPETS** (*Long-term Monitoring Program & Experiential Training for Students*, <https://limpets.org>) a statewide citizen science program focusing on coastal ecosystems. Created in 2002, the LiMPETS Network is a collaborative effort among **Greater Farallones Association**, the **Pacific Grove Museum of Natural History**, and **California's National Marine Sanctuaries**, using student-friendly protocols for monitoring coastal ecosystems, developed with John's and many other scientists and teachers in the field.

As a Pacific Grove resident, he was an active commentator regarding **local coastal land use**.

Many of the tributes at his passing mention his role as a mentor, which is reflected in remembrances by League members:

*"John and his wife Vicki were very involved supporters of **Measure Z**, the successful ballot measure to **ban fracking and new oil wells and phase out aquifer damaging wastewater injection wells and ponds**. I attended two fund raising dinners at their home which they generously opened to us, and I enjoyed far ranging conversations with John. He was a research scientist and teacher AND deeply involved in the environmental community."*
