

#### **LWVNPC Voter Service News**

#### **CANDIDATE FORUMS**

The Voter Service team has been very busy in January with three Candidate Forums. January 17 the candidate forum in Tarpon Springs went very well with Marti Folwell moderating, Becki Snyder and Mary Rao timing, and Gladys Garcia, Arlette Limen, and Beth Hovind assisting.

January 19 the Safety Harbor candidate forum also went smoothly. At that Beth Hovind was moderating, Dusty Walters and Mary Rao timing, and Arlette Limen and Candy Ryan were assisting.

Our next candidate forum is January 31 in Indian Rocks Beach. It will be held at the Art Center on 1515 Bay Palm Blvd starting at 7pm. Beth Hovind is moderating, Arlette Limen and Gladys Garcia are timing, and Kathy Woods-Masalski, Marti Folwell, and Clare Dyer are assisting.

#### From the LWVNPC Education Committee

Let our legislators hear us! That's exactly what the LWVNPC Education Committee intends to do! We will be attending the Pinellas County Legislative Delegation meeting on January 31st and the March Legislative Summit in Tallahassee. Our committee will advocate for: increased transparency of charter school management companies; strict delineation of guidelines for qualifying as an innovative charter school; and adherence to the Florida State statute requiring not for profit charter management companies. We will continue to monitor the State's control of the teacher evaluation system and will work to support the current State Senators supporting equity in the accountability system for public and charter schools.

Our committee members continue to monitor all school board meetings, and workshops. We are currently observing the meetings of the District's Monitoring and Advisory Committee, a court ordered community based group that makes recommendations to the school board concerning issues of equity and diversity.

# Semina in Wareh!

The committee will host Dr. Lewis Brinson, minority achievement officer from the Pinellas County School District, on March 21 at 6:30 p.m. at the Largo Library. Dr Brinson oversees the districts Bridging the Gap program, which has been charged to eliminate or greatly narrow the achievement gap between minority students and non-minority learners. This will be an important meeting for anyone interested in the Pinellas County School District and our students!

### 2017 Legislative Priorities

The League of Women Voters of Florida is a grassroots organization, and as such, we focus on the issues that our members care the most about.

Each year, our membership is polled to see which issues are most important to them. Every local league submits priorities. After tabulating each local league's submissions, the top five areas become priorities for the Legislative Session.

Here are the **2017 Legislative Priorities**:

#### 1. Education

- Restore district authorization to levy 2.0 mills for capital outlay funding for school facilities construction and renovation.
- Increase operational funding to pre-2008 levels so that districts may increase the school day and curriculum choices.
- Revise the sole focus of the state accountability system from test scores to measures that more accurately reflect districts' progress in raising student achievement, meet the needs of diverse students and improve access to high quality academic and career programs for all students.
- Improve fiscal and operational oversight of charter schools by increasing transparency in student admission and retention data, ensuring the independence of charter boards from charter management companies and providing guidelines to reduce self-dealing opportunities in real estate transactions and other charter services.
- Eliminate the growth of corporate-tax credit scholarships to private schools and require private schools currently receiving these scholarships to participate in the state accountability system.

#### 2. Election Law

- Support the automatic restoration of voting rights for former felony offenders, including support for a constitutional amendment to achieve same.
- Support legislation to reduce from 29 days to 19 days the time voter registration books must be closed before each election.
- Support legislation to restrict the ability of an elector to file as a write-in candidate, the goal being to minimize what has become a problem, as "ghost candidates" file in order to close primary elections.
- Monitor and support the progress of online voter registration implementation to ensure that it meets its 2017 deadline, and adopt legislation for Florida to join the at least 26 other states that that are members of the Electronic Registration Information Center (ERIC) " statewide.

- Support legislation necessary for Florida to join the at least 10 other states that are members of the National Popular Vote Interstate Compact (NPVIC), so that Florida's Presidential Electors would be required to award all their votes to the candidate who wins the overall popular vote in the 50 states and District of Columbia.
- Ensure the adoption by Florida of the National Voter Registration Act ("Motor-Voter" law) requirement that every citizen be automatically provided voter registration update services when she/he applies for, renews or changes her/his address on a driver's license or state-issued identification card.

#### 3. Gun Safety

- Support proposals that would expand background checks in Florida, thereby closing the gun show and Internet loopholes.
- Support proposals that would impose a statewide ban on semi-automatic assault weapons and large capacity magazines.
- Oppose any proposals that would make it legal for those with concealed weapons permits to carry firearms on Florida's public college and university campuses.
- Oppose any proposals that would make it legal for those with concealed weapons permits to carry openly firearms in public places.
- Oppose any proposals that would permit Floridians to carry concealed weapons without a permit.
- Oppose any proposals that would expand the current "Stand Your Ground" law.
- Oppose any proposals that would permit Florida School Boards or School Superintendents to designate employees or others to carry concealed firearms, for security purposes, on school grounds at K-12 schools.

#### 4. Health Care

- Correct the Florida KidCare program's coverage so it will provide insurance to children ages 0 to 1-year old who are not eligible for Medicaid.
- Develop legislation to accept 2017 Medicaid expansion dollars for Florida, without being bound for future years, or develop a budget for a comprehensive plan to provide health insurance for working.
- Amend Florida's Public Health statute, Chapter 390, to remove the provision providing that a physician must delay at least 24 hours before terminating, with a pregnant woman's voluntary and informed written consent, her pregnancy.

#### 5. Natural Resources

- Support sustainable energy solutions for Florida, including adoption of renewable energy standards and legislation promoting the expansion of solar energy.
- Support efforts to improve water quality of both surface water and aquifers through legislation to reduce pollution and excessive withdrawals, including prohibiting "fracking" statewide.

• Support full funding of the Florida Forever land acquisition program and proper implementation of the Water and Land Legacy Conservation Amendment (Amendment 1) adopted in 2014.

#### State League Heads Up Coalition to Prevent Gun Violence

"No one is trying to take away your guns. We are just trying to increase gun safety. Too many people are dying from gun violence in the state of Florida."

With these words, Patricia Brigham, Vice President of the Florida League of Women Voters and leader of the Coalition to Prevent Gun Violence for the Florida League of Women Voters, held a joint session with the LWVPC and the Osher Lifelong Learning Institute (OLLI) on January 19, 2017. This was the first in what is hoped to become a regular cooperation between the two groups.



Formed after the Pulse massacre in Orlando, the Coalition is seeking two goals in the 2017 legislative session in an effort to prevent gun crimes, injuries and deaths: 1) a state ban on all semiautomatic assault weapons and large capacity feeding devices, and 2) comprehensive and universal background checks before a gun purchase can occur. Patricia explained that semiassault weapons allow for mass killings within a short period of time, such as what occurred at the Pulse nightclub.

Brigham stated that Florida has the highest number of mass shootings in the country. Florida rates among the top in the U.S. with 1.7 million concealed gun permits. 92% of Americans support background checks – because they do make a difference, but 22% of gun sales go unchecked due to loopholes. This means there is no checking of criminal records or mental health records to determine potentially dangerous gun purchasers.



The Coalition now has over 100 member organizations and is working with their legislators to promote these goals. Unfortunately, new legislation is being offered to increase gun use. Bills to allow guns on campuses, in airport terminals and government buildings are all being introduced this session as are bills to put the onus of Stand Your Ground claims on the prosecution instead of on the shooter. Patricia encouraged League members to watch closely new legislative attempts that

will reduce gun safety and to contact legislators in support of legislation to increase gun safety. Brigham's motto: "No campus carry, no open carry, and no stand your ground."


