### From the LWVNPC Education Committee

The Education Committee meets monthly and has been discussing educational needs in the Pinellas County School District. Since our study of charter schools three years ago, we continue to be interested in the operation of those in our county and we will be conducting some research on them in the coming months. We attempt to have at least one member of the committee at school board meetings.

We know we can learn from others and have reached out to some knowledgeable persons. This month we will be meeting on January 14, 2016 with Pat Hall LWV of the Hillsborough County. She has done extensive studies of charter schools and we look forward to information she will share with us.

In March we are excited that the Chairperson of the Education Committee of LWV Florida, Sue Legg, will be speaking to our League on the 19th. Sue maintains the lwveducation.com blog and provides multiple resources there to help folks know what is going on in education not only in Florida but around the country as well. In March she will be the main speaker for the LWVNPC meeting and it is hoped that not only League members will attend but that community members will also. Please spread the word that she is coming. There will be more information about that in the February Voter.

All of us need to be vigilant about legislation that is being considered in the State Legislature. Sue's blog often has information as does also the website of the State League. (http://thefloridavoter.org/) Be sure to look at page 5 of this Voter.

### 2016 Florida Legislative Session

It is hard to believe that 2016 Legislative Session will begin on January 12, 2016. If you haven't been paying attention, here are some proposed bills that are making their way through the committee process. These are just some of the issues that the League will be following during the session:

### **Education**

<u>SB 830:</u> The bill appears to be similar to other states' takeover of public school's measures. The relevant section of the bill is "High Impact Charter School Network". It targets 'D' or 'F' public schools.

- a. It eliminates provisions for districts to modify charter contracts for charters with grades of 'C' or below.
- b. It allows the State Board of Education to grant charters directly for the new network and bypass the local school board authorization process. Districts would not have oversight and could not collect current administrative oversight fees.

<u>\$\$B\ 808</u>: The bill would redefine school districts and local school boards. Cities could form their own school districts or combine with contiguous areas and create their own partisan school boards. The new districts could use their own city or county commissions as school boards. This could be a means for northern Pinellas to separate from southern Pinellas where the notorious 'Faiing Factories' are located. The status of this bill is uncertain.

<u>SB 434</u>: The bill is called the Principal's Autonomy Pilot Program Initiative. It would require participating public schools to participate in the University of Virginia School Turn Around Program. This bill needs further scrutiny.

**HUR 759:** The bill would allow the Department of Education to establish a statewide system for approving charter schools. Currently, school districts authorize charter schools and the State Board of Education can over-rule school board decisions.

<u>PCB-CIS 1601:</u> This is a rework of prior bills to create the Florida Charter School Institute which is designed to reduce local district charter authorizing authority. In addition, it creates a high impact charter district and changes charter board requirements. This is a bill that revives state vs. district control concern over charter school authorization.

### Fracturing aka Fracking

HB 191: Among other things this bill preempts to the state the ability to regulate any activity related to oil and gas exploration, development, production, processing, storage and transportation. In addition, it voids any county, municipality or other political subdivision's ordinance or regulation (except for zoning ordinances passed before January 1, 2015), related to oil and gas exploration, development, production, processing, storage, and transportation.

**SB 166:** This bill and its companion in the House, **HB19**, would define the terms "hydraulic fracturing" and "well stimulation treatment" and prohibit a person from engaging in hydraulic fracturing or performing well stimulation treatments in Florida or the waters adjacent to Florida. It would also prohibit a person from disposing of related materials and byproducts of hydraulic fracturing or well stimulation treatments, etc. These bills have not been heard in any committees.

#### **Guns**

**HB 4001**: Campus Carry. Passed all of the House committees. It's now poised to go to the floor when session begins in January. (continued next page)

**SB 68:** Its companion in the Senate is now in the Judiciary Committee but not yet on calendar to be heard. **HB 163:** Open Carry. Has passed two House committees. Now in Judiciary. Not yet on calendar for a hearing in that committee.

**SB 300:** Companion bill in Senate has passed one committee. Next up: Judiciary and Rules though date of those hearings has not yet been determined.

For our newer members, during the session which runs 60 days, the League's lobbyist provides a weekly update, usually on Friday, recapping what has transpired during the week with updates on the state League's priority issues. One way in which you can help, is to respond to "Action Alerts" which are issued by the state League. The Alerts ask member to contact their legislators and request either their support or non-support of an issue. Please respond when you receive an Alert! ### Remember these priorities we shared in November:

### **LWVF 2016 Legislative Priorities**

### 1. Election Law:

- a. Oppose any efforts that might be made to limit convenient voter registration or to limit access to the polls by limiting early voting locations, days or hours.
- b. Support pre-paid absentee ballot returns to the Supervisors of Election and oppose any infringement or restrictions on the absentee ballot process.
- c. Monitor, consider and comment on proposals to establish an independent Florida election redistricting commission.

### 2. Education:

- a. Oppose efforts to expand corporate tax credit scholarships. We continue to believe they are an inappropriate and unconstitutional program, funding private and religious schools with no proven benefit to students.
- b. Require greater fiscal management and accountability of charter school contracts, with over sight by local school boards.
- c. Address proposals to change the statewide assessment program to assure that a national assessment instrument is used, with such assessments applicable to every Florida student educated with public funds and reported at appropriate intervals related to children's educational cognitive development.

### 3. Health Care:

- a. Expand health care access and coverage for low-income, uninsured and underinsured Floridians.
- b. Accept federal funding to expand health care access and coverage and offset the costs of uncompensated care to hospitals and providers.

c. Address proposals to change the statewide assessment program to assure that a national assessment instrument is used, with such assessments applicable to every Florida student educated with public funds and reported at appropriate intervals related to children's educational cognitive development.

### 4. Gun Safety:

a Oppose Bills (HB 4001/SB 68) that would make it legal for those with concealed weapons permits to carry firearms on all Florida public college and university campuses.



b. Oppose Bills (HB 19/SB 180) that would allow Florida School Boards and

Superintendents to designate employees to carry concealed firearms, for security purposes, on school grounds at K-12 schools.

c. Oppose Bills (HB 41/SB 130) that would purport to regulate the recreational discharge of firearms in residential areas. It is already illegal to discharge recklessly a firearm on any residential lot, and such Bills would create exceptions to that.

### 5. Land and Water:

- a. Properly implement Amendment 1 restore funding to Florida Forever and exclude existing agency operating expenses.
- b. Pass comprehensive water quality and quantity Bills that concentrate on cleaning up pollution at the sources and conserving our aquifer with no net additional withdrawals.
- c. Pass Bills that ban fracking in the state of Florida.
