By-Laws Change

ARTICLE VI – FINANCIAL ADMINISTRATION

Section 2. Dues. Annual dues shall be set at the Annual Meeting.

Members joining on or after April 28, 2018, shall have anniversary billing, and their dues shall be payable on or before their yearly anniversary date.

Dues for previous members shall continue to be due and payable on or before May first, with the exception of those who joined between February 1, 2018, and April 27, 2018, whose first renewal date shall not be until May 1, 2019.

Any member whose dues have not been received by August first shall be dropped from membership with the consent of the Board of Directors. Membership will alert the Board of expiring memberships two (2) months following due date. Any member whose dues have not been received within three (3) months of their due date shall be dropped from membership.

Expired members rejoining will receive a new anniversary date.

When two or more members reside at the same address, full payment of dues shall be made for the first member; a payment equal to one-half the annual dues payment shall be made for each additional member. <u>Dues for Cornerstone</u> <u>Members shall be twice the annual dues</u>.

If the League of Women Voters of Florida or the League of Women Voters of the United States should <u>change increase</u> the per member payment, the dues of the League of Women Voters of North Pinellas County shall be <u>changed increased</u> to reflect the <u>change increase</u> at the time it becomes effective. <u>Dues for Cornerstone Members shall be twice the annual dues.</u>

DUNEDIN — Perhaps the city's most recognizable landmark building is scheduled to reopen as a boutique hotel in September.

Mainsail Lodging & Development is planning to reopen the Fenway Hotel, which has been undergoing renovations since 2016, according to a news release.

The restored hotel, which will feature a rooftop bar as well as 83 guest rooms and suites, will now be a member of the Marriott International Autograph Collection, a chain of luxury hotels.

The Fenway Hotel first opened in 1927 at 453 Edgewater Drive and became a hub for jazz, artists, politicians and musicians. The hotel also housed Pinellas County's first radio station on its roof in 1925. The building has been undergoing renovations since 2016.

"The unique history of Fenway Hotel and the community of Dunedin inspired our vision for the property," Joe Collier, president of Mainsail Lodging & Development, said in the release. "The new Fenway will bring together touches of the past in a modern setting, giving new life to the hotel and restoring a piece of the destination's charming, offbeat character."

Other announced features include a resort-style pool; "extensive dining options;" the HEW Parlor & Chophouse; an open kitchen bar and a "Hi-Fi Rooftop Bar" where guests can see the Honeymoon and Caladesi islands; and roughly 10,000 square feet of indoor and outdoor event space.

Guests will also be able to use it's "expansive" front lawn for croquet, badminton and special events, according to the release. In addition, the hotel's public areas will eventually be used for live entertainment "as a nod to the hotel's musical past.
