

Katie Fahey is Executive Director of The People, an organization committed to sharing the lessons learned in Michigan when she was the Founder/Director of Voters Not Politicians that took on gerrymandering.



VNP facilitated the passage of a Michigan Constitutional Amendment regarding redistricting.

Ms. Fahey reaches out to voters across the ideological spectrum, bridging political divides and supporting nonpartisan good governance reforms nationwide.



# (2) LWVOA's Annual Meeting & Luncheon will feature speaker Barbara McQuade on Wednesday, May 15, 2024, at 10a at the Heathers Club of Bloomfield

Barbara McQuade's extensive legal career included serving as the US Attorney for the Eastern District of Michigan from 2010-2017. Ms. McQuade now is a professor of Law at the University of Michigan, a legal analyst for NBC

News and MSNBC, and recently authored the book "Attack from Within: How Disinformation is Sabotaging America".

Her presentation will include identifying and combatting disinformation.

## Michigan women accomplishing great things:

**Sarah Elizabeth Ray** (1921–2006) was an African American civil rights activist who, in 1945, was denied entry on SS *Columbia*, a ferry operated by the Bob-Lo Excursion



Company. She initiated a legal battle against the company via the NAACP which eventually ended up being processed by the United States Supreme Court. The court ruled in Ray's favor, setting her case as a precursor to *Brown v. Board of Education*. After the *Bob-Lo Co. vs. Michigan* court case, she went on to create the Action House in Detroit which helped to empower Black youth in the city and offered spaces for recreational activities.



#### In memory of Kathy Henry

LWVOA member, Kathy Henry, age 58, passed away on February 20, 2024, after a 17-month battle with cancer. Kathy is survived by her spouse, Karen Hager, and her two sons.

Kathy was an energetic member since 2016, organizing presentations, attending committee meetings, and encouraging active participation. One of her many accomplishments was organizing the Observer Corps where members monitor local school board meetings. After creating an informative tutorial video, Kathy recruited members to help with this important effort.

A celebration of Kathy's life will be held in the spring at the Northwest Unitarian Universalist Church.
