

Judge Rosen will discuss The Detroit Grand
Bargain - a Tale of Rebirth Following
Turbulent Times

As the chief mediator in the largest municipal bankruptcy in American history and architect of the "Grand Bargain"




that saved the Detroit Institute of Art's priceless collection—Judge Rosen will discuss the dramatic inside story of how Detroit was rescued from the brink of oblivion. Judge Rosen is also able to share perspectives on the current state of the judicial system. The presentation is open to the public and will include questions and answers.

Judge Rosen is the author of the new book, *Grand Bargain*. He served as a federal judge on the Eastern District of Michigan court for almost 27 years, including seven as its chief judge. He served as an adjunct law professor and coauthored two widely read law books. He

is a frequent lecturer – both domestically and internationally – on a variety of topics. He currently works with JAMS, the largest mediation, arbitration, and other alternative dispute resolution services provider.


### (4) LWVUS Eliminate the Electoral College work group: Friday, May 16th at 1p via Zoom

Monthly presentations provide information about the necessity of abolishing the Electoral College by US Constitutional Amendment, which is now one of the League's top priorities. Speakers have

provided in-depth analysis of current issues with the Electoral College and the history of facilitating change.

This month's presenter will be Professor Wilfred U. Codrington III, the Walter Floersheimer Professor of Constitutional Law and co-director of the Floersheimer Center for Constitutional Democracy at Benjamin N. Cardozo School of Law, New York, and Fellow of the Brennan Center for Justice. He co-authored, with John F. Kowal, Vice President for programs at the Brennan Center for Justice at NYU School of Law, *The People's Constitution: 200 Years, 27 Amendments, and the Promise of a More Perfect Union*, The New Press, 2021.
