## **End Gerrymandering: Focus on the NYS Capital District**

The Albany, Rensselaer, Saratoga and Schenectady chapters of the League of Women Voters in coordination with the One Person, One Vote Coalition will hold an educational session on the upcoming redistricting of the state's congressional and legislative districts. This one hour virtual program will take place on August 19 at 7 p.m. It is open to all organizations and individuals who are interested in participating in an effort to have district lines drawn consistent with communities of interest above partisan interests. Political Scientist and League member, Steve Elliott, will be the key presenter.

"We are offering this program in an effort to encourage and increase public participation as their districting process goes forward. It is an opportunity for all who seek fair districts to learn how to be an effective advocate on behalf of their interests," said Vicente Alfonso, Vice President of the Albany Hispanic Chamber of Commerce. #### POLL WORKERS NEEDED IN SCHENECTADY COUNTY

The Schenectady County Board of Election is currently seeking friendly, reliable, and detail orientated people to serve as Poll Workers for future elections. Poll workers are responsible for performing a variety of tasks including: signing in voters, assisting voters, and documenting information on appropriate forms. Bilingual individuals, speaking fluent English and Spanish, are also needed and encouraged to apply.

In order to serve as a poll worker you must be a registered voter, resident of Schenectady County and attend a two to three hour annual certification training. Poll workers are paid: \$35 for training and \$210 for an full Election day (Hours are 5am-9:30pm).
