Letter from the President – March 2022

Dear LWVSC Friends.

This evening – March 1 – will be President Biden's first State of the Union address. After reading various news sources commenting on what topics the President will include in his speech, I wondered how those topics would synch with some of the League of Women Voters' major positions.

Certainly, President Biden will speak about the recent Russian invasion of the democratic republic of Ukraine. Crossing Ukraine's borders was presented as a "peace-keeping" mission, but soon became a full-fledged war, and has since targeted innocent civilians and created a serious refugee crisis. LWV has a lengthy position on International Relations that includes support of the United Nations; arms control measures that would reduce the risk of war and prohibit the use of nuclear weapons; membership in treaty organizations such as NATO; and the use of preventive diplomacy.

Climate change initiatives were one of Biden's major campaign promises, and LWV has taken a significant position on the endangered climate as well. Since the 1960's the LWV has worked for the passing of the Clean Air Act, the Clean Water Act, Resource Conservation and Recovery Act, and various regulatory programs.

The pandemic will likely be another topic in the State of the Union Address. In the past two years, Biden's administration has ensured that workers, families, and businesses hit hard by the pandemic would have federal financial support. Based on current science, vaccines were developed to protect against the virus. The LWV has strong positions on both health care and employment protections, especially for the most vulnerable populations.

As I mentioned in my last Bulletin Letter, the League is still waiting for the passage of the Voting Rights Act and the Equal Rights Amendment. These issues are the very basis of the LWV mission and goals, but political wrangling has prevented their passage. The State of the Union Address would be the perfect place to remind Congress and the American people about their importance.

LWVSC concurred with the national league's position "Campaign to make democracy work" and also with healthcare and digital equity positions. (Report due March 1, 2022). Two remaining positions, voting for incarcerated people and election administrative structure, will be discussed separately since the report is not due until May 1, 2022.

The following policies were briefly explained:

Cheryl Nechamen explained that the The League of Women Voters is a *nonpartisan* citizen activist organization that operates at the local, state, and national level. It influences public policy through education and advocacy. We never support or oppose any political party or candidate. The League of Women Voters has two separate and distinct roles.

Diversity, Equity and Inclusion Policy- Sandra McGarraugh

Taking Action- Ann Hatke After studying an issue, we use the League's positions to advocate for or against particular policies in the public interest.

Please note the following changes to our positions:

Local Government- add the SMHA (Schenectady Municipal Housing Authority) to entities to be monitored (Joan Elliot offered to attend eviction proceedings)

Local Education- Ensure school districts are adequately prepared and staffed for **relevant** education Environmental Issues- add emergency to global climate change

Health Services- add the following position: educate the public about the Ellis/St. Peter's merger and its impact on end of life procedures.

Women's History Month Carrie Chapman Catt and Ida B. Wells

Originally, the LWV organization began at the National American Women Suffrage Association's 50th convention in St. Louis, Missouri, when President Carrie Chapman Catt proposed the creation of a "league of women voters to finish the fight and aid in the reconstruction of the nation." One year later, on February 14, 1920 - the League was officially created in Chicago, Illinois. da B. Wells-Barnett was a prominent journalist, activist, and researcher, in the late 19 th and early 20th centuries. In her lifetime, she battled sexism, racism, and violence. As a skilled writer, Wells-Barnett also used her skills as a journalist to shed light on the conditions of African Americans throughout the South, including civil rights and women's suffrage. Although she was in Niagara Falls for the founding of the National Association for the Advancement of Colored People (NAACP), her name is not mentioned as an official founder. Late in her career Wells-Barnett focused on urban reform in the growing city of Chicago. She died on March 25,1925
