# SUMMARY OF PUBLIC POLICY POSITIONS LWVNYS 2019-2020

#### **ELECTION LAW**

**UNDER LWVUS POSITIONS Support** of measures to protect, extend and encourage the use of the franchise, including paperless and Election Day registration, no-excuse absentee and in-person early voting. Restore integrity to the election process – specifically support for uniformity in election laws and procedures in their implementation and enforcement; promote measures that ensure the integrity of all ballots; support ballot access and fair campaign practices.

Support comprehensive campaign finance reform, including public financing of campaigns.

Opposition to term limits for members of the NYS Legislature.

Opposition to term limits for NYS statewide elected officials.

Support the continuation of Fusion Voting in New York State whether or not Wilson-Pakula is repealed.

#### GOVERNMENT

UNDER LWVUS POSITIONS Support of citizen rights, including reproductive rights.

Support of effective regulation of lobbying and ethics.

Support of standards to ensure equitable representation in the State legislature and Congress.

*Support* for staggered four year terms for both houses and the limiting of outside income for legislators, preferably on the federal model using a percentage of base income.

*Support* of improved measures to provide representation for legislative districts in case of a vacancy. *Support* of responsive and responsible legislative processes which increase the role of the individual member and the committee system.

*Support* of procedural reforms in the constitutional convention process to promote openness and nonpartisanship.

*Support* of the consolidation of government/shared services when it promotes effective and efficient operation of government.

#### HEALTH CARE

*Support* of measures to assure a basic level of quality physical and mental health care, including regulatory incentives to encourage development of cost-effective alternative methods of delivery; funding for health promotion and disease prevention programs; provisions for effective citizen participation in health policy decisions.

*Support* of measures that enable individuals to assume responsibility for their own health and to participate in decisions, including extraordinary life-extending procedures.

*Support* for uniform eligibility and coverage of basic health care costs through public financing with single payer concept as an acceptable approach to implementing League positions on equitable access and cost containment.

Support for the option of medical aid in dying for the terminally ill.

#### JUDICIAL

*Support* of a unified state court system with improved provisions for judicial selection. *Support* of statewide guidelines for law enforcement at all levels to prevent racial and economic profiling.

*Support* of measures to improve pretrial procedures in the criminal courts. *Support* of measures to promote a fair and efficient jury system.

*Support* the rights of indigent defendants to representation at public expense.

Support of alternatives to incarceration.

**Opposition** to the death penalty, with life without parole as the primary alternative.

#### NATURAL RESOURCES

**UNDER LWVUS POSITIONS Support** for protection and management of New York's natural resources in the public interest, including energy conservation and energy options from

renewable sources.

*Support* for measures to achieve watershed protection including limiting pesticide use and applying Best Management Practices.

Support for a state-established, intergovernmental system for land resource management.

*Support* for a proactive role for New York State in regional land use planning, containing urban sprawl and protecting sensitive areas.

*Support* of reconditioning of the New York State Erie/Barge Canal System and its development for recreational uses.

*Support* for preserving and enhancing the environmental integrity and quality of the Great Lakes-St. Lawrence River Ecosystem.

#### SOCIAL POLICY

**UNDER LWVUS POSITIONS Support** for equality of opportunity, meeting basic human needs, childcare, energy-efficient and environmentally sound public transit, and gun control.

*Support* measures to meet the needs for affordable and accessible housing through use of state funds and incentives to localities

Support of a livable wage for all localities in New York State

#### STATE FINANCES

*Support* reforms for greater equity in education financing (K-12) for both pupils and taxpayers.

*Support* raising funds to provide New York's children with a sound basic education through increases in the New York State personal income tax, implemented in a progressive fashion.

*Support* for the replacement of the existing local residential property tax relief programs in which relief goes to all with programs based on need, with annual cost of living adjustment.

*Oppose* in principle the use of public funds to support non-public schools (K-12).

*Oppose* any increase in the maximum number of charter schools without improvements to the Charter School Act.

*Support* the funding of public higher education and the existing formula for financing the community system, 1/3 tuition, 1/3 state aid, and 1/3 county support.

Support a uniform equitable assessment and property tax system.

*Support* of measures to provide for openness and accountability in the operation of the New York State public authority system.

*Support* of a timely and responsive state budget.

#### WOMEN'S ISSUES

*Support* of measures that hold marriage to be an economic partnership with a presumption of equality between the spouses.

**Opposition** to measures that contain a presumption of joint custody of the children.

*Support* for equity in employment laws and practices and equal pay for jobs of comparable worth. *Support* of measures to reduce the incidence and effects of domestic violence.

# LWVSC Local Program 2020-2021

#### Justice and the Law

Support improvements to the local criminal justice system by:

- \* monitoring and strengthening the Probation and Parole procedures, with an emphasis on rehabilitation and supportive services with programs such as the Ex-Offender Re-Entry Program in Schenectady County.
- \* facilitating the implementation of alternative courts (problem solving courts) in Schenectady County and promoting collaborations to support them.
- \* monitoring the juvenile justice system including Family Court and promoting community-based rehabilitation.
- \* supporting restorative justice programs such as the Community Accountability Board.
- improve accessibility to police complaint procedure
- Improved Mental Health Crisis Intervention

#### Local Government

- \* Monitor activities of county governmental units, including town boards, the Schenectady City Council and the Schenectady County Legislature, monitor activities of other quasi-governmental units, public authorities and agencies such as Metroplex, IDAs and Planning Boards, monitor activities of elected public Boards of Education.
- \* Support standards of high professional qualifications and political nonpartisanship in manager form of government.
- \* Evaluate opportunities for inter-municipal cooperation and examine options for the consolidation of governmental services in Schenectady County.

#### **Children at Risk**

\* Collaborate with other organizations to identify the needs of children in Schenectady County, facilitate programs on their behalf and educate the community about their needs and challenges.

\* Study early childhood education and caregiving needs in Schenectady County from a policy and financing perspective.

#### **Local Education**

\* Monitor local initiatives related to schools and promote and advocate adequate and equitable funding for all school districts so the students can reach their potential.

#### **Environmental Issues**

Support the protection of environmental resources, land, water and air in Schenectady County:

- \* Âdvocate for the protection of water resources in the County.
- \* Promote understanding of global climate change and support efforts to mitigate its effects.
- \* Support energy conservation and development of renewable energy alternatives.
- \* Support solid waste management programs that increase reuse and recycling in the County and City.

#### **Health Services**

- \* Educate and advocate for national/state/local health care reform that provides quality physical and mental health care for all citizens.
- \* Encourage and support countywide comprehensive health care planning and access, equity, and safety in health care.

# **Diversity and Equity**

February is Black History Month, and the history of Africans in the United States is American history. This month the DEI Spotlight is on the following excerpts from **"The Untold Story of Women of Color in the League of Women Voters"**, by Carolyn Jefferson Jenkins.

"My dream for this organization that has such promise is that in its next one hundred years, it will recognize the value of all people in reality and not just in rhetoric, in value not just voice (using visuals and symbols), in beliefs not just benefits, with no quotas, no stereotypes, no double standards and without the residue of race! My hope is that it will be an organization that is true to its principles and ideals ...."

"The League of Women Voters of the United States is at a crossroads. At a time when the fundamental tenets of a democratic nation are being challenged, there is no time for the organization to retreat. Leaguers can be the architects of a vision that moves the organization forward, truly becoming an inclusive "everywomans" organization by honoring all of its members and moving the accomplishments of women of color past, present, and future out of the footnotes and into the main narrative. The actions the league takes must not be crisis but by design. This is our opportunity to get it right!"

#### LWVNYS DEI Task Force: recent discussions included the following:

- Ways in which a "DEI lens" had been applied by local Leagues to their GOTV activities. (i.e., partnerships with Operation PUSH and NAACP, lawn signs, bus signage.
- Beginning to identify how to include Organizational Equity as part of our LWVNYS Strategic Plan. To do that, we have to understand the differences between the standard objectives of Equality versus today's goals as relate to Equity.
- Confirmation that local Leagues that have not yet started to adopt the LWVUS DEI Policy, and placed it in visible locations, do need to begin.
- **DEI** Assessment Survey: As of January, the State League has joined the ranks of the local Leagues represented on the Task Force who have completed a DEI Assessment Survey. The results will be aggregated shortly for the Task Force to disseminate.

# League Testifies at Education Finance Meeting

This week, the League's Education Financing Specialist, Marian Bott, testified before the Joint Budget Committees on Elementary Education. Marian recommended that the state seek to adjust factors in Title I funding to allow schools greater access to receive these funds. Title I provides federal funds to schools with high percentages of low-income students. These funds pay for extra educational services to help at-risk students achieve and succeed regardless of any disadvantages through no fault of their own. How much funding a school gets is determined by a formula used to measure poverty.

The testimony also discussed education of homeless children, school tax relief, local district funding adjustments, NYC fiscal stabilization grant, elimination of NYC charter facilities aid, and the Smart Schools Bond Act. You can read Marian's full testimony at https://files.constantcontact.com/

# **Redistricting Commission Meets to Discuss Funding**

This week the Independent Redistricting Commission met to discuss their ongoing funding needs and newly released timeline for the release of census data. The Co-Executive Directors reported that the negotiation of contracts between the Department of State and SUNY Research Foundation was ongoing. The Commission has not been involved in the drafting of the contract and SUNY research will get 10% of this appropriation and \$250,000 will be set aside for legal fees meaning the Commission will only be eligible for \$750,000. The Co-Executive Directors said that SUNY will be involved in any contracting of vendors and that all employees would be employees of SUNY Research rather than employees of the state.

The continued delay in funding has halted the Commission from having access to the U.S. Census Bureau's Topologically Integrated Geographic Encoding and Referencing (TIGER) data, the backbone of the map-making process, because it has no funds for computers or staff.

The Commissioners discussed issuing a letter to Governor Cuomo urging him to release the funding immediately. Several Commissioners had drafted a letter to the Governor's office before the meeting. The remaining Commissioners requested the opportunity to propose edits before sending it to the Governor's office. The Commission made edits during the live webcast and agreed to have the Co-Executive Directors send the letter to the Governor, Budget Director, State Attorney General, US Attorney General, and legislative leaders.

The next meeting was scheduled for Feb 19th at 10:00 am.
