Is It Time To Review Closed Primary Elections?

Most state and federal primary elections in the U.S are divided up by political party and many are only open to voters who are members of a party. However, in the last 25 years independents (voters who have chosen not to align with a political party) are the largest and fastest group of voters in the country. Over 50% of young people do not register in a political party. Onondaga County Board of Elections statistics dated November 2023 show that there were 87,231 voters not



registered in a political party out of a total of 306,077 registered voters. That shows that over 87,000 will be unable to vote in the Presidential Primary.

In 15 states (including New York) and the District of Columbia, at least one political party conducts closed primaries, while states with open primaries (or some variation of an open primary) allow cross over voting. To vote in a closed primary you must be registered in that party. An example would be if you are enrolled as a democrat, you cannot vote in a republican or other party primary. If you are registered as an independent, you lose your right to vote. Experts and advocates say this electoral process that excludes voters has led to more extreme candidates and a polarization problem in U.S primaries.

As we approach the 2024 election, there is movement in many closed primary states to open the process so all registered voters can participate. However, they are running against opposition from party leaders and partisans who think only party leaders should choose their candidates for the general election.

The League's History Sponsoring Presidential Debates

With presidential debates coming soon, it's worth remembering an important moment in history -

"In 1988, the League of Women Voters of the USA ended its role as the sponsor of presidential debates because it has no intention of being an accessory to the hoodwinking of the American public."

The League of Women Voters had hosted candidate debates at the local and state level since its founding in 1920. In 1976, they sponsored the first ever televised, nonpartisan debate between presidential candidates Ronald Reagan and Walter Mondale. The debate allowed Americans across the country to see two candidates side by side for the first time, addressing the same issues in a nonpartisan setting. The league received an Emmy award for Outstanding Achievement in Broadcast Journalism for sponsoring the debate. The League went on to sponsor presidential debates in 1980 and 1984.

As campaigns became more and more image-driven and scripted, the chairpersons of the Democratic and Republican parties announced their intention to sponsor their own debates. The League was explicit in its opposition to this move. How could an organization set up by political parties offer an unbiased, nonpartisan forum for debate?

The League moved forward with its own plans for a nonpartisan debate. In September representatives from the Bush and Dukakis campaigns presented the League with an agreement that gave the campaigns the power to:

- Pack the debate hall with their own supporters and relegate press to the back two rows
- Control the selection of the people who asked candidates questions during the debate
- Determine the debate format
- Restrict what the television cameras could take pictures of during the debate

In response, on October 3, 1988, the League withdrew its sponsorship of the presidential debate.

NEW YORK STATE PUBLIC CAMPAIGN FINANCING PROGRAM

The New York State Public Campaign Financing Commission approved in 2020, is now in effect for candidates seeking legislative office in 2024 and statewide office in 2026. For statewide candidates crom an individual donor over the course of an election cycle. Now statewide candidates can only except \$18,000 per donor.

For senate candidates the limit is \$10,000 and for assembly candidates it is \$6,000. Under the new system, candidates who receive donations between \$5.00 and \$250.000 qualify for matching funds if donors do not give a \$1.00 more in the same election cycle.

Candidates do need to qualify to participate by demonstrating they have enough support to be viable candidates. Candidates must also raise a certain amount of matchable funds from enough New Yorkers in their district to become eligible for public money.

The program should also provide an opportunity for more citizens to run for office.

. Let's hope it works!



NYS CONGRESIONAL REDISTRICTING UPDATE

The NYS Congressional Redistricting Saga continues. In December 2024 the New York State Court of Appeals ruled that the congressional maps used during the 2022 congressional election were temporary. The Court ordered New York's Independent Redistricting Commission (IRC) to submit new maps to the state legislature by February 28, 2024. The IRC released its latest proposal on February 15, 2024.

On February 27th, after returning from winter break, the legislature voted to reject the proposal. According to the NYS Constitution, the legislature, with the approval of the governor, gets to draw the congressional lines.

The IRC map proposal is now in the hands of the state legislature whose members can approve the plan or draw its own lines. The vote is planned for February 29th. If approved by the democratic majority in both the Senate and the Assembly, it will be sent to the governor for her approval.

What does this mean for Onondaga County voters? The 22nd Congressional District appears the same as the plan submitted by the IRC.

Will it end here? Republicans still have the potential to file a legal challenge against the plan.

REVIEWING OUR CURRENT LWVUS POSITIONS

Every two years prior to the League's national convention members are asked to review LWVUS present positions and recommend changes or add new positions to be acted on at convention. The goal of the LWVUS Program Planning process is to achieve collective agreement around how Leagues will move our mission forward for the next two years.

As apart of the process, Leagues are also asked to share information on how their work will impact the Campaign for Making Democracy Work.

The group also agreed to support a concurrence request from the Vermont League of Women Voters that would update the LWVUS Privatization Position to include "Healthcare" as a public good.

A concurrence from the Washington State League was also approved. With the loss of dozens of weekly newspapers across the country in the last several years, the LWVWA commenced a two year study that reached consensus by its members that it is the responsibility of the government to provide support for conditions under which credible local journalism can survive and thrive.

The Syracuse LWV will also include a question on why the LWVUS position to abolish the Electoral College was not focusing on the National Popular Vote Interstate Compact that would call for states to reward their electoral votes to the winner of the national popular vote once enough states join the agreement.
