However, some of them have dropped out but did not do so before the ballots were printed. Therefore, if you vote as a Democrat, you may want to check to see who is still in the running before marking your ballot. In addition, some suggest that waiting to vote until after Super Tuesday on March 3 might be worthwhile. The top two candidates from the Republican and Democratic parties will then move on to the General Election on November 3, as will the non-presidential candidates from the August 4 Primary. Letter to the Editor Marilyn Perkins and Bree Bowen

This letter appeared in the February 26, 2020 issue of the Tri-City Herald.

2020 marks the 100th anniversary of women gaining the right to vote with the passage of the 19th Amendment, championed by the women's suffrage movement. This year we also celebrate the 100th anniversary of the League of Women Voters (LWV).

LWV is a direct result of 70 years of hard work by different women's groups. A similar organization was first proposed in 1909, by 'The Mother of Women's Suffrage' Emma Smith DeVoe from Tacoma. However, it would be another decade before the LWV was formally proposed at the National American Woman Suffrage Association in St. Louis. It was officially founded at the next convention in Chicago on February 14, 1920, six months before the 19th amendment would be ratified and signed into law.

The League is proud to be nonpartisan, neither supporting nor opposing candidates or political parties at any level of government, but always working on vital issues of concern to members and the public. If you (man or woman) believe in empowering voters, defending democracy, and envision a country where everyone has the desire, right, knowledge, and confidence to participate, contact the League of Women Voters of Benton and Franklin Counties at https://my.lwv.org/washington/benton-franklin-counties to join or ask questions.

2020 Legislative Session Update

March 12 is the last day of this session. February 28 was the deadline to pass bills out of the **policy** committees. The bill we hoped would pass, **SB 6610- Eliminating Advisory Votes**, didn't make it out of committee so is dead.

Bills will have until March 2 to pass out of House fiscal committees, Senate Ways & Means and Transportation committees. Senator Sharon Brown is on the Ways and Means Committee.

The LWVWA would like your help to pass **SHB 2575- Modernizing the Redistricting Commission**. If you support this bill, please alert our senators. You can tell them "you believe in increasing access to democracy, transparency in government processes, and maximizing people's ability to give input to the Washington State Redistricting Commission." Don't forget to add your own story of why access to democracy is important to you. Another bill you may want to speak up for is **ESSB 5323- Banning single-use thin plastic grocery carryout bags**, which clog recycling equipment and pollute our waterways as they break down. Grocery companies, recyclers, and trade organizations support this bill because it makes the regulations uniform across the state.
