**Everyone take note, please!** The Health Interest Committee will give another of their outstanding, not-to-be-missed talks, this time on Advanced Directives. They will present to the Carlsbad Unit on March 15<sup>th</sup> and the San Dieguito Unit on March 22<sup>nd</sup>.

Advanced Directives are written instructions to your chosen agents as to what medical care you wish to have, or not have, when you no longer can speak for yourself. There will be paper samples for everyone to examine--and a resource page for everyone to take home. The resource page has information about where you can get Advanced Directives for free or a minimal charge with instructions. They will discuss considerations to think about when filling out Advanced Directives. Learn how to have that "Conversation" with your loved ones. ## Countdown to a Position on Homelessness

An almost year-long study process has brought our League and the San Diego LWV closer to consensus and a joint League position on the problem of homelessness in San Diego County.

Here's a history of our journey. Last spring, a League committee, composed of members of both LWVNCSD and LWVSD, was formed to study the problem of homelessness in San Diego County. What followed was months of study, research, and meetings with various experts in the field of homelessness, services to the homeless, and affordable housing.

The committee placed articles about these issues in our fall *VOTER* newsletters and presented informational meetings, designed to bring members up to speed with the many aspects of this problem, in the late fall.

Finally in February 2018, both Leagues held consensus meetings for members. At these meetings members received more background information on the issue of homelessness in San Diego County. The committee then presented 13 statements for consideration in inclusion of a future position for our Leagues to adopt. An hour of discussion by members on these statements produced member opinions and suggestions about what direction our position should take. Chairwoman Kay Ragan directed discussion and "took the temperature" of the room regarding agreement, disagreement, or no consensus for each statement. All comments from members during discussion were recorded.

The next step is for the committee to meet again to begin to form a final consensus. Only those statements that members "came to consensus" in agreement with will be considered for the final position. Any topic that had no agreement or no consensus will not be included in the final position. Committee members will consider all the comments, opinions, and suggestions on the statements given by members from each of the two consensus meetings when formulating this position.

When this final recommendation for a position is ready, it will be presented to each Board of Directors for their approval. Then it will be presented to the membership.

This is how League works—a member directed grassroots process to establish a position from which our leadership can advocate and take action region-wide.

Stay tuned for the exciting conclusion—a new position on Homelessness.

# **Board Report**

- Heard recommendations about how to use the \$23,000 that LWVNCSD received from the dissolution of the ILO.
- Discussed organizing a program on the Make It Fair Initiative supported by the League of Women Voters California.
- Voter Service Director Elizabeth Brady announced we will sponsor a candidates forum for the 4/24 Special Election in Rancho Santa Fe.
- Voted to sign a petition to the Board of Supervisors to reinstate a night budget hearing, send the petition to our members to sign as individuals, and write a separate letter to the Board along with the LWV San Diego.
- Learned that a county-wide initiative is going to be circulated that will require the Board of Supervisors to take General Plan changes that increase density to the electorate.

# In 2018, would you like to:

- Make a positive impact on society from home, in your spare time, without having to attend meetings?
- Update your personal resume with some marketable skills that will impress prospective employers?
- Promote civility in political discourse?
- Reduce the role of money in determining election outcomes?
- Provide voters with unbiased information about the candidates and measures on their ballots?

You can accomplish all of the above by joining the San Diego County Voter's Edge Team. Voter's Edge California <u>http://votersedge.org/ca</u>. is a website that allows voters to inform themselves before casting their ballots. It is a joint project of the League of Women Voter's Education Fund and MapLight, a not-for-profit organization that tracks where political donations are coming from.

Through Voter's Edge California, the League of Women Voters offers all San Diego County candidates on the ballot the same opportunity to tell voters about their qualifications and priorities, at no cost. This free publicity reduces the need for candidates to amass large war chests of campaign donations in order to introduce themselves to voters.

Voter's Edge also promotes civility in campaigning, by requiring participating candidates to refrain from making any mention of their competitors in their Voter's Edge statements. This encourages candidates to stay positive and focused on what they want to accomplish for the public if elected--not on the shortcomings of their competitors.

During the 2016 elections, Voter's Edge was promoted on local public television and radio as "the KPBS Voter's Guide." Local universities, libraries, and the San Diego County Registrar of Voters were also very supportive of our efforts.

Whether you would simply like to volunteer a few hours to contact candidates by phone, or if you would like extensive training in order to master all the bells and whistles of our data entry system and spreadsheets--a real resume-building opportunity!--Julie Ann Sih will be happy to put you to work for Voter's Edge.

## What does Your LWVNCSD Board of Directors Do?

Often people think of "the board" of an organization as a group of people who meet, give opinions on various issues, and then go out to lunch. True, LWVNCSD Board members, do occasionally go out to lunch, but they do not sit around giving opinions. It is a working, not advisory, board. If you are asked to join, know that you will be working at your job, sometimes very hard, and doing so with other interesting, motivated, and intelligent women!

The second prong of what League does after Voter Services/Citizen Education is Action and Advocacy. The League of Women Voters is unique in taking action on many issues rather than a single issue. LWV at the federal, state and local levels formulates positions based on studies followed by consensus meetings like our recent meetings in February. Our League advocates for these positions, based on what the Board of Directors, after thorough study, consideration and discussion, recommends. The recommended Positions are then presented for approval by the membership at the Annual Meeting.

It is the Board of Directors of our local League who voted to take public action by approving and sending a letter to the San Diego County Board of Supervisors in favor of night budget meetings, based on a state transparency in government policy. Another state position informed our decision to oppose the Lilac Hills proposed development. The National LWV position on human trafficking gave our board the ability to send a letter to local superintendents urging them to support the education on human trafficking bill in schools; that bill recently passed. Based on our local position on land use, supported by a local agricultural study, the Board voted to support the SOAR initiative to protect agricultural areas from development in Oceanside. These are just a few of the decisions the Board has taken for our League.

Our board consists of five Officers-President, Secretary, Treasurer, and two Vice-Presidents, aided by ten Directors, who each have areas of study and responsibility, plus four off-board Committee Chairs (directors often have committees working under them), plus three unit chairs who transmit board decisions and issues to their unit members, permitting a good flow of ideas in both directions as units are often where local issues begin to bubble. The officers and directors vote on the advocacy measures our League enacts, based on policy positions our local league has approved. So being on our League Board isn't sipping tea and crumpets, but rolling up one's sleeves and digging into the work of educating and advocating.


